



APPLICATION FOR THE BANKS ON TRADES SCHOLARSHIP AWARD

Banks on Trades Scholarship: This scholarship is provided by M & B Auctions Inc. for students planning to enroll full-time at an accredited vocational, trade or technical institution of post-secondary education.

This scholarship is for those students who wish to pursue a career by means of a trade, vocational, or technical institution. An example of a trade could be auctioneering, welding, pipefitting, cosmetology, HVAC, massage therapy, electrician, plumbing, construction management, and many more.

- 1 scholarship will be awarded annually
- Award Amount: \$1,000.00 (One Time Payment)
- Past recipients could apply each year to be in the selection processes with new applicants, but new applicants are the selection preference

Application Deadline: Tuesday March 31, 2026.

Banks on Trades Scholarship

A Clinton High School graduate may apply for the Banks on Trades Scholarship. Scholarship candidates are evaluated by completing an application, and submitting an essay to the scholarship committee. A complete application includes:

- **General information Document**- See attached form.
- **Applicant Essay**- See attached form.
- **High School Transcript(s)**- Complete, except for last semester
- **College Transcript(s)**- for any college courses completed while in high school or for renewals
- **Two letters of recommendation** - Request and submit two (2) letters of recommendation, only one of which may be provided by a current or recent teacher or school employee, and **one provided by a contact outside of the school district. Do not use relatives or CCEF board members.**
- **Be sure to include all of the above or the application will be denied.**

Completed applications **MUST BE RETURNED** in a **sealed envelope** to the high school guidance office by the application deadline noted on the application packet cover page. The outside of the envelope must be marked with the **student's name** and **CCEF- Banks on Trades Scholarship**.

Those students selected to receive a scholarship will receive further instructions outlining the eligibility requirements for disbursement of the scholarship award.

The number of scholarships awarded will be one for first-time applicants (this is preferred) **OR** one for applicants who are renewing (if there are no new applicants). Scholarship decisions are made by the scholarship committee which is comprised of district faculty members, CCEF board members, M & B Auctions Inc. family members, and/or community members. An interview is not required. The Clinton Community Educational Foundation has the final decision on all scholarship awards.
