## INSTRUCTIONS FOR COMPLETING A QUIT CLAIM DEED



**Step 1:** Enter the date. This date must match the date on the second page (notary signature page)

**Step 2:** Enter all sellers' names as they appear on the original recorded deed. *For each name, indicate marital status in parentheses.* (example: married, single, widow)

Note: If an owner is deceased, you must provide a death certificate for their name to be released from the deed.

\*All sellers and their spouses must be present to place their signatures on the second page (notary signature page). A notary must be present at this time to sign and stamp this page thus verifying all signatures.

Complete the mailing address portion and enter the county of residence for that mailing address.

<u>Step 3:</u> Enter all buyers' names as you want them to appear on the new recorded deed. <u>For each name, indicate marital status in parentheses.</u> (example: married, single, widow)

Complete the mailing address portion and enter the county of residence for that mailing address.

<u>Step 4:</u> Enter lot information. This includes lot, block section. More than one lot can be entered here.

Once the form is completed, you can hand deliver or mail the deed to the Washington County Recorder's office.

The fee of \$27 is due at the time of recording.

If you mail the deed, include payment and a stamped self-addressed envelope.

Bring the certified, recorded deed to the office. You will not be considered the owner until the deed has been recorded with the Recorder's office.
