

RESTRICTIONS AS THEY ARE RECORDED ON THE PLAT MAPS

SECTION 1: ALL LOTS IN THIS SECTION CONTAINING LESS THAN 15,000 SQUARE FEET SHALL BE DESIGNATED AS CAMPER LOTS.

SECTION 2: ALL LOTS IN THIS SECTION CONTAINS LESS THAN 15,000 SQUARE FEET SO THEY ARE HEREBY DESIGNATED AS CAMPER LOTS.

SECTION 3: NO STRUCTURE IN THIS SECTION WHETHER MOBILE HOME OR DWELLING SHALL CONTAIN LESS THAN 720 SQUARE FEET OF FLOOR SPACE.

SECTION 4: NO PLAT RESTRICTIONS ON THE PLAT. ALL LOTS ARE OVER 15,000 SQUARE FEET AND THEREFORE ARE RESIDENTIAL LOTS

SECTION 5: *NO DWELLING IN SECTION 5 SHALL CONTAIN LESS THAN 1000 SQUARE FEET OF FLOOR SPACE, NO CAMPER OR MOBILE HOME SHALL BE PERMITTED IN THIS SECTION.*

SECTION 6: *NO PLAT RESTRICTIONS ON THE PLAT. ALL LOTS ARE OVER 15,000 SQUARE FEET AND THEREFORE ARE RESIDENTIAL LOTS.*

SECTION 7: *NO PLAT RESTRICTIONS ON THE PLAT. ALL LOTS ARE OVER 15,000 SQUARE FEET AND THEREFORE ARE RESIDENTIAL LOTS.*

SECTION 8: *NO PLAT RESTRICTIONS ON THE PLAT. ALL LOTS ARE OVER 15,000 SQUARE FEET AND THEREFORE ARE RESIDENTIAL LOTS.*

SECTION 9: *NO DWELLING IN SECTION 9 SHALL CONTAIN LESS THAN 1000 SQUARE FEET OF FLOOR SPACE, NO CAMPER OR MOBILE HOME SHALL BE PERMITTED IN THIS SECTION.*

SECTION 10: NO DWELLING IN SECTION 10, BLOCK 1, LOTS 1 AND 2, BLOCK 4 LOTS 1, 2 AND 3 SHALL CONTAIN LESS THAN 1000 SQUARE FEET OF FLOOR SPACE. NO CAMPER OR MOBIL HOME SHALL BE PERMITTED ON THE ABOVE DESCRIBED LOTS . THE REMAINING LOTS IN SECTION 10 WILL PERMIT MOBILE HOMES OR DWELLINGS OF NOT LESS THAN 720 SQUARE FEET OF FLOOR SPACE.

SECTION 11: NO DWELLING IN SECTION 11, BLOCK 1, LOTS 1 THRU 12 AND LOT 63 SHALL CONTAIN LESS THAN 1000 SQUARE FEET OF FLOOR SPACE. COMMERCIAL FACILITIES WILL BE PERMITTED ON THE ABOVE-DESCRIBED LOTS. LOTS 31 THRU 37 AND LOTS 52 THRU 73 SHALL CONTAIN NO LESS THAN 1000 SQUARE FEET OF FLOOR SPACE. NO CAMPER OR MOBILE HOME WILL BE PERMITTED ON ABOVE- DESCRIBED LOTS. THE REMAINING LOTS IN SECTION 11 WILL PERMIT MOBILE HOMES OR DWELLINGS OF NOT LESS THAN 720 SQUARE FEET OF FLOOR SPACE.

SECTION 12: NO DWELLINGS IN THIS SECTION, WHETHER MOBILE HOME OR DWELLING SHALL CONTAIN LESS THAN 720 SQUARE FEET OF FLOOR SPACE.

SECTION 13: NO PLAT RESTRICTIONS ON THE PLAT. ALL LOTS ARE OVER 15,000 SQUARE FEET AND THEREFORE ARE RESIDENTIAL LOTS.

SECTION 14: NO DWELLING IN SECTION 14 SHALL CONTAIN NO LESS THAN 1000 SQUARE FEET OF FLOOR SPACE. NO MOBILE HOMES OR CAMPER WILL BE PERMITTED IN THES SECTION.

SECTION 15: NO DWELLING IN SECTION 15 BLOCK 1, LOTS 1,2,3,4, BLOCK 2, LOTS 12 THRU 18 SHALL CONTAIN LESS THAN 1000 SQUARE FEET OF FLOOR SPACE. NO CAMPER OR MOBILE HOME WILL BE PERMITTED ON ABOVE- DESCRIBED LOTS. THE REMAINING LOTS IN SECTION 15 WILL PERMIT MOBILE HOMES OR DWELLINGS OF NOT LESS THAN 720 SQUARE FEET OF FLOOR SPACE.

SECTION 16: NO DWELLING IN SECTION 16 SHALL CONTAIN LESS THAN 1000 SQUARE FEET OF FLOOR SPACE. NO MOBILE HOME SHALL CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE. NO MOBILE HOME OR CAMPER SHALL BE PERMITTED IN BLOCK 1, LOTS 14, 15 AND 16 ONLY.

SECTION 17: ALL LOTS IN SECTION 17 SHALL BE DESIGNATED AS CAMPING LOTS. NO PERMANENT DWELLING WILL BE PERMITTED EXCEPT LOTS 17 – 23 OF BLOCK 86 AND LOTS 1 – 24 OF BLOCK 87 WHICH WILL BE DESIGNATED AS OF NOT HAVING A DWELLING OF NOT LESS THAN 1000 SQUARE FEET OF FLOOR SPACE WITH THE EXEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQUARE FEET OF FLOOR SPACE.

SECTION 18: NO DWELLING IN SECTION 18 BLOCK 1, LOTS 1 THRU 3 AND LOTS 29 THRU 37 SHALL CONTAIN LESS THAN 1000 SQUARE FEET OF FLOOR SPACE. NO CAMPER OR MOBILE HOME WILL BE PERMITTED ON THE ABOVE- DESCRIBED LOTS. THE REMAINING LOTS IN SECTION 18 WILL PERMIT MOBILE HOMES OR DWELLINGS OF NOT LESS THAN 720 SQ FEET OF FLOOR SPACE.

SECTION 19: NO CONSTRUCTED DWELLING IN PLAT 19 SHALL CONTAIN LESS THAN 1000 SQUARE FEET OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL CONTAIN NO LESS THAN 720 SQUARE FEET OF FLOOR SPACE.

SECTION 20: ALL LOTS IN SECTION 20 CONTAINS LESS THAN 15,000 SQUARE FEET AND ARE HEREBY DESIGNATED AS CAMPER LOTS ONLY.

SECTION 21: ALL LOTS IN SECTION 21 ARE DESIGNATED AS CAMPING LOTS WITH THE EXCEPTION OF BLOCK 18 LOTS 1 THROUGH 11. NO DWELLING IN BLOCK 18 LOTS 1 THROUGH 11 SHALL CONTAIN LESS THAN 1000 SQUARE FEET OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL CONTAIN NO LESS THAN 720 SQUARE FEET OF FLOOR SPACE.

SECTION 22: UNSURE WHAT THIS ONE SAYS. (I BELIEVE IT TO SAY: ALL LOTS IN SECTION 22 FROM 1 THRU 45 IN BLOCK 14 ARE DESIGNATED AS CAMPING LOTS, NO DWELLING WILL BE PERMITTED ON THESE LOTS. THE REMAINING LOTS IN SECTION 22 SHALL PERMIT A DWELLING OF NO LESS THAN 1000 SQUARE FEET OF FLOOR SPACE WITH THE EXEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQUARE FEET OF FLOOR SPACE.)

SECTION 23: ALL LOTS IN SECTION 23 SHALL NOT CONTAIN LESS THAN 1000 SQUARE FEET OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQUARE FEET OF FLOOR SPACE. LOTS 12, 13, AND 14 OF BLOCK 16 ARE DESIGNATED AS PERMANENT DWELLINGS.

SECTION 24: NO DWELLING IN SECTION 24 SHALL CONTAIN LESS THAN 1000 SQUARE FEET OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL CONTAIN NO LESS THAN 720 SQUARE FEET OF FLOOR SPACE.

SECTION 25: NO DWELLING IN SECTION 25 SHALL CONTAIN LESS 1000 SQUARE FEET OF FLOOR SPACE. AND NO MOBILE HOME SHALL CONTAIN LESS THAN 720 SQUARE FEET OF FLOOR SPACE. LOTS 15 THRU 22 IN BLOCK 22 AND LOTS 4 THRU 15 IN BLOCK 23 ARE DESIGANTED AS PERMANENT DWELLING LOTS.

SECTION 26: NO DWELLING IN SECTION 26 SHALL CONTAIN LESS THAN 1000 SQUARE FEET OF FLOOR SPACE AND NO MOBILE HOME SHALL CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE.

SECTION 27: NO DWELLING IN SECTION 27 SHALL CONTAIN LESS THAN 1000 SQUARE FEET OF FLOOR SPACE WITH THE EXCEPTION F MOBILE HOMES WHICH SHALL CONTAIN NO LESS THAN 720 SQ FT OF FLOOR SPACE.

SECTION 28: NO DWELLING IN SECTION 28 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE AND NO MOBILE HOME SHALL CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE.

SECTION 29: NO DWELLING IN SECTION 29 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL CONTAIN NO LESS THAN 720 SQ FT OF FLOOR SPACE.

SECTION 30: NO DWELLING IN THIS SECTION SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE. NO MOBILE HOME SHALL CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE.

SECTION 31: NO DWELLING IN THIS SECTION SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE. NO MOBILE HOME SHALL CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE. ALL LOTS WITH LESS THAN 15,000 SQ FT ARE HEREBY DESIGNATED AS CAMPER LOTS.

SECTION 32: ALL DWELLINGS IN BLOCK 56 SECTION 32 SHALL CONTAIN NO LESS THAN 1000 SQ FT OF FLOOR SPACE. MOBILE HOMES SHALL CONTAIN NO LESS THAN 720 SQ FT OF FLOOR SPACE. ALL OTHER LOTS IN SECTION #32 ARE HEREBY DESIGNATED AS CAMPERS ONLY.

SECTION 33: NO DWELLING IN SECTION 33 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE. ANY LOT CONTAINING LESS THAN 15,000 SQ FT SHALL BE DESIGNATED AS CAMPER LOTS ONLY.

SECTION 34: NO DWELLING IN SECTION 34 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE.

SECTION 35: ALL LOTS IN SECTION 35 ARE DESIGNATED AS CAMPER LOTS ONLY. NO PERMANENT DWELLINGS WILL BE PERMITTED ON THESE LOTS.

SECTION 36: NO DWELLING IN SECTION 36 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE.

SECTION 37: NO DWELLING IN SECTION 37 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE.

SECTION 38: NO RESTRICTIONS ON PLAT

SECTION 39: NO DWELLING IN SECTION 39 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE

SECTION 40: NO DWELLING IN SECTION 40 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE.

SECTION 41: ALL LOTS IN SECTION 41 ARE DESIGNATED AS CAMPER LOTS ONLY. NO PERMANENT DWELLINGS WILL BE PERMITTED ON THESE LOTS.

SECTION 42: NO DWELLING IN SECTION 42 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE.

SECTION 43: NO RESTRICTIONS ON PLAT

SECTION 44: ALL LOTS IN SECTION 44 ARE DESIGNATED AS CAMPER LOTS ONLY. NO PERMANENT DWELLINGS WILL BE PERMITTED ON THESE LOTS

SECTION 45: NO DWELLING IN SECTION 45 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE.

SECTION 46: NO DWELLING IN SECTION 46 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE

SECTION 47: ALL LOTS IN SECTION #47 ARE DESIGNATED AS CAMPER LOTS ONLY. NO PERMANENT DWELLINGS WILL BE PERMITTED ON THESE LOTS

SECTION 48: ALL LOTS IN SECTION 48 ARE DESIGNATED AS CAMPER LOTS ONLY. NO PERMANENT DWELLINGS WILL BE PERMITTED ON THESE LOTS.

SECTION 49: NO DWELLING IN SECTION 49 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE.

SECTION 50: NO DWELLING IN SECTION 50 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE

SECTION 51: ALL LOTS IN SECTION 51 ARE DESIGNATED AS CAMPER LOTS. NO PERMANENT DWELLINGS WILL BE PERMITTED ON THESE LOTS.

SECTION 52: NO DWELLING IN SECTION 52 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE.

SECTION 53: NO DWELLING IN SECTION 53 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE, WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE.

SECTION 54: NO DWELLING IN SECTION 54 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE.

SECTION 55: NO RESTRICTIONS ON PLAT

SECTION 56: ALL LOTS IN SECTION 56 ARE DESIGNATED AS CAMPER ONLY LOTS. NO PERMANENT DWELLINGS WILL BE PERMITTED ON THESE LOTS.

SECTION 57: NO DWELLING IN SECTION 57 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE.

SECTION 58: NO DWELLING IN SECTION 58 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE.

SECTION 59: ALL LOTS IN SECTION 59 ARE DESIGNATED AS CAMPER LOTS ONLY. NO PERMANENT DWELLINGS SHALL BE PERMITTED ON THESE LOTS.

SECTION 60: NO DWELLING IN SECTION 60 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE.

SECTION 61: NO DWELLING IN SECTION 61 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE.

SECTION 62: NO DWELLING IN SECTION 62 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE.

SECTION 63: NO DWELLING IN SECTION 63 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE.

SECTION 64: ALL LOTS IN SECTION 64 ARE DESIGNATED AS CAMPER LOTS ONLY. NO PERMANENT DWELLINGS WILL BE PERMITTED ON THESE LOTS.

SECTION 65: ALL LOTS IN SECTION 65 ARE DESIGNATED AS CAMPER LOTS ONLY. NO PERMANENT DWELLINGS WILL BE PERMITTED ON THESE LOTS.

SECTION 66: ALL LOTS IN SECTION 66 ARE DESIGNATED AS CAMPER LOTS ONLY. NO PERMANENT DWELLINGS WILL BE PERMITTED ON THESE LOTS.

SECTION 67: NO DWELLING IN SECTION 67 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE.

SECTION 68: NO DWELLING IN SECTION 68 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE

SECTION 69: NO DWELLING IN SECTION 69 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE.

SECTION 70: ALL LOTS IN SECTION 70 SHALL BE DESIGNATED AS CAMPING LOTS. NO PERMANENT DWELLING WILL BE PERMITTED.

SECTION 71: NO DWELLING IN SECTION 71 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE.

SECTION 72: ALL LOTS IN SECTION 72 SHALL BE DESIGNATED AS CAMPING LOTS. NO PERMANENT DWELLING WILL BE PERMITTED.

SECTION 73: ALL LOTS IN SECTION 73 SHALL BE DESIGNATED AS CAMPING LOTS. NO PERMANENT DWELLING WILL BE PERMITTED.

SECTION 74: ALL LOTS IN SECTION 74 ARE DESIGNATED AS CAMPER LOTS EXCEPT FOR LOTS 1-10 IN BLOCK 217, LOTS 1-8 IN BLOCK 213 & LOTS 47- 56 IN BLOCK 213 ARE DESIGNATED AS FOR DWELLINGS OF NOT LESS THAN 1000 SQ FT OF FLOOR SPACE, WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE.

SECTION 75: NO DWELLING IN SECTION 75, BLOCK 220, LOTS 39 THRU 55 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE AND NO MOBILE HOMES WHICH SHALL CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE. ALL LOTS IN BLOCKS 218, 219, 221 AND 220 WITH LOTS 1 THRU 38 AND 56 THRU 61 IN SECTION 75 ARE DESIGNATED AS CAMPER LOTS ONLY. NO PERMANENT DWELLINGS WILL BE PERMITTED ON THESE LOTS.

SECTION 76: ALL LOTS IN SECTION 76 SHALL BE DESIGNATED AS CAMPING LOTS. NO PERMANENT DWELLING WILL BE PERMITTED.

SECTION 77: ALL LOTS IN SECTION 77 SHALL BE DESIGNATED AS CAMPING LOTS. NO PERMANENT DWELLING WILL BE PERMITTED.

SECTION 78: NO DWELLING IN SECTION 78 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE. ANY LOT CONTAINING LESS THAN 15,000 SQ FT SHALL BE DESIGNATED AS CAMPER LOTS ONLY.

SECTION 79: NO DWELLING IN SECTION 79 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE. ANY LOT CONTAINING LESS THAN 15,000 SQ FT SHALL BE DESIGNATED AS CAMPER LOTS ONLY.

SECTION 80: NO DWELLING IN SECTION 80 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE.

SECTION 81: NO DWELLING IN SECTION 81 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE.

SECTION 82: NO DWELLING IN SECTION 82 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE.

SECTION 83: NO DWELLING IN SECTION 83 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE.

SECTION 84: ALL LOTS IN SECTION 84 SHALL BE DESIGNATED AS CAMPING LOTS. NO PERMANENT DWELLING WILL BE PERMITTED.

SECTION 85: NO DWELLING IN SECTION 85 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE.

SECTION 86: ALL LOTS IN SECTION 86 SHALL BE DESIGNATED AS CAMPING LOTS. NO PERMANENT DWELLING WILL BE PERMITTED.

SECTION 87: NO DWELLING IN SECTION 87 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE. ANY LOT CONTAINING LESS THAN 15,000 SQ FT SHALL BE DESIGNATED AS CAMPER LOTS ONLY.

SECTION 88: ALL LOTS IN SECTION 88 ARE DESIGNATED AS CAMPER LOTS ONLY. NO PERMANENT DWELLINGS WILL BE PERMITTED ON THESE LOTS.

SECTION 89: NO DWELLING IN SECTION 89 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE.

SECTION 90: NO DWELLING IN SECTION 90 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE.

SECTION 91: NO DWELLING IN SECTION 91 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE.

SECTION 92: ALL LOTS IN SECTION 92 ARE DESIGNATED AS CAMPER LOTS ONLY. NO PERMANENT DWELLINGS WILL BE PERMITTED ON THESE LOTS.

SECTION 93: NO DWELLING IN SECTION 93 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE. ANY LOT CONTAINING LESS THAN 15,000 SQ FT SHALL BE DESIGNATED AS CAMPER LOTS ONLY.

SECTION 94: NO DWELLING IN SECTION 94 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE. ANY LOT CONTAINING LESS THAN 15,000 SQ FT SHALL BE DESIGNATED AS CAMPER LOTS ONLY.

SECTION 95: NO DWELLING IN SECTION 95 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE. ANY LOT CONTAINING LESS THAN 15,000 SQ FT SHALL BE DESIGNATED AS CAMPER LOTS ONLY.

SECTION 96: NO DWELLING IN SECTION 96 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE. ANY LOT CONTAINING LESS THAN 15,000 SQ FT SHALL BE DESIGNATED AS CAMPER LOTS ONLY.

SECTION 97: NO DWELLING IN SECTION 97 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE. ANY LOT CONTAINING LESS THAN 15,000 SQ FT SHALL BE DESIGNATED AS CAMPER LOTS ONLY.

SECTION 98: NO DWELLING IN SECTION 98 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE. ANY LOT CONTAINING LESS THAN 15,000 SQ FT SHALL BE DESIGNATED AS CAMPER LOTS ONLY.

SECTION 99: NO DWELLING IN SECTION 99 SHALL CONTAIN LESS THAN 1000 SQ FT OF FLOOR SPACE WITH THE EXCEPTION OF MOBILE HOMES WHICH SHALL NOT CONTAIN LESS THAN 720 SQ FT OF FLOOR SPACE. ANY LOT CONTAINING LESS THAN 15,000 SQ FT SHALL BE DESIGNATED AS CAMPER LOTS ONLY.
