HURRICANE READINESS

- Medications (7-day supply) and medical items
- Water: one gallon per person, per day (3-day supply for evacuation, 2-week supply for home)
- Food: non-perishable, easy-to-prepare items (3-day supply for evacuation, 2-week supply for home)
- Flashlight
- Battery-powered or hand-crank radio (NOAA Weather Radio, if possible)
- Extra batteries
- Deluxe family first aid kit
- Multi-purpose tool
- Sanitation and personal hygiene items
- Copies of personal documents (medication list and pertinent medical information, proof of address, deed/lease to home, passports, birth certificates, insurance policies)
- Cell phone with chargers
- Family and emergency contact information
- Extra cash
- Emergency blanket
- Map(s) of the area

It's not too late to respond to the 2020 Census! In fact, you have until October 31, 2020 to respond online at <https://go.usa.gov/xvhJ4>. Or, if you prefer by phone, or by mail.

It has never been easier to respond on your own, all while practicing social distancing and minimizing the need for the Census Bureau to send census takers out into communities to follow up.
