

Beach Butler® Cargo Lift Warranty

UniFab[™], the manufacturer, warrants only to the Original Purchaser of an aluminum cargo lift purchased or used for private and recreational purposes, the following:

1. That the structural components of the aluminum cargo lift are free from manufacturing defects or defects in craftsmanship for a period of three (3) years when purchased from UniFab[™] or any authorized agent of UniFab[™]. During this period, UniFab[™] will provide replacement parts, without charge, for the structural components of the aluminum cargo lift which exhibit manufacturing defects or defects in craftsmanship. Defect is determined at absolute and sole discretion of UniFab[™].

2. That the gear unit components of the aluminum cargo lift are free from manufacturing defects or defects in craftsmanship for a period of two (2) years when purchased from $UniFab^{TM}$. During this period, $UniFab^{TM}$ will replace gear unit components, without charge, for the gear unit components of the aluminum cargo lift, or any part or piece thereof, which exhibits a manufacturing defect or defect in craftsmanship. Defect is determined at absolute and sole discretion of $UniFab^{TM}$.

3. That the electrical components of the aluminum cargo lift are free from manufacturing defects or defects in craftsmanship for a period of one (1) years when purchased from UniFab, or any authorized agent of UniFabTM. During this period, UniFabTM will provide replacement parts for the electrical components of the aluminum cargo lift, or any pat or piece thereof, which exhibits a manufacturing defect or defect in craftsmanship. Defect is determined at absolute and sole discretion of UniFabTM.

This limited warranty becomes effective as of the date of delivery to the original purchaser. In order for this limited warranty to become effective, the original purchaser must, within ninety (90) days of the date of delivery, by completing the warranty registration card provided with the aluminum cargo lift and return it to UniFab™, PO Box 1118, Snow Hill, NC 28580 or REGISTRATION IS A CONDITION PRECEDENT TO UNIFAB™'S OBLIGATION UNDER THIS LIMITED WARRANTY.

In order to submit an acceptable claim under this limited warranty, the Original Purchaser must provide the following in writing addressed to:

- 1. Full name and address of person making claim
- 2. Model and Serial Number of the aluminum cargo lift
- 3. Date of registration of warranty
- 4. Date of purchase and from whom
- 5. A clear and specific description of the defect
- 6. Name, address, and telephone number of the person(s) or companies performing the installation
- 7. Return authorization number from UniFab™ is required before parts are returned to UniFab™ by Original Purchaser.

This limited warranty does not include labor costs associated

with repairing or replacing the aluminum cargo lift, nor does it require UniFab services for the repairing or replacing of the aluminum cargo lift. This limited warranty does not extend to products, equipment and accessories not manufactured by UniFab™, including without limitation, the stainless steel cables of the aluminum cargo lift. This limited warranty is valid only when such products are used under normal conditions of recommended use. This limited warranty does not cover replacement or repair of the aluminum cargo lift, or any part there of damaged by acts of God, abuse, accident, misuse, neglect, alteration, repair, disaster, overloading, negligence, unauthorized use, improper installation, improper testing, improper product selection, failure to follow maintenance recommendations, failure to follow instructions or warnings, or any other cause beyond the control of UniFab™.

This limited warranty does not cover routine maintenance and service. Any repair work performed on the aluminum cargo lift, or any part or piece thereof manufactured by $UniFab^{TM}$ than an employee of $UniFab^{TM}$ in writing by $UniFab^{TM}$ work, shall void this warranty. This limited warranty is not transferable or enforceable by any party other than the original purchaser. $UniFab^{TM}$ parts provided pursuant to this limited warranty to be free from manufacturing defects or defects in craftsmanship, under the same terms as set forth herein, except that the time period for the limited warranty shall, in that instance, be the greater of (I) ninety (90) days from the date the replacement part was delivered to the original purchaser, or (ii) the period of time remaining on the original limited warranty. This limited warranty is limited to aluminum cargo lifts sold and used in the United States.

The sole and exclusive remedy provided by this limited warranty is the providing of replacement parts for the aluminum cargo lift, or any part or piece thereof manufactured by $UniFab^{TM}$ as more fully set forth in this document.

ALL WARRANTIES IMPLIED BY LAW, INCLUDING (BUT NOT LIMITED TO) IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, ARE DISCLAIMED OR, IF A DISCLAIMER IS NOT PERMITTED BY APPLICABLE STATE LAW, ARE EXPRESSLY LIMITED TO THE DURATION OF THE COVERAGE PERIOD SET FORTH ABOVE.
