Terms for advertising on Steam Network.

1. Payment to be made in advance prior to membership being posted on the website or in any social media platforms.
2. All fees are per annum commencing on the date the company Bio is live on the website.
3. The use or reference of other associations, institutes is strictly forbidden unless prior agreement from steam network has been granted. Any reference not approved will be removed from the Bio. For example, such references to the likes of CHAS, Safe Contractor, CEA will be removed.
4. Steam Network accept reference to legislation, regulations and government departments only for example, HSE, EA, SEPA, PSSR, INDG436 can be used however reference to guidance documents is forbidden.
5. Only one corporate entity can be advertised under each membership. Company name and number will be checked as part of our due diligence audit process. For example, any group organisations with subsidiaries individually registered will be treated as separate entities.
6. As a member Steam Network UK allow the use of the Steam Network UK logo on your corporate media, emails signatures, website or any other media that supports promotion of your business. Should membership cease to be valid then the logo must be removed.
7. Businesses that are facing legal cases or in liquidation will have membership ceased.
8. All additional chargeable services must be paid for in advance.
9. Membership commences for the date of publication onto the website which will be communicated to the registered name on the membership form. This allows time for payment of fees and admin to make your Bio live.
10. Non-payment of membership fees before prior to renewal will see removal of your bio from all platforms with no extension periods granted. These will be re-instated on re-payment of any applicable fees.
