# 2025 WINTER CODE UPDATES







Wisconsin's regional inspector associations, in cooperation with Wisconsin Code Officials Alliance and the Wisconsin Department of Safety & Professional Services are offering virtual and in-person training sessions in early 2025 about Wisconsin's Electrical Code, Uniform Dwelling Code, Plumbing Code and Commercial Building Code. These courses can provide continuing education credits for Industry Services administered inspection and DCQ credentials. Fire inspectors, designers, contractors, and others with an interest in Wisconsin's codes may also benefit from the programs.

## **CLASS HIGHLIGHTS**

- All training sessions are available both virtually (online) and in-person.
- All in-person sessions include lunch.
- The price for all training sessions is \$125.
- Training sessions provide 6 hours of continuing education credits see credential approvals below.
- Training sessions begin at 7:45 am and conclude at 3:15 pm. There will be a morning and afternoon break and a one hour lunch break. Doors open, registration and check-in begins at 7:00 am.

#### **GENERAL COURSE OVERVIEW AND APPROVALS**

**Commercial Electrical Code** – This course will provide code panel discussion covering many issues encountered during inspections. Energy storage system requirements for commercial buildings, commonly missed commercial electrical code items and an overview of the labeling requirements found in the NEC will be covered. Approved for Commercial Electrical Inspector, Industrial Journeyman Electrician, Journeyman Electrician, Master Electrician, Registered Electrician, Residential Journeyman Electrician, Residential Master Electrician, and UDC-Electrical Inspector.

1 & 2 Family Electrical Code – This course will provide code panel discussion covering problems encountered during inspections. Battery storage basics for one and two family dwellings, review of commonly missed UDC electrical codes as well as a discussion of UL and the UL website as it applies to UDC buildings will also be provided. Approved for Commercial Electrical Inspector, UDC-Electrical Inspector, Industrial Journeyman Electrician, Journeyman Electrician, Registered Electrician, Residential Journeyman Electrician, and Residential Master Electrician.

**Uniform Dwelling Code** – This course will cover SPS 322 and the applicability to residential buildings in WI. The significance of energy efficiency standards including insulation requirements, HVAC systems and lighting will be discussed. Energy conservation and compliance pathways will also be covered. Discussion will be provided of some of the most common issues that inspectors find in the field, covering all aspects of the UDC code. The last session will cover rooftop PV systems and how PV systems affect the roof structure of homes and what to look for when reviewing and inspecting rooftop PV systems. Approved for UDC Building Inspector, Dwelling Contractor Qualifier, and UDC HVAC Inspector. This class does **NOT** cover any of the 4 hrs. of required legal training for Dwelling Contractor Qualifier credential holders.

**Commercial Building Code** – All presentations will focus on the 2015 IBC. Flat roof requirements, membrane structures (with & without structural supports), and review and inspection of distilleries will be covered. Which codes to prioritize for review and inspection will also be discussed. Egress and accessibility as well as inspection of fire stopping will be included. Approved for Commercial Building Inspector and Dwelling Contractor Qualifier.

**Plumbing Code** – This course will cover the Wisconsin Plumbing Code changes and interpretations that went into effect October 1, 2023. Hot topics like storm water systems, plan review submittals, sizing re-circ lines, and grease interceptor requirements will also be covered. Approved for Commercial Plumbing Inspector, UDC Plumbing Inspector, Journeyman Plumber / restricted appliance-service, and Master Plumber / restricted appliance-service.
