

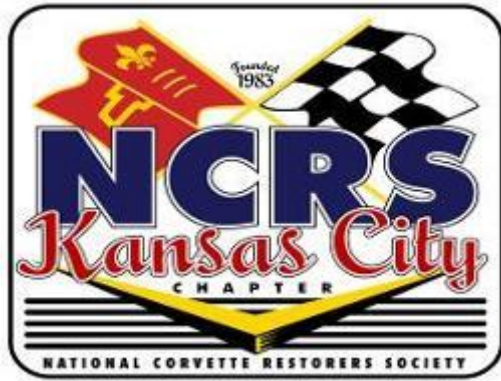

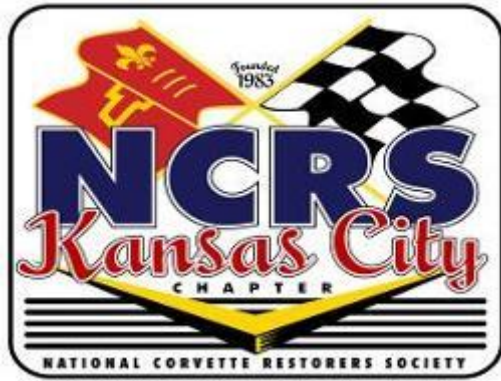

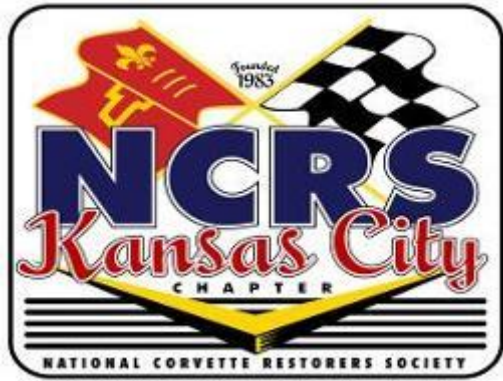
Patty is planning a couple of local events currently and we are working to secure a driving tour to Booneville in the early fall timeframe. If you have suggestions on possible activities---please call or email.

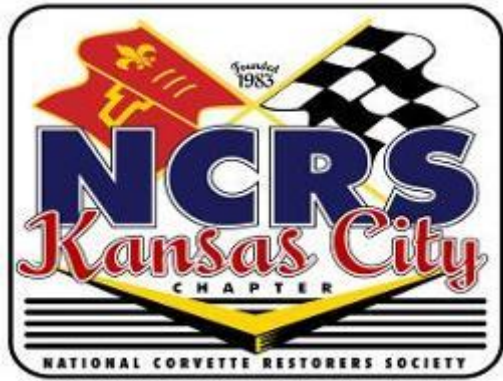

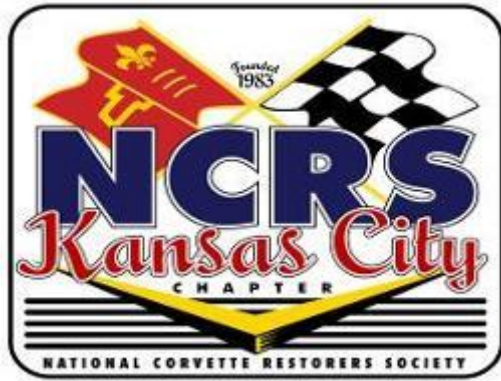
As always if you have anything you want in the newsletter—technical , and an event you have been to, questions, or concerns, or an article about your car, please send them to me and we get them in the newsletter.
