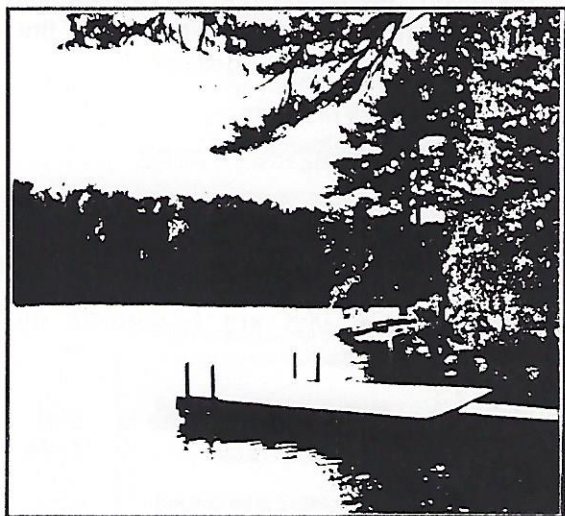

HISTORY OF THE A.K.PSI COUNTRY CLUB

In 1938 a group of approximately 100 Brothers of Alpha Kappa Psi founded the Alpha Kappa Psi Building Corporation. Its purpose was to establish and maintain club properties for the use and enjoyment of its members; to promote a closer relationship among the members of AKPsi Fraternity; and to aid, promote, and foster worthy enterprises of any and every kind of benefit to the members of AKPsi Fraternity as provided in its charter granted June 29, 1938 by the Superior Court of Fulton County, Georgia.

The original property that the Corporation purchased was a 3 acre tract of land with a clubhouse located on Briarcliff Road. At this time the Briarcliff Road area was a relatively non-developed area just outside of Atlanta. The brothers enjoyed this facility until the late 1950's when the clubhouse burned and was subsequently sold. The funds from the sale were used as a down-payment on 58 acres in Gwinnett County. The property has a 12 acre lake, a 1,250 square foot clubhouse (the old Lawson General Hospital building), areas for campers and tents, and a general recreation area including a barbeque pit and volleyball court. In 1984, the final payment was made on the mortgage. This event was celebrated by a ceremonial mortgage burning at the Corporation's annual cookout.

Through the years, members of the Corporation have enjoyed boating, fishing, and swimming in the lake as well as utilizing the facilities for parties and cookouts. The Country Club is also open for use by the college and Alumni chapters in the region.

Rules and Regulations

- Membership includes use of the property by members of the immediate family, or their guest when accompanied by the member.
- All members shall have use of the club property, including club-owned boats, picnic areas, swimming areas, docks, and grills. Oars or paddles, safety equipment such as cushions and vests. Anchors and lines shall be furnished by member.
- Gasoline motors are not permitted on the lake. Private boats may be left at the lake site at the owner's risk.
- Campers must abide by the rules and regulations set forth.
- No sleeping in the clubhouse except in extreme emergencies.
- Charcoal cooking and open flames prohibited on porch and in the clubhouse.
- All club-owned boats must be returned to the boat storage area and turned over.
- The dock is for use by swimmers only. There will be no chairs or coolers allowed on the dock.
- Speed limits as posted on the premises are to be observed at all times.
- Fishing limits are posted and should be respected. Use of minnows is PROHIBITED. There will be no fishing from docks. Record all catches in register next to fish cleaning area.

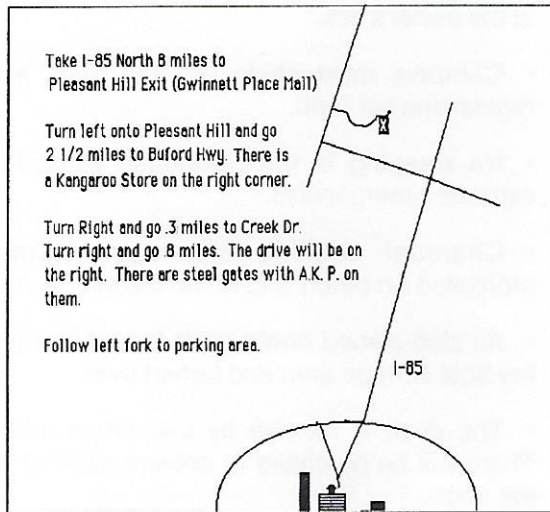
