Terms and Conditions

As a Temporary Foster Family, I/We agree to the following:

- I/We understand the animal is currently named __Renee_____, and it is necessary for record keeping, appointments, public information, etc. to refer to the animal by this name.
- The Animal will be provided with adequate fresh food and water, clean, dry shelter when outside, and daily exercise
- Rabies and I.D. tags are to be worn at all times.
- To obey all applicable laws governing control and custody of animals
- The dog is not to ride loose in the bed of pickup trucks, convertibles or to be left in a car when air temperatures exceed 70 degrees
- The Foster Family agrees to have a clean, secure fenced area for the dog. If a fenced enclosure is not available, Foster Family agrees to leash walk dog.
- Foster Family understands that Blackdog Club, Inc. retains legal control of the animal and is not authorized to make any legal or medical decisions on his/her behalf.
- Foster Family agrees to respond to Blackdog Club, Inc. phone calls, emails, and text messages with 4 hours.
- Blackdog Club, Inc. makes no guarantees or statements regarding the dog's temperament. While Blackdog Club, Inc. has made every effort to provide accurate history and assessment of the dog, Blackdog Club, Inc. is not able to guarantee behavior or disposition.
- All medical expenses that are approved by the Blackdog Club, Inc. Board and treated through Blackdog Club, Inc. approved veterinary office will be covered by Blackdog Club, Inc. If you take our dog to your vet it will not be covered.
- Foster agrees to release Blackdog Club, Inc. and its members or representatives of any and all possible claims arising from injury or damage caused by the animal to any person or property.
- If you choose to adopt your foster animal you will be required to fill out an adoption application. Upon receipt, it will be processed to Blackdog Club, Inc. guidelines.

As a Foster Family, I/We agree to release the previous owner as well as Blackdog Club, Inc. and its representatives of any liability arising from our duties as a Foster Family, from this date forward.

I/we agree to abide by the foster conditions and I/we have read and fully understand that Blackdog Club, Inc. may repossess this animal at any time if the foster conditions are violated or the animal is mistreated.
