# **Tournament Rules:**

- The Tournament will bowling 3 divisions. Senior, Women and Open. To qualify for Senior 1. Division ALL bowlers on the team must be 55 years of age or older as of the date of the tournament.
- 2. Entry Fee \$200 US per team for all divisions. Entry breakdown: \$70 tournament expenses & Lineage, \$130 prize fee; 100% of prize fee returned to bowlers.
- The highest 2019-2020 USBC Certified average with 21 games or more is to be used. If no 3. 2019-2020 USBC average then highest 2018-2019 USBC Certified average with 21 games or more to be used. If no 2018-2019 average then the highest 2017-2018 USBC Certified average with 21 games or more to be used. If no average in the past 3 years then scratch average of 230 to be used. If not certified, bowlers may purchase affiliate USBC memberships for \$25 thru USBC or may pay a \$5 USBC participation fee.
- 4. Handicap 80% from 1150 in Senior and Women's Division. NO Handicap for Open Division.
- 5. Cash ratio 1 in 4 teams.
- 6. Tournament certified through USBC.
- 7. All disputes will be settled by the Tournament Director who will refer to USBC rulebook.
- Entry closing date <u>August 16, 2021 (unless filled on an earlier date)</u>
- Bowlers need not report previous tournament prize winnings per USBC Rule 319D. Rule 9. 319E is waived.

0. Failure to use the correct average shall disqualify score if submitted average is lower than correct average, thereby resulting in a lower classification or more handicap. Prize winnings shall be based on the submitted average if it is higher than the correct average. Team Captains are responsible for listing correct average for each team member on score sheet. Failure to submit averages may result in team disgualification.

11. Entry form must be submitted with the entire \$200 fee for the Team! Or it won't be accepted.
