## II. Definitions

The term "record" is to be liberally construed to include: any 1) sound or voice recording, 2) photographs or images (.png, .jpg. .jpec, .tiff or any other photograph formats), 3) video, 4) text message, 5) mobile/web app messages (from applications such as Messenger, Whatsapp, Signal, Telegram, etc.) 6) email, 7) web page and blog captures and archives, 8) paper, computer, phone, or digital file, 9) spreadsheet, 10) paper, 11) microfilm, 12) digital archive, 13) X-rays or imaging, 14) recorded conversations or audio messages; 15) document or any other format where the information sought may be stored. The term "record" includes both the principal record responsive to the request as well as any studies, exhibits, supporting documentation or supplement thereof.

III. Records Requested

I request the production of a copy of the following records relating to Jane Doe, including all the varieties of his or her identifying information set forth in section I above:

1. All correspondence, including criminal complaints, and prior Freedom of Information Act requests by Jane Doe to the FBI.

2. All responses from the FBI to all correspondence, criminal complaints, and Freedom of Information Act requests by Jane Doe.

3. All Article III Court and/or FISA applications and warrants, renewals obtained, and/or executed against Jane Doe from January 1, \_\_\_\_, until July 1, 2024, and every record generated as a result of each one, including, but not limited to, the inventory of surveillance carried out and summary of each. Include the affidavit and supporting documentation submitted in support of each Section 702 FISA application and the testimony of the person(s) that submitted each one to the FISA Court.

4. All photographs, videos, images, or any other media depicting the image of Jane Doe, or his or her body, or any part thereof from **(1/1/year you were targeted)** authorized by him or her or not.

5. All voice or sound recordings including the actual or reproduced voice of Jane Doe that were made with or without his or her knowledge or consent.

6. All "Sneak and Peek" warrants issued, requested and/or executed against Jane Doe's property or within his or her property. Include all records generated as a result of each one, including, but not limited to: inventory of items seized, date, place, and current custodian thereof for each one.

7. All FD-930 or VIPER nomination forms filled out and submitted to

nominate Jane Doe to the Terrorist Screening Database and for any change of status within it.

8. Complete expense records and ledgers reflecting expenses, payments, fees, purchases, professional services paid or any other disbursement carried out in any matter relating to Jane Doe.

9. Inventory and chain of custody records of all property, records and documents seized, stolen, or removed from Jane Doe's property or vehicles with or without an Article III Court warrant.

10. All geofencing warrants and renewals obtained for Jane Doe or any of his or her known aliases, and all records generated as a result of each one up to and including July 31, 2024.

12. All communications relating to the processing of this FOIA request with anyone within or outside of the FBI.

13. Records, correspondence, or communications to and from any person (including confidential human sources) relating to Jane Doe or any of his or her known aliases with anyone.

14. Inventory of property seized from, occupied, removed from, or otherwise taken away from Jane Doe or from any of his or her residences or vehicles at the behest of the agency or its contractors.

15. Records obtained from any of Jane Doe's computers, phones, email or social media accounts, web, or smartphone applications, or phone.

16. Records of payments, bartering, financial contributions, checks, money orders, bank transfers, gifts, donations or any other kind of economic transaction made by any person, corporation, research institution, or organization including the United States Government in compensation for or payment of any surveillance, physical harm, stalking and harassment services, medical procedures, veterinary actions against his or her pets, public relations campaigns, implanted medical devices, planted honeypots, and/or data harvesting relating to Jane Doe\_\_\_\_\_.

17. All physical or electronic correspondence, footage, photographs, reports, communications, documents with any member of the state, territorial, or federal judiciary, or public or private law enforcement or security company regarding Jane Doe.

18. All physical, electronic or documented conversations, documents, instructions, or any kind of communication with officials from state or federal judiciary, United States Probation Office, United States Marshals Office, IRS, or any other federal agency relating to Jane Doe, his or her children \_\_\_\_\_\_, his or her property, and profession.

19. All "assessments" made about or relating to Jane Doe.

20. All records regarding repairs, vandalism, sabotage and payments made in connection to Jane Doe's vehicles.

21. Any other document in your possession or that of a third party that you know of that relates to Jane Doe or his or her property.

22. All reports, emails, text messages, recordings, videos, images or any other kind of record regarding the monitoring of Jane Doe's Formerly Twitter/Now X accounts under the handles @\_\_\_\_\_ and @\_\_\_\_\_, including monitoring logs, correspondence, emails and communications to and from Twitter/X.

As you know, FOIA requires agencies to release information unless it is specifically exempt from disclosure, and also requires agencies to release all reasonably segregable nonexempt portions of documents, i.e., to redact exempt portions of documents and release the rest. See 5 U.S.C. § 552(a)(8).

For any document you know exists but do not have, please provide the name of agency and contact information as to request it from.

## III. Request for Fee Waiver

The undersigned hereby requests a fee waiver of search, review, and duplication fees on the grounds that disclosure of the requested records is "in the public interest because it is likely to significantly contribute to public understanding of the operations or activities of the government and is not primarily in the commercial interest of the requester." See 5 U.S.C. § 552(a)(4)(A)(iii); see also 22 C.F.R. § 171.17(a); 28 C.F.R. § 16.11(k); 32 C.F.R. § 286.28(d); 32 C.F.R. § 1900.13(b)(2). Furthermore, a waiver of search and review fees is warranted inasmuch as the undersigned will report the results of this endeavor as a "representative of the news media" and that the records are not sought for commercial use. See 5 U.S.C. § 552(a)(4)(A)(ii))(7); 32 C.F.R. § 1900.02(h)(3), 1900.13(i)(2).

For any document you fail to produce, I request that you provide a Vaughn Index and declaration setting forth reasonably detailed explanations for each withheld document as to why it falls within any statutory exemption. See *Vaughn v. Rosen*, 484 F. 2d 820 (D.C. Cir. 1973).

The Vaughn statement must specify details about each document's sender, recipients, date and time, and subject.
