## BLOOMDALE PUMP STATION EMERGENCY GENERATOR CONNECTION UPGRADE

The project includes but is not necessarily limited to the installation of a new 1600A generator tap box, existing switchboard modification to add a new 1600A generator section, upgrade of the existing switchboard to add a new surge protective device (SPD) and modification of the existing main breaker in the switchboard with a kirk key. - 4. The extent to which the goods or services meet GTUA's needs;
- 5. The vendor's past relationship with GTUA;
- 6. The total long-term cost to the GTUA to acquire the vendor's goods or services;
- 8. Any other relevant factor specifically listed in the request for bids or proposals; and
- 9. The safety record of the bidder, of the firm, corporation, partnership, or institution represented by the bidder, or of anyone acting for such a firm, corporation, partnership, or institution.
