Sealed Bids for the construction of the Project will be received at the Training Room of the Temporary City Hall located at 317 S Travis Street, Sherman, Texas 75090. Bids will be accepted until Wednesday October 30th, 2024, at 2:30 pm local time. At that time the Bids received will be publicly opened and read aloud. Any bid received after the above time and date will be returned unopened.

The Bidder shall identify their bid on the outside of the envelope by writing the words:

Obtaining the Bidding Documents

Plans, specifications, and bidding documents may be secured from the City of Sherman Engineering, Temporary City Hall, 317 S Travis Street, Sherman, Texas 75090. A non-refundable fee of \$250 is required for obtaining a hard copy of the bid package with 11"x17" drawings. The bid package is also available in digital pdf format at no charge.

Prospective Bidders are urged to register with the designated website as a plan holder, even if Bidding Documents are obtained from a plan room or source other than the designated website in either electronic or paper format. The designated website will be updated periodically with addenda, lists of registered plan holders, reports, and other information relevant to submitting a Bid for the Project. All official notifications, addenda, and other Bidding Documents will be offered only through the designated website. All questions shall be submitted through Civcast. Questions submitted to Owner or Engineer through other means will not be considered.

Neither Owner nor Engineer will be responsible for Bidding Documents, including addenda, if any, obtained from sources other than the designated website.

A non-mandatory pre-bid conference for the Project will be held on Monday October 21st, 2024, at 10:00 am local time at the Sherman WTP (243 La Cima Rd, Sherman, TX 75092).

Instructions to Bidders

Bids shall be accompanied by a cashier's check or certified check upon a national or state bank in an amount not less than five percent (5%) of the total maximum bid price payable without recourse to the City of Sherman, or an original bid bond in the same amount from a reliable surety company licensed by the State of Texas to act as a Surety and be listed on the current U.S. Treasury Listing of Approved

Sureties, or a Binder of Insurance executed by a surety company licensed by the State of Texas to act as a surety or its authorized agent as a guarantee that the bidder will enter into a contract and execute a Performance Bond within ten (10) days after notice of award of contract to bidder.

Performance, Payment, and Warranty Bonds will be required on the forms provided in the amount of one hundred percent (100%) of the contract price from an approved surety company holding a permit from the state of the project state to act as surety, or other surety or sureties acceptable to the Owner.

The Qualifications Statement in the Bidding Documents must be completed and submitted with the bid.

In case of ambiguity or lack of clearness in stating bid prices, the Owner reserves the right to adopt the most advantageous construction thereof, to reject any or all bids, and to waive formalities. No bid may be withdrawn within sixty (60) days after the date on which bids are opened.

The right is reserved by the Mayor and the City Council, as the interests of the City, to reject any or all bids and to waive any informality in bids received.

For all further requirements regarding bid submittal, qualifications, procedures, and contract award, refer to the Instructions to Bidders that are included in the Bidding Documents.
