The Work is to include furnishing all labor, materials, and equipment, and performing all work necessary for the construction of a proposed 0.5 million gallon composite elevated storage tank and 2.0 million gallon elevated storage tank, and all associated piping, paving, electrical work, SCADA integration, and grading as detailed in the Construction Plans and Specifications. The proposed 0.5 million gallon elevated storage tank is located on the south side of Elevon Parkway, east of North State Highway 78 in Lavon, Collin County, TX.
