

**Notice for Bid**  
**GTUA/City of Bells Water Meter Installation Project**

The Greater Texoma Utility Authority (GTUA) (Owner) on behalf of the City of Bells, TX (City) is seeking proposals from Contractors to install approximately 700 Automated Meter Reading (AMR)- and Advanced Metering Infrastructure (AMI)- compatible water meters. This water meter replacement project will modernize water infrastructures in Bells through improving data collection and enhancing service. These water meters will ultimately connect to a future Advanced Metered Infrastructure (AMI) system for monitoring and control.

The envelope must be sealed and clearly marked "WATER METER INSTALLATION PROJECT".

**The Project Consists of:**

Installation of 700 AMR/AMI-compatible water meters for replacement in the City of Bells, including residential, public, and commercial buildings. Approximately 690 meters are 3/4" or 5/8"; approximately 10 meters are 2" in size.

Instructions to Bidders, Proposal Forms, Specifications, Plans and Contract Documents, etc. may be examined without charge at the office of the Greater Texoma Authority, Texas, 5100 Airport Drive, Denison, Texas 75020.

A bid bond in the amount of five percent (5%) of the bid issued by an acceptable surety shall be submitted with each bid. A certified check or bank draft payable to the Greater Texoma Utility Authority or negotiable U.S. Government Bonds (as par value) may be submitted in lieu of the Bid Bond.

The Greater Texoma Utility Authority reserves the right to reject any or all bids or to waive any informalities in the bidding. Bids may be held by GTUA for a period not to exceed 60 days from the date of the bid opening for the purpose of receiving bids and investigating the bidder's qualifications prior to the contract award.

The contract will be contingent upon release of funds from the Texas Water Development Board (TWDB). Any contract or contracts awarded under this Notice for Bids are expected to be funded in part by a loan from the Texas Water Development Board. Neither the State of Texas nor any of its departments, agencies, or employees are or will be a party to this Notice for Bids or any resulting contract.

Equal Opportunity in Employment – All qualified applicants will receive consideration for employment without regard to race, color, religion, sex, handicap, age or national origin. Bidders on this work will be required to comply with the President's Executive Order No. 11246, as amended by Executive Order 11375, and as supplemented in Department of Labor regulations 41 CFR Part 60
