ABOUT YOUR EXPERIENCE

The **Ocean**Academy cares about your success. The school reserves the right to advise you, on behalf of the RYA, as to your eligibility to for the training course you have selected. The following questions will help us guide you into the right course(s) for you...

The RYA requires minimum experience levels to be eligible for this course and to help you achieve the goals you have. The**Ocean**Academy may advise you to undertake additional training or to delay your examination. This advice is offered to help you, not to hinder your expectations. The Minimum Requirements for the RYA Yachtmaster qualification are as follows:

Yachtmaster Offshore

50 days of experience underway.

2500 miles of distance logged.

5 passages over 60 miles each, 2 overnight and 2 as Captain.

Do you meet these requirements?

Yachtmaster Coastal

30 days of experience underway.
800 miles of distance logged.
12 hours of night experience.
2 days as Captain
Do you meet these requirements?

Do you have experience on twin engine, inboard vessels?

Do you have some experience with chart plotting and tidal calculations?

Do you have chart plotting and navigational experience to the RYA DaySkipper level?

TERMS AND CONDITIONS

You are scheduling a course that is generally in high demand and is planned well in advance of your arrival to obtain the highest level of training possible. Therefore, this Booking form must include a 50% deposit for the course selected. The remaining balance is payable on or before the start of your course. If you need to cancel your course and do so more than two weeks prior to the start of your course, you will receive a refund minus a \$200 processing fee.

If you cancel your course within two weeks of the start date you will receive a refund minus a \$500 cancelation fee.

If you cancel on the start date of the course or do not attend the course for any reason, you will, unfortunately, forfeit your payments in total.

Whether theory or practical training, the school will make every effort possible to deliver the course. However, if weather conditions are such that may risk the safety of our students, or if unforeseen issues develop, the school may see fit to cancel, reschedule or modify the training course. In this event, a credit will be given, in full, to allow you to attend the course when conditions are safe. Changes in travel plans, accommodations and related costs cannot be reimbursed by the school for situations beyond our control.

The student is required to carry out all reasonable instructions given by the school or instructor(s) during the course, and The**Ocean**Academy adheres to a strict zero tolerance policy about drugs or alcohol.

The**Ocean**Academy will facilitate and address any **complaints**. This process may include, but not be limited to, the following based on your individual situation:
