## **Leash your Pet- IMPORTANT!**

Our office has recently received reports of serious incidents involving dogs that were off leash, resulting in harm to another pet and person. The Association takes these matters very seriously, as the safety of our residents and their pets is our top priority.

In light of these incidents, we would like to remind all owners of the following requirements outlined in the Community Rules and Regulations:

- ***Animals belonging to Owners, occupants or their licensees, tenants or invitees within the Property must be either kept within an enclosure or an enclosed yard or on a leash or other restraint being held by a person capable of controlling the animal.***
- ***Residents are responsible and liable for any personal injury or property damage caused by their pets.***



Additionally, under the City of Chula Vista Municipal Code, Chapter 6.24, Section 020, dogs must be on a leash no longer than six (6) feet and under the control of a competent person in all public places, including streets and parks.


Please be advised that leaving a dog unleashed in a garage, front yard, or any area not fully enclosed is not permitted. Failure to properly restrain your pet places others at risk and may result in serious injury and costly consequences.

We strongly encourage all pet owners to take proactive measures to restrain their animal(s) when outside the confines of their home. Doing so helps prevent incidents, protects you and your pet, and ensures the safety of our entire community.
