NEW 10 Day Rules

1. Effective 1/1/21—No exhibitor may show a dog under a judge at a tracking test if the exhibitor has participated in a training session taught by that judge within ten (10) days prior to the date of the event.

2. Effective 1/1/21 People cannot act as tracklayers for dogs if, within the past 10 days, they have boarded, laid track for, or regularly trained the dogs whose tracks they are to lay. The tracklayer must not be a person with whom the dog has resided or a member of the household or a member of the immediate family of the dog's handler.

Closing Date: Even though the advertised limit has been reached, entries will be accepted until Saturday, January 24, 2026 at 5:00 pm. Tracking Dog (TD) A TD Certification issued within two years of the date of the test must be included with the entry form for all dogs not having a TD title. ACSD has implemented the Test Worker Option, giving preference for 1 TD track to past workers. Entries of dogs will be accepted only to the extent that the limit of entries is NOT filled by: 1) Dog without a TD title; 2) Dog with a TD title.

Tracking Dog Excellent (TDX) ACSD has implemented the Test Worker Option, giving preference for 1 TDX track to past workers. Entries of dogs will be accepted only to the extent that the limit of entries is NOT filled by: 1) Dog without a TDX title; 2) Dog with a TDX title.

Combined Test Exchange. This test will be held under the combined test exchange policy (AKC Tracking Regulations, Chapter 1, Section 17a). The exchange policy will be in effect with the available tracks being filled first with untitled dogs followed by titled dogs. If the limit for entries is not reached in one test at a combined TD, TDX test and the limit for entries is exceeded in the other test, the number of tracks may be exchanged, up to the day of plotting. A maximum of twelve (12) TDs or six (6) TDXs can not exceed the limits set in the AKC Tracking Regulations, Chapter 1, Section 19.

Entry fee: \$90.00 for Tracking Dog (TD) and \$135.00 for Tracking Dog Excellent (TDX). One check per entry. Fees must be paid in U.S. funds. Make checks payable to ACSD. This includes a .50 cent recording fee and a \$3.00 event fee for the AKC.

Should an entry that made the draw need to cancel, the entry fee will be returned provided that an alternate is available to fill the spot. If there are no alternates available, the entry fee will not be returned. Request for cancellation of entry must be received in writing prior to the tracking test by the test secretary. Alternate's checks will not be returned but will be shredded unless otherwise instructed.

Entry Draw: A drawing will be held at 6:00 pm on Saturday, January 24, 2026 at 4811 49th St., San Diego, CA. Entrants will be notified by email and an alternates list maintained if necessary.

JUDGING/TRACK DRAW: Tracking Dog (TD) will be drawn at 6:45 am and Tracking Dog Excellent (TDX) will be drawn at 9:15 am. All dogs entered must be at the test site at the time of their draw for running order of the tracks. Judging will begin when the tracks have sufficiently aged.

Bitches in season may participate in the test. They will be allowed to participate after all other dogs and bitches have been tested. If you have a bitch in season, park away from the other cars and immediately notify the test secretary.

By their presence on the Test grounds, all exhibitors and spectators agree to abide by the AKC Rules and Regulations and to follow the instructions of the Test Committee to the best of their Ability. Exhibitors must be aware that the test may be canceled if extreme weather conditions arise.

The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.

4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquisition, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name.
