**Closing Date:** Even though the advertised limit has been reached, entries will be accepted until **Thursday, January 4, 2018 at 5:00 pm.** All entries must be delivered to: **Marla Cook, 10323 Rosie Lane, Santee, CA 92072.**

**Tracking Dog (TD)** Entries of dogs will be accepted only to the extent that the limit of entries is NOT filled by: 1) Specialty breed without a TD title; 2) Specialty breed with a TD title; 3) Other breeds without TD title; 4) Other breeds with a TD title. A TD Certification issued within one year of the date of the test must be included with the entry form for all dogs not having a TD title. All entries must include release to deliver without signature.

**Tracking Dog Excellent (TDX)** Entries of dogs will be accepted only to the extent that the limit of entries is NOT filled by: 1) Specialty breed without a TDX title; 2) Specialty breed with a TDX title; 3) Other breeds without TDX title; 4) Other breeds with a TDX title.

**Combined Test Exchange.** This test will be held under the combined test exchange policy (AKC Tracking Regulations, Chapter 1, Section 13a). The exchange policy will be in effect with the available tracks being filled first with untitled dogs followed by titled dogs. If the limit for entries is not reached in one test at a combined TD, TDX test and the limit for entries is exceeded in the other test, the number of tracks may be exchanged, up to the day of plotting. The maximum of twelve (12) TDs or six (6) TDXs can not exceed the limits set in the AKC Tracking Regulations, Chapter 1, Section 15.

**Entry fee:** \$50.00 for Tracking Dog (TD). \$100.00 for Tracking Dog Excellent (TDX). One check per entry. Fees must be paid in U.S. funds. Make checks payable to GSDSD. This includes a .50 cent recording fee and \$3.00 event fee for the AKC. Alternate's checks will not be returned but will be shredded unless otherwise instructed.

Entry fees will be returned to those that did not make the draw (after the test). Should an entry that made the draw need to cancel, the entry fee will be returned provided that an alternate is available to fill the spot. If there are no alternates available, the entry fee will not be returned. Request for cancellation of entry must be received in writing 4 days prior to the tracking test by the test secretary.

**Entry Draw:** A drawing will be held at 8:30 am on Friday, January 5, 2018 at McDonald's, 8876 Cuyamaca, Santee CA 92071. Take highway 52 to Cuyamaca. Go north on Cuyamaca approximately 1/4 mile. Entrants will be notified by email and an alternates list maintained if necessary.

**JUDGING/TRACK DRAW:** 3 Tracking Dog (TD) tracks will be drawn at 6:45 am.. 3 Tracking Dog Excellent (TDX) tracks will be drawn at 9:00 am. All dogs entered must be at the test site at the time of their draw for running order of the tracks. Judging will begin when the tracks have sufficiently aged.

Bitches in season may participate in the test. They will be allowed to participate after all other dogs and bitches not in season have been tested. If you have a bitch in season, park away from the other cars and immediately notify the test secretary.

By their presence on the Test grounds, all exhibitors and spectators agree to abide by the AKC Rules and Regulations and to follow the instructions of the Test Committee to the best of their ability. The owner or agent entering a dog in a Tracking Test does so at his or her own risk.
