Test limited to Variable Surface Tracking (VST) 4 tracks

**Closing Date:** Even though the advertised limit has been reached, entries will be accepted until Thursday, April 19, 2018 at 5:00 pm. All entries must be delivered to: **Marla Cook, 10323 Rosie Lane, Santee, CA 92072 .**

### Variable Surface Tracking (VST)

Entries of dogs will be accepted only to the extent that the limit of entries is NOT filled by: 1) dog without a VST title and a TD title; 2) dog with a VST title. All entries must include release to deliver without signature.

**Entry fee:** \$100.00 for Variable Surface Tracking (VST) Fees must be paid in U.S. funds. Make checks payable to ACSD. One check per entry. This includes a .50 cent recording fee and \$3.00 event fee for the AKC. Alternate's checks will not be returned but will be shredded unless otherwise instructed.

Entry fees will be returned to those that did not make the draw (after the test). Should an entry that made the draw need to cancel, the entry fee will be returned provided that an alternate is available to fill the spot. If there are no alternates available, the entry fee will not be returned. Request for cancellation of entry must be received in writing 4 days prior to the tracking test by the test secretary.

**Entry Draw:** A drawing will be held at 8:30 am on April 20, 2018 at McDonald's, 8876 Cuyamaca, Santee CA 92071. Take highway 52 to Cuyamaca. Go north on Cuyamaca approximately 1/4 mile. Entrants will be notified by email and an alternates list maintained if necessary.

**JUDGING/TRACK DRAW: Variable Surface Tracking (VST)** tracks will be drawn at and at 7:45 am. All dogs entered must be at the test site at the time of their draw for running order of the tracks. Judging will begin when the tracks have sufficiently aged.

Bitches in season may participate in the test. They will be allowed to participate after all other dogs and bitches not in season have been tested. If you have a bitch in season, park away from the other cars and immediately notify the test secretary.

By their presence on the Test grounds, all exhibitors and spectators agree to abide by the AKC Rules and Regulations and to follow the instructions of the Test Committee to the best of their ability. The owner or agent entering a dog in a Tracking Test does so at his or her own risk.

Exhibitors must be aware that the test may be canceled if extreme weather conditions arise.
