Test limited to 4 Variable Surface Tracking (VST) tracks

Closing Date: Even though the advertised limit has been reached, entries will be accepted until Thursday, March 7, 2019 at 5:00 pm. All entries must be delivered to: Marla Cook, 10323 Rosie Lane, Santee, CA 92071

Entry fee: \$100.00 for Variable Surface Tracking (VST). Fees must be paid in U.S. funds. Make checks payable to BTCSC. One check per entry is required. This includes a .50 cent recording fee and \$3.00 event fee for the AKC.

Entries of dogs will be accepted only to the extent that the limit of entries is NOT filled by: 1) Specialty breed without a VST title and with a TD title; 2) Specialty breed with a VST title; 3) Other breeds without a VST title and with a TD title; 4) Other breeds with a VST title. All entries must include release to deliver without signature.

Entry fees will be returned to those that did not make the draw (after the test). Should an entry that made the draw need to cancel, the entry fee will be returned provided that an alternate is available to fill the spot. If there are no alternates available, the entry fee will not be returned. Request for cancellation of entry must be received in writing 4 days prior to the tracking test by the test secretary.

Entry Draw: A drawing will be held at 8:30 am on March 8, 2019 at McDonald's, 8876 Cuyamaca, Santee CA 92071. Take highway 52 to Cuyamaca. Go north on Cuyamaca approximately 1/4 mile. Entrants will be notified by email and an alternates list maintained if necessary.

JUDGING/TRACK DRAW: Variable Surface Tracking (VST) tracks will be drawn at 7:45 am. All dogs entered must be at the test site at the time of their draw for running order of the tracks. Judging will begin when the tracks have sufficiently aged.

Bitches in season may participate in the test. They will be allowed to participate after all other dogs and bitches not in season have been tested. If you have a bitch in season, park away from the other cars and immediately notify the test secretary.
