### \*\*\*\*\*IMPORTANT\*\*\*\*\* 30 Day Rules

1. No exhibitor may show a dog under a judge at a tracking test if the exhibitor has participated in a training session taught by that judge within thirty (30) days prior to the date of the event.

2. People cannot act as tracklayers for dogs if, within the past 30 days, they have boarded, laid a track for, or regularly trained the dogs whose tracks they are to lay. The tracklayer must not be a person with whom the dog has resided or a member of the household or a member of the immediate family of the dog's handler. Chapter 2, Sec 9, page 10

## Test Information

### Test Limited to : 4 Variable Surface Tracking (VST) tracks:

**Closing Date:** Even though the advertised limit has been reached, entries will be accepted until Thursday, June 27, 2019 at 5:00 pm. All entries must be delivered to: **Marla Cook, 10323 Rosie Lane, Santee, CA 92071** .

**Variable Surface Tracking (VST)** Entries of dogs will be accepted only to the extent that the limit of entries is NOT filled by: 1) Specialty breed without a VST title and with a TD or TDX title; 2) Specialty breed with a VST title; 3) Other breeds without a VST title and with a TD or TDX title; 4) Other breeds with a VST title. All entries must include release to deliver without signature.

**Entry fee:** \$100.00 for Variable Surface Tracking (VST). One check per entry. Fees must be paid in U.S. funds. Make checks payable to GSDSD. This includes a .50 cent recording fee and a \$3.00 event fee for the AKC.

Should an entry that made the draw need to cancel, the entry fee will be returned provided that an alternate is available to fill the spot. If there are no alternates available, the entry fee will not be returned. Request for cancellation of entry must be received in writing prior to the tracking test by the test secretary. Alternate's checks will not be returned but will be shredded unless otherwise instructed.

**Entry Draw:** A drawing will be held at 8:30 am on Friday, June 28, 2019 at McDonald's, 8876 Cuyamaca, Santee CA 92071. Take highway 52 to Cuyamaca. Go north on Cuyamaca approximately 1/4 mile.. Entrants will be notified by email and an alternates list maintained if necessary.

**JUDGING/TRACK DRAW:** Variable Surface Tracking (VST) will be drawn at 7:45 am. All dogs entered must be at the test site at the time of their draw for running order of the tracks. Judging will begin when the tracks have sufficiently aged.

Bitches in season may participate in the test. They will be allowed to participant after all other dogs and bitches in season have been tested. If you have a bitch in season, park away from the other cars and immediately notify the test secretary.

By their presence on the Test grounds, all exhibitors and spectators agree to abide by the AKC Rules and Regulations and to follow the instructions of the Test Committee to the best of their Ability.

Exhibitors must be aware that the test may be canceled if extreme weather conditions arise.
