*****IMPORTANT*****

NEW 10 Day Rules

1. Effective 1/1/21—No exhibitor may show a dog under a judge at a tracking test if the exhibitor has participated in a training session taught by that judge within ten (10) days prior to the date of the event.

2. Effective 1/1/21—People cannot act as tracklayers for dogs if, within the past 10 days, they have boarded, laid track for, or regularly trained the dogs whose tracks they are to lay. The tracklayer must not be a person with whom the dog has resided or a member of the household or a member of the immediate family of the dog's handler.

Test Information

Test Limited to : 4 Variable Surface Tracking (VST)

Closing Date: Even though the advertised limit has been reached, entries will be accepted until Thursday, March 12, 2026 at 5:00 pm. All entries must be **mailed** to: **Sarah Ball, 4811 49th St., San Diego, CA 92115. NO HAND DELIVERED OR EMAILED ENTRIES WILL BE ACCEPTED.** Overnight deliveries must include release to deliver without signature.

Variable Surface Tracking (VST) SRCSD has implemented the Test Worker Option, giving preference for 1 VST track to past workers. Entries of dogs will be accepted only to the extent that the limit of entries is NOT filled by: 1) Specialty breed without a VST title and with a TD title; 2) Specialty breed with a VST title; 3) Other breeds without a VST title and with a TD title; 4) Other breeds with a VST title. All entries must include release to deliver without signature.

Entry fee: \$135.00 for Variable Surface Tracking (VST). One check per entry. Fees must be paid in U.S. funds. Make checks payable to SRCSD. This includes a .50 cent recording fee and a \$3.00 event fee for the AKC.

Should an entry that made the draw need to cancel, the entry fee will be returned provided that an alternate is available to fill the spot. If there are no alternates available, the entry fee will not be returned. Request for cancellation of entry must be received in writing prior to the tracking test by the test secretary. Alternate's checks will not be returned but will be shredded unless otherwise instructed.

Entry Draw: A drawing will be held at 6:00 pm on Thursday, March 12, 2026 at 4811 49th St., San Diego, CA 92115. Entrants will be notified by email and an alternates list maintained if necessary.

JUDGING/TRACK DRAW: Variable Surface Tracking (VST) Tracks will be drawn 7:45 am. All dogs entered must be at the test site at the time of their draw for running order of the tracks. Judging will begin when the tracks have sufficiently aged.

Bitches in season may participate in the test. They will be allowed to participate after all other dogs and bitches have been tested. If you have a bitch in season, park away from the other cars and immediately notify the test secretary.

By their presence on the Test grounds, all exhibitors and spectators agree to abide by the AKC Rules and Regulations and to follow the instructions of the Test Committee to the best of their Ability. Exhibitors must be aware that the test may be canceled if extreme weather conditions arise.
