# \*\*\*\*\*IMPORTANT\*\*\*\*\* NEW 10 Day Rules

- 1. Effective 1/1/21—No exhibitor may show a dog under a judge at a tracking test if the exhibitor has participated in a training session taught by that judge within ten (10) days prior to the date of the event.
- 2. Effective 1/1/21—People cannot act as tracklayers for dogs if, within the <u>past 10 days</u>, they have boarded, laid track for, or regularly trained the dogs whose tracks they are to lay. The tracklayer must not be a person with whom the dog has resided or a member of the household or a member of the immediate family of the dog's handler.
