# \*\*\*\*\*IMPORTANT\*\*\*\*\* NEW 10 Day Rules

- 1. Effective 1/1/21—No exhibitor may show a dog under a judge at a tracking test if the exhibitor has participated in a training session taught by that judge within ten (10) days prior to the date of the event.
- 2. Effective 1/1/21—People cannot act as tracklayers for dogs if, within the <u>past 10 days</u>, they have boarded, laid track for, or regularly trained the dogs whose tracks they are to lay. The tracklayer must not be a person with whom the dog has resided or a member of the household or a member of the immediate family of the dog's handler.

**Variable Surface Tracking (VST)** GSDCSD has implemented the Test Worker Option, giving preference for 1 VST track to past workers. Entries of dogs will be accepted only to the extent that the limit of entries is NOT filled by: 1) Specialty breed without a VST title and with a TD or TDX title; 2) Specialty breed with a VST title; 3) Other breeds without a VST title and with a TD title; 4) Other breeds with a VST title.

**Entry fee**: S125.00 for Variable Surface Tracking (VST). One check per entry. Fees must be paid in U.S. funds. Make checks payable to GSDSD. This includes a .50 cent recording fee and a \$3.00 event fee for the AKC.

Should an entry that made the draw need to cancel, the entry fee will be returned provided that an alternate is available to fill the spot. If there are no alternates available, the entry fee will not be returned. Request for cancellation of entry must be received in writing prior to the tracking test by the test secretary. Bitches in season may participate in the test. They will be allowed to participant after all other dogs and bitches have been tested. If you have a bitch in season, park away from the other cars and immediately notify the test secretary.
