## Test Information

**JUDGING/TRACK DRAW: VST track running order will be drawn at 7:45 am. All dogs entered must be at the test site at the time of the draw for running order of the tracks. Judging will begin when the tracks have sufficiently aged.**

**Test limited to 4 Variable Surface Tracking (VST) tracks.**

BTCSC has implemented the Test Worker Option, giving preference for one VST track to past workers.

**Closing Date:** Even though the advertised limit has been reached, entries will be accepted until **Thursday, March 5, 2026 at 5:00 pm**. All entries must be delivered to: **Sarah Ball, Test Secretary, 4811 49<sup>th</sup> St., San Diego, CA 92115.**

**NO HAND DELIVERED OR EMAILED ENTRIES WILL BE ACCEPTED**

**Entry fee:** \$135.00 for Variable Surface Tracking (VST). Fees must be paid in U.S. funds. **Make checks payable to BTCSC.** One check per entry is required. This includes a .50 cent recording fee and \$4.00 event fee for the AKC.

Entries of dogs will be accepted only to the extent that the limit of entries is NOT filled by: 1) Belgian Tervuren without a VST title and with a TD title; 2) Belgian Tervuren with a VST title; 3) Other AKC breeds without a VST title and with a TD title; 4) Other AKC breeds with a VST title. All Americans are allowed in this test. All entries must include release to deliver without signature.

Entry fees will be returned after the test to those that did not make the draw. Should an entry that made the draw need to cancel, the entry fee will be returned provided that an alternate is available to fill the spot. If there are no alternates available, the entry fee will not be returned. Request for cancellation of entry must be received in writing prior to the tracking test by the test secretary. Alternate's checks will not be returned but will be shredded unless otherwise instructed.

**Entry Draw:** A drawing will be held at 6:00 pm on March 5, 2026, at 4811 49<sup>th</sup> St., San Diego, CA 92115. Entrants will be notified by email and an alternates list maintained if necessary.

Bitches in season may participate in the test. They will be allowed to run their tracks after all other dogs and bitches not in season have been tested. If you have a bitch in season, park away from the other cars and immediately notify the test secretary.

By their presence on the test grounds, all exhibitors and spectators agree to abide by AKC Rules and Regulations and to follow the instructions of the Test Committee to the best of their ability. The owner or agent entering a dog in a Tracking Test does so at his or her own risk.

Please follow current Covid-19 safety protocols.

Exhibitors must be aware that the test may be canceled if extreme weather conditions arise.

### **Dogs On Leash!**

**Dogs shall be kept on leash at all times in any area of the test site. Any dog not on leash before, during or after the tracking test will not qualify.**



AGREEMENT

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other persons. INSTRUCTIONS

1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, age division, color division, weight division.

4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)

5. Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.
