

#### **NEW 10 Day Rules**

- 1. Effective 1/1/21—No exhibitor may show a dog under a judge at a tracking test if the exhibitor has participated in a training session taught by that judge within ten (10) days prior to the date of the event.
- 2. Effective 1/1/21 People cannot act as tracklayers for dogs if, within the past 10 days, they have boarded, laid track for, or regularly trained the dogs whose tracks they are to lay. The tracklayer must not be a person with whom the dog has resided or a member of the household or a member of the immediate family of the dog's handler.

A TD Certification issued within two years of the date of the test must be included with the entry form for all dogs not having a TD title. Any tracking certification that expires 3/1/20 through 12/31/20 will be granted an additional one-year extension, e.g. a certification that would expire 10/1/20 will not expire until 10/1/21.
