

- 1. No exhibitor may show a dog under a judge at a tracking test if the exhibitor has participated in a training session taught by that judge within thirty (30) days prior to the date of the event. Chapter 1, Sec 12, page 10
- 2. People cannot act as tracklayers for dogs if, within the past 30 days, they have boarded, laid a track for, or regularly trained the dogs whose tracks they are to lay.
