# **NEW 10 Day Rules**

- 1. Effective 1/1/21—No exhibitor may show a dog under a judge at a tracking test if the exhibitor has participated in a training session taught by that judge within <u>ten (10) days</u> prior to the date of the event.
- 2. Effective 1/1/21—People cannot act as tracklayers for dogs if, within the <u>past 10 days</u>, they have boarded, laid track for, or regularly trained the dogs whose tracks they are to lay. The tracklayer must not be a person with whom the dog has resided or a member of the household or a member of the immediate family of the dog's handler.

Variable Surface Tracking (VST) GRCSDCo. has implemented the Test Worker Option, giving preference for 1 VST track to past workers. Entries of dogs will be accepted only to the extent that the limit of entries is NOT filled by: 1) Specialty breed without a VST title and with a TD title; 2) Specialty breed with a VST title; 3) Other breeds without a VST title and with a TD title; 4) Other breeds with a VST title.
