HOLLYWOOD DOG OBEDIENCE CLUB offers a plaque to each dog passing the TD or TDX tracking test.

HDOC has implemented the Test Worker Option giving preference for one (1) of the tracks per test to past workers.

**NOTE: Entries close 6:00 p.m. Thursday January 26, 2023**

The Hollywood Dog Obedience Club will hold a Tracking Test and a Tracking Test Excellent on Sunday, February 5, 2023. The Tracking Test will be limited to 3 dogs; the Tracking Test Excellent will be limited to 3 dogs. We will accept alternates. In the event that the Tracking Test or the Tracking Test Excellent does not fill we reserve the right exchange tracks at a ratio of 2 TD per TDX track.

One (1) TD track will be set-aside for previous workers in each test. If you wish to use the worker certificate, you **must** send it with your entry.

Bitches in season may participate in accordance with AKC Tracking Regulations, Chapter 2, Section 8. Please keep bitches in season in your vehicle and notify the Test Secretary upon arrival.

Entry fee is **\$110.00** for the Tracking Test and **\$125.00** for the Tracking Test Excellent (fee includes the required AKC recording fee). Make checks payable to HDOC Inc.

Entries must be made on an official AKC entry form that includes the Agreement. Do not send entries by any method requiring a signature for delivery.

A written statement, dated within two years of the date on the entry form, certifying that the dog entered is considered ready for such a test, signed by a person approved by the American Kennel Club to Judge a Tracking Tests or by a person/evaluator who has handled a dog to a TDX or VST title **must accompany each entry form for a dog who has not passed a Tracking Test**. Written permission to waive or modify this requirement may be granted by AKC in unusual circumstances.

A drawing to determine participants required by AKC in the Tracking Regulations, Chapter 1, Sec. 17, will be held Thursday January 26, 2023 at 6:00 PM at: 28262 Rey de Copas Ln, Malibu, CA 90265

**DIRECTIONS TO TRACKING SITE:** Prado Regional Park is located in Chino, a city in San Bernardino County, in Southern California. It is located in the western end of the Riverside-San Bernardino Area and it is easily accessible via the Chino Valley (71) and Pomona freeways (60). (<http://cms.sbcounty.gov/parks/Parks/PradoRegionalPark.aspx>)

From the 71 Freeway exit # 4 (Butterfield Ranch RD./Euclid Ave). Euclid Ave/CA 83 is to the east of the 71 Freeway. As you travel on Euclid Avenue/CA 83 you will pass the Prado Recreation Dog Park before you come to Prado Regional Park. Base Camp will be at the far end of the park, near the recreation center and the RV camping site. There is an \$10 entry fee plus \$1 dog fee. Dogs must be on leash at all times.

Directions: Exit the Park and turn right onto Euclid Avenue, go north 6 miles on CA 83. Turn right onto East Riverside Drive 2.3 miles, turn left on S. Vineyard Avenue for .7 mile.

**ALL CANCELLATIONS** of entries must be made in writing to the Test Secretary and received prior to the stated date and time of closing entries. Entry fees will be returned to those who did not make the draw after the test. Should an entry that made the draw need to cancel, the entry fee will be returned provided an alternate is available to fill the spot.

**DRAW FOR TRACKS:** Track order for TD will be at 6: a.m. All dogs entered must be at the test site at the time of their draw for running order. Judging will begin when the tracks have aged sufficiently. Track order for TDX will be when TD test is done, not before 9:00 am.

By their presence on the Test grounds, all exhibitors and spectators agree to abide by the AKC Rules and Regulations and to follow the instructions of the Test Committee to the best of their ability. The owner or agent entering a dog in a Tracking Test or Tracking Test Excellent does so at his or her own risk.

Exhibitors must be aware that the test may be cancelled if extreme weather conditions arise.

DOGS SHALL BE KEPT ON LEASH AT ALL TIMES IN ANY AREA OF THE TEST SITE. ANY DOG THAT IS IN THE TRACKING TEST THAT IS NOT ON A LEASH BEFORE, DURING OR AFTER THE TRACKING TESTS WILL **NOT** QUALIFY.

Potty your dogs in designated dog-potty area. Signs for potty area will be posted.
