From the North: CA 60 (Pomona Freeway) to CA 71 (Chino Valley Freeway) south. Exit at Butterfield Ranch Road (Euclid Avenue). Turn right on Butterfield Ranch Road and go under the freeway. The road becomes Euclid Avenue. Follow Euclid to the park entrance.

NOTE: Do not turn right at the dog training center signs. That is Prado Recreation Dog Park. The Prado Regional Park entrance is approximately 1/2 mile east of this.

Meet at the **Elm Group Camp site**. Please park there.

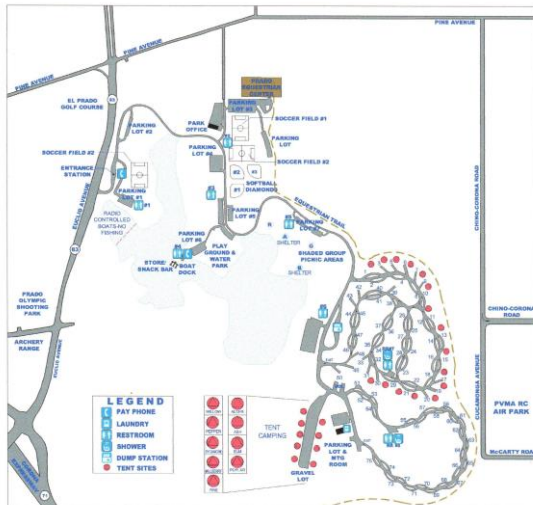

### 10 Day Rules

1. Effective 1/1/21 No exhibitor may show a dog under a judge at a tracking test if the exhibitor has participated in a training session taught by that judge within ten (10) days prior to the date of the event.

2. Effective 1/1/21 People cannot act as tracklayers for dogs if, within the past 10 days, they have boarded, laid track for, or regularly trained the dogs whose tracks they are to lay. The tracklayer must not be a person with whom the dog has resided or a member of the household or a member of the immediate family of the dog's handler.

**Tracking Dog (TD)** A TD Certification issued within two years of the date of the test must be included with the entry form for all dogs not having a TD title. GWFCR Club has implemented the Test Worker Option, giving preference for 2 TD tracks to past workers. Entries of dogs will be accepted only to the extent that the limit of entries is NOT filled by: 1) Specialty breed without a TD title; 2) Specialty breed with a TD title; 3) Other breeds without TD title; 4) Other breeds with a TD title.

**Tracking Dog Excellent (TDX)** GWFCR Club has implemented the Test Worker Option, giving preference for 1 TDX track to past workers. Entries of dogs will be accepted only to the extent that the limit of entries is NOT filled by: 1) Specialty breed without a TDX title; 2) Specialty breed with a TDX title; 3) Other breeds without TDX title; 4) Other breeds with a TDX title.

**Combined Test Exchange.** This test will be held under the combined test exchange policy (AKC Tracking Regulations, Chapter 1, Section 17a). The exchange policy will be in effect with the available tracks being filled first with untitled dogs followed by titled dogs. If the limit for entries is not reached in one test at a combined TD/TDX test and the limit for entries is exceeded in the other test, the number of tracks may be exchanged up to the day of plotting. The maximum of 11 TDs or 6 TDXs cannot exceed the limits set in the AKC Tracking Regulations, Chapter 1, Section 19.

**Entry fee:** \$125 for Tracking Dog (TD) \$125 for Tracking Dog Excellent (TDX). One check per entry. Fees must be paid in U.S. funds. Make checks payable to GWFCR Club. This includes a .50 cent recording fee and a \$3.00 event fee for the AKC.

Should an entry that made the draw need to cancel, the entry fee will be returned provided that an alternate is available to fill the spot. If there are no alternates available, the entry fee will not be returned. Request for cancellation of entry must be received in writing prior to the tracking test by the Test Secretary. Alternate's checks will not be returned but will be shredded unless otherwise instructed.

**Entry Draw:** A drawing will be held at 6:00 pm on Thursday, January 29, 2025 at 16817 Fox Glen Road, Riverside, CA 92504 or via video conference. Entrants will be notified by email and an alternates list maintained if necessary.

**JUDGING/TRACK DRAW:** Tracking Dog (TD) will be drawn at 6:45 am and Tracking Dog Excellent (TDX) will be drawn at 9:15 am. All dogs entered must be at the test site at the time of their draw for running order of the tracks. Judging will begin when the tracks have sufficiently aged.

Bitches in season may participate in the test. They will be allowed to participate after all other dogs and bitches have been tested. If you have a bitch in season, park away from the other cars and immediately notify the test secretary.

By their presence on the test grounds, all exhibitors and spectators agree to abide by the AKC Rules and Regulations and to follow the instructions of the Test Committee to the best of their ability. Exhibitors must be aware that the test may be canceled if extreme weather conditions arise.

3. (Event Class) Consult the classification in this premium list. 4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed.
