Combined Test Exchange. This test will be held under the combined test exchange policy (AKC Tracking Regulations, Chapter 1, Section 17a). The exchange policy will be in effect with the available tracks being filled first with untitled dogs followed by titled dogs. If the limit for entries is not reached in one test at a combined TD, TDX test and the limit for entries is exceeded in the other test, the number of tracks may be exchanged, up to the day of plotting.
