APPLICATION PROCESS & DUES

The application process takes three (3) meetings. First Reading takes place at the first lodge meeting following the application received by our Lodge Secretary. Your sponsor will speak about you to the membership. The Second Reading takes place next. At this meeting, you are asked to contact the Lodge Secretary to schedule an appointment with the Executive Board where you will be asked questions about yourself. At the Third Reading, the membership will once again hear from your sponsor and vote on your membership. If approved, you will swear the oath of office that you signed on page 1 of this application. Dues are \$180 per calendar year and we begin collecting in October. You are expected to pay a prorated dues amount following your swearing in: Jan \$180, Feb \$165, Mar \$150, Apr \$135, May \$120, Jun \$105, Jul \$90, Aug \$75, Sep \$60, Oct \$45 + \$180, Nov \$30 + \$180, Dec \$195
