- #1. I am Herbert William Mullin. I believe that the exhibits in this Petition show clearly that I am in need of Competant Legal Counsel.
- #2. The exhibits indicate that am 57 years old and have been in prison in California scince February 13th, 1973. Some 312 years (approx.). The crime spree that resulted because of the psychological & sexual abuse needs to be brought to Court and re-evaluated. My former family & former friends & the catholic church should not be allowed freedom from chastisement by your Honorable Court.
- Incompetance of Legal Counsel is part of the problem. At the orig-#3. inal Criminal Trial in the Summer of 1973 (*XXXXXX)(Trial # 50219 in Santa Cruz County) my Fublic Defender, James Jackson, refused to put the Catholic Priest on the stand to be cross examined. Furthermore, James Jackson's Home Residence was burned to the ground during the first week of the trial against me. After his home residence burned down he became very incompetant and inefficient. Springer was an Electronics Retail Store manager in Felton, California, where I lived & went to High School in 1963 & 64 & 65. When I went into his store for the first time in 1963 and asked about purchasing a phonograph, he became extremely verbally abusive and threatened me with MATA harm because I would not buy a \$ 300.00 phonograph.
