OHIO TITLE BOX

This is a corrective amendment to the Seventh Amendment to the Declaration and Drawings of WORTHINGTON GLEN CONDOMINIUM, made on or as of the 27 day of November, 1995.

Recitals

A. Worthington Glen Condominium is a condominium created pursuant to the provisions of Chapter 5311 of the Revised Code of Ohio ("the Condominium Act") by the filing of the Declaration of Worthington Glen Condominium, and the Drawings thereof, recorded, respectively, in Official Records 11960A-01 et seq., and Condominium Plat Book 41, page 70 et seq., both of the records of the Recorder of Franklin County, Ohio, and all amendments thereto.

→ B. The Seventh Amendment to the Declaration and Drawings, recorded, respectively, at Official Record Volume 14100G-12 et seq., and Condominium Plat Book 44, page 97 et seq., both of the records of the Recorder of Franklin County, Ohio, among other things, added Units 48A, 48B, 48C, 43-D, 48-E and 48-F to the Condominium. By inadvertent error these Units were shown in reverse order on Exhibit D of the Seventh Amendment to the Declaration and on the first page of the Seventh Amendment to the Declaration to that intended and believed to be the case by the Declarant and the purchasers of these Units.

C. Declarant desires by this corrective amendment to correct these errors, the Worthington Glen Condominium Association joins in to approve and adopt this corrective amendment, and the owners of each of those Units, by their consents attached hereto, approve, adopt, consent and agree to this corrective amendment.

Corrective Amendment

NOW THEREFORE, the Seventh Amendment to the Declaration of and the Drawings for Worthington Glen Condominium are hereby amended and corrected as follows:

1. Declaration. Exhibit D of the Seventh Amendment to the Declaration of Condominium of Worthington Glen Condominium is hereby superseded and replaced, in its entirety, by the attached Exhibit D, which is hereby approved and adopted, and which correctly shows the location of Units added by that Seventh Amendment.

2. Drawings. The first page of the Seventh Amendment to the Drawings for Worthington Glen Condominium is hereby superseded and replaced, in its entirety, by the attached "Corrective Amendment to Worthington Glen Condominium Drawings," which is hereby approved and adopted, and which correctly shows the location of Units added by that Seventh Amendment. 


