Bighth Amendment to the Declaration of Condominium of Worthington Glen Condominium

This Eighth Amendment to the Declaration of Worthington Glen Condominium is made this ______ day of _______, 1990.

Recitals

- A. Worthington Glen Condominium is a condominium created pursuant to the provisions of Chapter 5311 of the Ohio Revised Code by the filing of the Declaration of Worthington Glen Condominium and the drawings hereof, recorded respectively in Official Record Volume 11960, at page A-01 and Condominium Plat Book 41, at page 70, both of the records of the Recorder of Franklin County, Ohio, and all amendments thereto.
- B. Pursuant to Article XIX of the Declaration, and the provisions of Ohio Revised Code Section 5311, the undersigned officers of the Condominium hereby certify that the following amendment has been promulgated according to the terms of Article XIX of the Declaration and that at least 75% of all unit owners have consented to the following amendment.

Now therefore, the Declaration of Condominium and all prior amendments thereto are hereby amended as follows:

- 1. Limited Common Areas, Patio Areas Only. The limited common areas, patio areas only, shall be increased in dimension from 8 feet deep x 16 feet wide to 10 feet deep x 16 feet wide; except, that each unit with a "G" designation, being those three (3) bedroom units on the ends of each building with attached garages shall have limited common areas for patio purposes in the dimensions of 27 feet wide and 19 feet deep adjacent to the garage and 10 feet deep adjacent to the adjoining unit.
- 2. Remaining Provisions Unchanged. The remaining provisions of the Declaration and all prior amendments shall remain unchanged.
