

REMEMBERING MARTIN LUTHER KING JR.



Martin Luther King Jr. was a social activist **Baptist** and minister who played a key role in the American civil rights movement from the mid-1950s until his assassination 1968. in King sought equality and human rights African for Americans, the

economically disadvantaged and all victims of injustice through peaceful proest. He was the driving force behind watershed events such as the Montgomery Bus Boycott and the 1963 March on Washington, which helped bring about such landmark legislation as the Civil Rights Act and the Voting Rights Act. King was awarded the Nobel Peace Prize in 1964 and is remembered each year on Martin Luther King Jr. Day, a U.S. federal holiday since 1986.

Martin Luther King Jr. was born on January 15, 1929, in Atlanta, Georgia, the second child of Martin Luther King Sr., a pastor, and Alberta Williams King, a former schoolteacher.

Along with his older sister Christine and younger brother Alfred Daniel Williams, he grew up in the city's Sweet Auburn neighborhood,

then home to some of the most prominent and prosperous African Americans in the country.

A gifted student, King attended segregated public schools and at the age of 15 was admitted to Morehouse College, the alma mater of both his father and maternal grandfather, where he studied medicine and law.

Although he had not intended to follow in his father's footsteps by joining the ministry, he changed his mind under the mentorship of Morehouse's president, Dr. Benjamin Mays, an influential theologian and outspoken advocate for racial equality. After graduating in 1948, King entered Crozer Theological Seminary in Pennsylvania, where he earned a Bachelor of Divinity degree, won a prestigious fellowship and was elected president of his predominantly white senior class.

King then enrolled in a graduate program at Boston University, completing his coursework in 1953 and earning a doctorate in systematic theology two years later. While in Boston he met Coretta Scott, a young singer from Alabama who was studying at the New England Conservatory of Music. The couple wed in 1953 and settled in Montgomery, Alabama, where King became pastor of the Dexter Avenue Baptist Church.

The Kings had four children: Yolanda Denise King, Martin Luther King III, Dexter Scott King and Bernice Albertine King.

The King family had been living in Montgomery for less than a year when the highly segregated city became the epicenter of the burgeoning struggle for civil rights in America, galvanized by the landmark Brown v. Board of Education decision of 1954.

On December 1, 1955, Rosa Parks, secretary of the local chapter of the National Association for the Advancement of Colored People (NAACP), refused to give up her seat to a white passenger

on a Montgomery bus and was arrested. Activists coordinated a bus boycott that would continue for 381 days. The Montgomery Bus Boycott placed a severe economic strain on the public transit system and downtown business owners. They chose Martin Luther King Jr. as the protest's leader and official spokesman.



Emboldened by the success of the Montgomery Bus Boycott, in 1957 he and other civil rights activists—most of them fellow ministers— founded the Southern Christian Leadership Conference (SCLC), a group committed to achieving full equality for African Americans through nonviolent protest.

The SCLC motto was "Not one hair of one head of one person should be harmed." King would remain at the helm of this influential organization until his death.

In his role as SCLC president, Martin Luther King Jr. traveled across the country and around the world, giving lectures on nonviolent protest

and civil rights as well as meeting with religious figures,

activists and political leaders.

During a month-long trip to India in 1959, he had the opportunity to meet family members and followers of Gandhi, the man he described in his autobiography as "the guiding light of our technique of nonviolent social change." King also authored several books and articles during this time.

In 1960 King and his family moved to Atlanta, his native city, where he joined his father as co- pastor of the Ebenezer Baptist Church. This new position did not stop King and his SCLC colleagues from becoming key players in many of the most significant civil rights battles of the 1960s. Their philosophy of nonviolence was put to a particularly severe test during the Birmingham campaign of 1963, in which activists used a boycott, sit-ins and marches to protest segregation, unfair hiring practices and other injustices in one of America's most racially divided cities.

Arrested for his involvement on April 12, King penned the civil rights manifesto known as the "Letter from Birmingham Jail," an eloquent defense of civil disobedience addressed to a group of white clergymen who had criticized his tactics.

The SCLC motto was "Not one hair of one head of one person should be harmed."

Later that year, Martin Luther King Jr. worked with a number of civil rights and religious groups to organize the March on Washington for Jobs and Freedom, a peaceful political rally designed to shed light on the injustices Black Americans continued to face across the country. Held on August 28 and attended by some 200,000 to 300,000 participants, the event is widely regarded as a watershed moment in the history of the American civil rights movement and a factor in the passage of the Civil Rights Act of 1964.

The March on Washington culminated in King's most famous address, known as the "I Have a Dream" speech, a spirited call for peace and equality that many consider a masterpiece of rhetoric. Standing on the steps of the Lincoln Memorial—a monument to the president who a century earlier had brought down the institution of slavery in the United States—he shared his vision of a future in which "this nation will rise up and live out the true meaning of its creed: 'We hold these truths to be self-evident, that all men are created equal."" The speech and march cemented King's reputation at home and abroad; later that year he was named "Man of the Year" by TIME magazine and in 1964 became, at the time, the youngest person ever awarded the Nobel Peace Prize.

In the spring of 1965, King's elevated profile drew international attention to the violence that erupted between white segregationists and peaceful demonstrators in Selma, Alabama, where the SCLC and Student Nonviolent Coordinating Committee (SNCC) had organized a voter registration campaign.

Captured on television, the brutal scene outraged many Americans and inspired supporters from across the country to gather in Alabama and take part in the Selma to Montgomery march led by King and supported by President Lyndon B. Johnson, who sent in federal troops to keep the peace.

That August, Congress passed the Voting Rights Act, which guaranteed the right to vote— first awarded by the 15th Amendment—to all African Americans.

The events in Selma deepened a growing rift between

Martin Luther King Jr. and young radicals who repudiated his nonviolent methods and commitment to working within the established political framework.

As more militant Black leaders such as Stokely Carmichael rose to prominence, King broadened the scope of his activism to address issues such as the Vietnam War and poverty among Americans of all races. In 1967, King and the SCLC embarked on an ambitious program known as the Poor People's Campaign, which was to include a massive march on the capital.


By the time the Supreme Court ruled segregated seating on public buses unconstitutional in November 1956, King— heavily influenced by Mahatma Gandhi and the activist Bayard Rustin—had entered the national spotlight as an inspirational proponent of organized, nonviolent resistance.

King had also become a target for white supremacists, who firebombed his family home that January.

On September 20, 1958, Izola Ware Curry walked into a Harlem department store where King was signing books and asked, "Are you Martin Luther King?" When he replied "yes," she stabbed him in the chest with a knife. King survived, and the attempted assassination only reinforced his dedication to nonviolence: "The experience of these last few days has deepened my faith in the relevance of the spirit of nonviolence if necessary social change is peacefully to take place."

On the evening of April 4, 1968, Martin Luther King was assassinated. He was fatally shot while standing on the balcony of a motel in Memphis, where King had traveled to support a sanitation workers' strike. In the wake of his death, a wave of riots swept major cities across the country, while President Johnson declared a national day of mourning.

James Earl Ray, an escaped convict and known racist, pleaded guilty to the murder and was sentenced to 99 years in prison. He later recanted his confession and gained some unlikely advocates, including members of the King family, before his death in 1998.

MLK Day

After years of campaigning by activists, members of Congress and Coretta Scott King, among others, in 1983 President Ronald Reagan signed a bill creating a U.S. federal holiday in honor of King. Observed on the third Monday of January, Martin Luther King Day was first celebrated in 1986.

Martin Luther King Jr. Quotes

While his "I Have a Dream" speech is the most wellknown piece of his writing, Martin Luther King Jr. was the author of multiple books, include "Stride Toward Freedom: The Montgomery Story," "Why We Can't Wait," "Strength to Love," "Where Do We Go From Here: Chaos or Community?" and the posthumously published "Trumpet of Conscience" with a foreword by Coretta Scott King. Here are some of the most famous Martin Luther King Jr. quotes: "Injustice anywhere is a threat to justice everywhere." "Darkness cannot drive out darkness; only light can do that. Hate cannot drive out hate; only love can do that."

"The ultimate measure of a man is not where he stands in moments of comfort and convenience, but where he stands at times of challenge and controversy."

"Freedom is never voluntarily given by the oppressor; it must be demanded by the oppressed."

"The time is always right to do what is right." "True peace is not merely the absence of tension; it is the presence of justice."

"Our lives begin to end the day we become silent about things that matter."

"Free at last, Free at last, Thank God almighty we are free at last."

"Faith is taking the first step even when you don't see the whole staircase."

"In the end, we will remember not the words of our enemies, but the silence of our friends."

"I believe that unarmed truth and unconditional love will have the final word in reality. This is why right, temporarily defeated, is stronger than evil triumphant."

"Nothing in the world is more dangerous than sincere ignorance and conscientious stupidity."

I hope everyone is doing well and recovering from the holidays. This is the time to recoup, stay healthy and get ready for the upcoming boating season.





The Basics of Boating Etiquette



B oating etiquette has been developed over hundreds of years. Some rules are actual rules, set in stone, that need to be followed. Ignoring these can have legal or financial repercussions. But a few rules are unwritten. These are courtesies that boaters extend to one another. Boat sets of rules work together to make boating a better experience for

everyone on the water. These apply to fishing boats, canoes, and yachts alike.

There are more to the Rules of the Road than just "leave plenty of room" between you and the other vessel. You need to respect the distance between you and that boat. You need to watch your wake, depth conditions, and limited space. Be mindful of your speed and the speed of the other boat. Consider the effect on smaller boats and their passengers.

When it comes to passing other watercraft, direction is important. Do you pass to the port side or the starboard side? There is a right way and a wrong way. Some boaters think if there is no risk of collision then they are free to go underway however they wish. Not so.

Your boat and your wake are your responsibility. Even if your boat doesn't cause damage, you can be held legally responsible if your wake does. The waves created by your wake could potentially knock a person overboard.

• You should always give as much room as possible when overtaking a vessel. The depth conditions will determine just how much room you can give.

- The stand on vessel is the one that has the right of way. The give way vessel should accommodate the stand on vessel.
- You should slow your speed to reduce your wake. A slower boat will get rocked by a faster boat's wake. This can be very disruptive.
- If a boat is stationary, be considerate. Give it a wide berth. Reduce speed so you don't swamp it. Stationary boats are usually being used for fishing, swimming, etc.
- If you are being overtaken, it's also a good idea to reduce speed. Slowing your own speed ensures the boat that intends to pass will not produce an even bigger wake. If you are proceeding at 8 knots, try slowing to 4. That way, the passing boat only needs to pass at 6 rather than 10.
- If you are being overtaken, remain on course. Retain speed or, if needed, slow down. You have as much responsibility to avoid a collision as the other boat.
- If you are going by a boat head on, both vessels should turn to starboard and pass port to port. If this is not possible, then you need to signal the other boaters, or vice versa.
- A sailboat under sail will always have the right of way over a powerboat.
- Human powered boats, like kayaks, have the right of way over any vessel. This includes sailboats.
- If another boat has restricted maneuverability, it is the stand on vessel. That means you need to accommodate it. This could be due to the size of the other vessel, or what it's doing. No matter what, you must always try to avoid accidents. That rule takes precedence over all others.

PICYA Change of Watch - UPDATE!



It is with great excitement and optimism I look forward to serving as your Parliamentarian and working with all of you to make the best of the year 2022.



Hello EBC,

Have you ever considered Boating In the Winter? The following are a few tips to start the 2022 boating experience.

Consider Survival Wear

1. Wearing appropriate clothing and footwear is vital for winter boating. However, a float coat or survival suit is a good investment if venturing out often.

2. Have Two Pairs of Warm Gloves

When you are fishing, one pair will likely get wet So save the second pair for the ride home.

3. Use Hand and Toe Warmers

Put hand warmers in your gloves or at least in your jacket pockets. Use toe warmers in your boots, or maybe electric socks or boot-warming insoles.

4. Cover Your Face and Eyes

Use ski goggles to cover your eyes when the boat is running fast, especially if you're the operator. A warm balaclava should cover all exposed facial flesh. Remember that the wind chill is considerably colder the faster the boat is moving.

5. Face the Stern; Go Low

If you're a passenger, put your back to the bow and face the stern when the boat is running. Get low if possible; some passengers sit on a bean bag on the floor. The shock of sudden entry into cold water dictates cold weather boating prudence. If something goes drastically wrong, you have a better chance of survival in chilly water if your PFD is already on, secure, and properly fitted.

7. Make Sure Your Boat/Motor Is in Top Shape

This is not the time for a crippling breakdown that strands you, especially when there are fewer people on the water to come to your assistance. Don't go out unless you have 100% confidence in your vessel.

8. And Get It Registered

This is also not the time to discover that you forgot to register your boat, which sometimes happens in winter and at the start of a new season. https:// www.dmv.ca.gov/portal/vehicle-registration/vehicleregistration-renewal/ to register.

9. Have Company

Take a capable companion (or paddle with another person if you're kayaking) along who can lend a hand if you get into trouble. Whether solo or with someone, let someone else know where you're headed and when you expect to be back, and when to raise an alarm if you haven't contacted them.

10. Don't Take Chances

Through your actions, you could you possibly run aground, or hit an underwater obstruction and disable your motor, or get stuck behind an ice floe (this happened to me once)? In each case, you could be in for a long and cold time until you can get out of the predicament. Be realistic about your abilities and the circumstances, especially considering the coldness of the weather and the water. Consider how you'd have to deal with an incident that you might otherwise avoid by making a good decision rather than a risky one.

Why You Should Save Your Potato Peels They're nutritious and delicious! - By Margaret Eby

Of all the compostable trimmings that show up on a regular basis, potato peels might seem like the least likely ones you'd want to save. Maybe you don't really peel your potatoes to begin with. Maybe after making <u>super crispy smashed potatoes</u> for a crowd, you just don't have it in you to save the scraps. That's all legitimate, but if you have them around, you should hang on to your potato peelings. Why? Because they are delicious.

You've heard of <u>potato skins</u> as an appetizer, or maybe you've watched the Netflix movie The Guernsey Literary and Potato Peel Society. Either way, you're probably aware that potato skins are perfectly edible—you just want to scrub them pretty well to get rid of the grime and dirt they accumulate. But maybe you never really connected those leftover potato peels with the delights of a twice-baked potato skin, loaded up with sour cream or salsa or cheese. Friends: It's time.

When you peel a potato, you're essentially doing all the work to make very delicious crispy bits of potato peel. All you do is toss those peels in oil and salt, <u>roast them</u> in a 400-degree oven until they're nice and crispy, and you have a perfect bonus snack or appetizer for the people in your life waiting for the other part of the potato to be done. They taste like super crispy French fries, and they definitely would not go awry with the addition of chives or other potato-friendly condiments.

Not only does this prevent waste in your kitchen, it also has a lot of <u>nutritional benefits</u>. After all, the skin has just as many nutrients as the flesh of the potato—roughly the same amount of protein, vitamin C, and iron. That means when you peel a potato and just compost or throw out the peelings, you're dumping half of the potato's nutrients. That's a bad deal for you and for the potato! So save your peels and give you and your potatoes a better chance at fulfilling their destiny.

EBC's HEALTH TIPS

These Household Items Can Become Dangerous Once They Go Bad

Home is where the heart is. Where you live is a place where you unwind, rejuvenate, and relax. It's common to routinely clean your home and keep things tidy, as well as dig into the occasional deep clean. But one house chore that's probably not on your to-do list is checking the expiration dates on your household products. Skipping this step might mean that you're taking unnecessary risks you're not even aware of. Take a look at the household products that need to be tossed out once they've reached their lifespan. This can get tricky, as some don't even have a labeled expiration date.



Old Spices Can Cause Digestive Problems

Spices can be expensive, so many of us will want to hold onto them so long as there is still some left. Maybe you bought a new spice for a specific recipe and haven't touched it in a year. Is it still good? Jocelyn Nadua, RPN, care coordinator at C-Care Health Services said, "They can last for multiple years, typically in the three-to-four-year range, but after that, they lose their potency and can cause some digestive problems." They won't put you in the grave, but you will end up on the toilet.



Eye Drops Expire 28 Days After You Break The Seal Sometimes, eye drops can save you from the most irritating dry eye scenario. It's convenient to have

some around the house but be wary of keeping it around longer than their expiration date recommends. "Eye drops are generally formulated with a preservative that keeps the product sterile for 28 days after breaking the seal," says Erin Nance, MD. The best practice would be to toss the bottle four weeks after you've opened it up. There's a chance that it can cause a bacterial infection!



They Might Be In A Can, But Look Out

Canned goods have a longer shelf life than produce, but these have an expiration date, too. Typically, the lifespan of canned food is between one to four years when stored properly, in a dark, cool space. Many people feel canned items can last 'forever.' Not so!" says Lisa Lewis, MD, a pediatrician in Fort Worth, Texas. "Never use canned foods after the expiration date." Lewis further warned that if you digest spoiled canned food, you may get food poisoning symptoms.



Boxed Wine Doesn't Last As Long As Bottled

If you prefer your wine out of boxes, then this is for you. Wine does improve with age, but you can't say the same about the packaged or boxed version. If it's in a box, then it has an expiration date, usually six to eight months after purchase. While most boxes don't pose a threat because of the polyethylene, others contain Bisphenol (BPA). That's a chemical which could lead to fertility problems and heart disease.

COVID-19 Vaccination

If you haven't been vaccinated or received your booster against COVID-19, now's the time to do so. Vaccines are critically important to preventing infection and decreasing the severity of illness from the highly contagious Omicron variant. While there are reports of Omicron infection being milder than other variants, it can still cause severe illness in people who are unvaccinated, un-boosted, or immunocompromised.

COVID-19 Testing

There are many options for COVID-19 testing to keep you safe, including testing at Kaiser Permanente, licensed community and retail facilities, and with home antigen tests.

Home test results:

- If you have a negative home antigen test result but you've been exposed to COVID-19 or have symptoms, please complete the <u>Coronavirus/COVID-19 Concerns E-visit</u> or check community testing sites to schedule a PCR test appointment 5 days following exposure to confirm you are not infected.
- If you have a positive home antigen test, regardless of symptoms, you're considered positive for COVID-19 and don't need a confirmatory PCR test. If you have a positive home antigen test you can let us know

through the <u>Positive COVID-19 Home Test</u> <u>E-visit</u> and receive information about COVID-19.

We know that testing appointments and at-home test supplies are difficult to find right now. We are working hard to make more testing appointments available where we can. For your health and the health of others, our physicians recommend staying at home in isolation and only coming to the medical center when you have an appointment. Please note that our Emergency Departments can only provide COVID-19 tests for non-routine emergent care purposes. For your safety and for the safety of those who need emergent care, please only use our emergency departments for non-routine medical emergencies.

COVID-19 Isolation Guidelines

If you have been exposed to someone with COVID-19 or have symptoms of possible COVID-19 (regardless of vaccine status or prior infection) and are either waiting for a test result or are unable to test, stay home and isolate from others. Stay in isolation until you get test results and instructions or 10 days have passed since symptoms started and they are now resolving. If your symptoms worsen, please contact us for care.

EBC COVID PROTOCOLS

Janet Noyd and Ann Dukes continue to receive updates from Alameda, Stanislaus and San Joaquin County Public Health offices regarding regulations mandates. Using the combined guidelines we updated this SOP. Temperatures are to be taken before entering the building. Persons with Temperatures of 100 F and above will not be allowed into public or private buildings per the two county regulations. (Except medical faculties).

- A. A designated EBC member will temperature scan each person before they enter the building.
- B. The thermometer should not touch the body.
- C. The thermometer will be cleaned and stored by the designated EBC member at the end of the each meeting.
- D. The temperature DOES NOT have to be recorded.
- E. Each person entering the building MUST sign in with NAME, AFFILIATION AND PHONE NUMBER.
- F. The dates and time of entry MUST be accurate.
- G. The phone number is just in case there is an incident and the county needs it for tracking. Ebony Boat Club will not be responsible for any data collection or tracing.
- 2. Please wash/sanitize your hands upon entering the building. There is a sanitizing station at each door. There is a mounted station at the front door and there will be a portable setup and there is also a portable station available... Please don a mask/face shield upon entry. Your temperature will be taken. If under 100 degrees you will be allowed inside. If 100 F or above there will be a second check. If it is still 100 F or above the second check you will be refused entry into the building. Please re-sanitize each time you leave and reenter the building.
- 3. Please don't forget to also wash your hands with soap and water after sanitizing five (5) times or as needed.
- 4. WASH YOUR HANDS WITH SOAP AND WATER WHEN ENTERING THE KITCHEN.
- 5. Mask/face shield, gloves, and hair covering must be worn when preparing or handling food.
- 6. Per the Department of ABC all bartenders are too have on mask/face shield and gloves when behind the bar.
- 7. Mask should be worn when not eating or drinking.
- 8. PROOF OF VACCINATION(S) INCLUDING THE BOOSTER MUST BE PROVIDED BEFORE ENTRY UNTIL FURTHER NOTICE.
- 9. TABLE SEATING WILL FOLLOW THE 6FT DISTANCE/SPACING PROTOCOL.
- 10. Please assist us in ensuring that everyone is following the mask and hand hygiene protocol.





As we look forward to 2022, we can mark significant dates on our calendars: birthdays, anniversaries and, of course, the deadlines the Internal Revenue Service (IRS) sets for filing and paying federal income taxes.

Bear in mind that we are filing taxes for income earned in 2021, even though we file those forms in 2022. To keep confusion to a minimum, tax experts refer to 2021 as the tax year and 2022 as the filing year. Most, but not all, of the deadlines in 2022 refer to tax year 2021.

When is Tax Day? It's complicated

The deadline for filing 2021 federal income tax returns for most taxpayers is April 18. Taxpayers haven't had to file on the traditional date, April 15, since the 2019 filing season.

In 2020 and 2021, the April 15 deadline got pushed back by the COVID-19 pandemic. And in some non-pandemic years, the deadline sometimes gets pushed back to the next business day because April 15 falls on a weekend.

The filing deadline this year is Monday, April 18, because Washington, D.C., observes Emancipation Day on Friday, April 15. By law, the IRS is required to treat D.C. holidays as if they were national holidays for tax-filing purposes. Emancipation Day commemorates the day in 1862 when President Abraham Lincoln signed into law a measure to free enslaved people in D.C. (Adding to the complexity, the actual date of Emancipation Day is April 16, but since it falls on a Saturday this year the holiday is celebrated a day early.)

19, because those states celebrate Patriots' Day on April 18. The holiday marks the first battles of the American Revolution in 1775.

Some taxpayers affected by recent natural disasters get extra time to file. Victims of the January Colorado wildfires will have until May 16 to file their federal tax returns. The same goes for victims of the December tornados and flooding in Kentucky.

Filing late?

Don't blow the deadline. The penalty for late filing is 5 percent of the amount due each month, and the penalty for failure to pay is 0.5 percent a month, and maxes out at 25 percent a year. (When both penalties are levied in the same month, the total penalty is 5 percent a month: 4.5 percent for failure to file and 0.5 percent for failure to pay.) Interest also accrues, at a current rate of 3 percent.

If you must file late, you can get an automatic extension by filing IRS Form 4868. The automatic extension typically gives you until Oct. 15 to file your return, but since Oct. 15 falls on a Saturday this year, the extended deadline is actually Oct. 17. However, an extension to file doesn't grant an extension to pay. You must still pay any taxes owed by April 18 or face penalties for late payment. If you're owed a refund and file late, the IRS won't levy a penalty, but you won't get your refund until you file. If you don't claim a refund within three years, you'll lose the money.

When does tax season start?

The IRS takes a few weeks to get ready to process the millions of returns it receives during tax season. Last year, taxpayers sent more than 168 million individual returns to the IRS. However, IRS and Treasury officials say some returns have yet to be processed due to delays stemming from the pandemic.

The IRS will begin accepting and processing new returns on Jan. 24. The IRS says most taxpayers will get their refunds within 21 days of when they file electronically, barring any issues with processing

their tax returns. Electronic filing, when linked with direct deposit, is the fastest way to get a refund. Last year's average tax refund was more than \$2,800.

Paying estimated taxes

The self-employed must pay estimated taxes every quarter. The last payment for the 2021 tax year is due on Jan. 18. The first payment for the 2022 tax year is due April 18, with other payments due June 15, Sept. 15 and Jan. 17, 2023.
