## **Memorial Day**

Sun, May 30, was Memorial Day. It is the day in which

we honor our fallen soldiers, both men and women who died fighting in wars that the United States was involved in including the Civil War. Memorial Day means much more to me than the unofficial opening day of summer. It is a day to honor our fallen soldiers.

Over the years on Memorial Day, I have visited the gravesites of my father, Money McCoy Jr (USMC WWII); my uncle, Clinton Walker (USN WWII); my grandfather, Calvin Walker (USArmy WWI); and a close friend of my son, Benjamin Tollefson (USArmy). Ben was killed in Balad, Iraq December 31, 2008, while serving during Operation Iraqi Freedom.

I was fortunate to coach Ben when he was a varsity offensive lineman at Berean Christian High School. The four men are all buried at the Golden Gate National Cemetery, San Bruno, California. May God Bless the families of all soldiers who fought and died for our country.

## **Black Wall Street**

The oil boom of the early 1900s attracted many people to Tulsa Oklahoma including African Americans. Of course, there was a strong racial divide in the 1920s.

African Americans inhabited the Greenwood district of Tulsa due to segregation.

The demographic of Greenwood was comprised of primarily black middle-class people who worked in the oil fields and black owned businesses. There were successful black businessmen and women such as Mr. Ottawa "O.W." Gurley that lived in Greenwood. They owned businesses such as beauty shops, barber shops, grocery, clothing, hardware stores and dry cleaners that everyone in Greenwood frequented. There were also theaters, dance halls and hotels owned by black people. The community of Greenwood thrived and became a very successful self-reliant community due to the efforts of people like Mr. O.W. Gurley. Greenwood was recognized nationally as Black Wall Street.

## The Tulsa Race Massacre

On May 31, 1921, a black teenager by the name of Dick Rowland was riding in the elevator of the Drexel building with elevator operator Sarah Page, a young white woman. Page screamed and Rowland ran from the elevator. Several rumors spread throughout Tulsa of what may have happened in the elevator. The Tulsa Tribune reported Tulsa Police arrested Rowland for sexually assaulting Page on the elevator. It is unknown to this day if in fact an assault had occurred.

Shortly thereafter white mobs looted and burned the Greenwood District to the ground. 300 black people were killed and 800 were injured by gunfire and aerial firebombs. Many of the white rioters were deputized and outfitted with weapons by the Sheriff. Many of the buildings were burned down by dropping Molotov cocktails from airplanes. None of the murderers were arrested. The National Guard was called out to help put out the fires and arrest all black people. The National Guard took several black citizens from the vigilantes and interned them. By June 1, 1921, 35 city blocks of Greenwood were burned to the ground which was the demise of Black Wall Street.



## A Message From : SAFETY & TRAINNING OFFICER

Greetings EBC Family,

This is a tip to check out an item that we often take for granted, our backing plates that hold onto our cleats, anchor windless', and any other through deck devices that take extreme loads. it is important to make sure that the backing plates are strong enough to withstand the forces of towing and harsh weather when we are tied up at the dock or a mooring ball. The effort you make now will surely payoff in the future, I've checked the backing plates on my cleats only to find that there wasn't adequate backing plates to support the loads that can be imposed on them, so I've got my work cut out for me, hopefully yours will be fine, but it doesn't hurt to check.

## THE CRITICAL WORLD OF BACKING PLATES

After major storms, you hear a lot about broken lines on boats. But a related issue that members of the GEICO | BoatUS Marine Insurance Catastrophe (CAT) Team also routinely find are cleats torn from decks. When you see TV storm coverage showing boats being pummeled in marinas, remember that a lunging 10,000- pound boat puts a tremendous load on any cleat used to tie it off.

So why do so many cleats fail? Inadequate installation, to put it bluntly. In the worst-case scenario, the cleat is simply screwed in place with large self-tapping screws. In other cases, the cleat is thru-bolted but has only a nut and washer on the underside. Bolts are stronger than screws, but multiple fasteners don't always support each

other. Pulling sideways on a cleat, for example, will load the far side fasteners, pulling them through the deck before loading the near side fasteners. I'd like to say that all hardware on all boats is installed properly, but I would be wrong. And a bigger problem is that you can't necessarily tell how a cleat is installed; from the outside, they all look OK. What you need to look for is a backing plate installed under the cleat.

Getting together with Dad calls for a celebratory drink, but of course, not every father likes the same sort of Father's Day cocktail. Is he a Scotch drinker? More of a G&T guy? Into mezcal or open to whatever new amaro you're loving lately? If you're drinking together while grilling up lunch, something light and refreshing is the way to go; if you're dropping off treats at his doorstep, something batched and long-lasting is a good bet. Below you'll find 2 of (epicurious.com) best cocktail recipes for your Father's Day menu



### FROZEN BOOZY ARNOLD PALMER

Transform the classic iced tea-lemonade combo into a refreshing frozen cocktail to sip on the back porch while the grill does its thing.

### **INGREDIENTS**

- 8 black tea bags, preferably English breakfast
- 5 tablespoons sugar
- 3 1/2 cups homemade lemonade, divide
- 1 cup vodka, divided
- Lemon wheels (for garnish)
- 1 5 lb bag of ice

**PREPARATION** - Bring 3 1/2 cups water to a boil in a medium saucepan. Remove from heat and add tea bags and sugar.

(you should have about 3 1/2 cups tea).

- Divide 3 cups tea between 2 ice cube trays; chill remaining 1/2 cup tea. Divide 3 cups lemonade between remaining 2 ice cube trays; chill remaining 1/2 cup lemonade. Freeze until solid, 3–4 hours.
- Blend lemonade ice cubes, 1/2 cup vodka, and 1/2 cup lemonade in a blender until smooth. Transfer to a spouted liquid measuring cup or pitcher. Rinse blender jar and add tea ice cubes and remaining 1/2 cup tea and 1/2 cup vodka; blend until smooth.
- Tilt a large glass to one side and fill halfway with lemonade mixture. While slowly returning glass to upright position, pour in frozen tea mixture to fill glass and create a swirl. Garnish with lemon wheels.



### **BLACKBERY-CUCUMBER MULE**

Just when this crowd-pleasing berry drink heats things up-hi there, ginger beer-it starts to cool things down, thanks to muddled cucumber and mint.

### **INGREDIENTS**

- 3 ripe blackberries
- · 2 cucumber slices, 1/4 inch thick
- · 10 fresh mint leaves
- · 2 ounces vodka
- 3/4 ounce fresh lemon juice
- 1/2 ounce 1:1 simple syrup (see note)
- 2 1/2 ounces ginger beer
- · GARNISH: mint sprig and cucumber wheel

### PREPARATION

• Muddle blackberries, cucumber, and mint in the smaller half of a cocktail shaker. Add vodka, lemon juice, and simple syrup and fill with ice. Shake until well chilled, about 12 seconds. Double-strain into an ice-filled collins glass, pour the ginger beer down the side of the glass, and give it a brief, gentle stir. Garnish with mint sprig and cucumber wheel, plus a straw if you have one.

### SIMPLE SYRUP: IT'S SIMPLE

Many folks are intimidated by the idea of simple syrup. It's time to get over our fears: no one wants a grainy mouthful of sugar in their drink. Plus, making simple syrup is actually crazy easy, especially if you happen to have a resealable jar (such as a mason jar) around. For 1:1 simple syrup, add equal parts sugar and hot water, seal, and shake until dissolved. Let cool before using and store for up to several weeks in the fridge.

Sport Fish Restoration, Recreational Boating Safety, and Wildlife Restoration Act Adapts to the Future

## Just-introduced bill earns bipartisan support

WASHINGTON, June 10, 2021 – A bill introduced today that provides critical funding for conservation, fisheries research, habitat restoration, and recreational boating access and safety also offers new provisions to help meet the future needs of anglers and boaters. The Sport Fish Restoration, Recreational Boating Safety, and Wildlife Restoration Act (H.R. 3702) aims to reauthorize the Sport Fish Restoration and Boating Safety Trust Fund, one of the most successful "user pay – public benefits" federal funding programs that relies on excise taxes paid on fishing and boating equipment as well as motorboat fuel taxes to support angling and boating programs.

Of several new provisions to the bill, the first is an effort to address the <u>derelict</u> <u>vessel</u> challenge which also includes the promotion of <u>boat recycling programs</u>. The

second is to examine the growing use of nonmotorized vessels on all types of waterway access and the resultant user conflicts and potential for increased boating accidents and fatalities.

The bill also gives the U.S. Fish and Wildlife Service more flexibility to effectively administer the Sport Fish Restoration fund programs, such as the <u>Boating Infrastructure Grant</u> (BIG) program that grows the availability of safe and protected harborage for transient boaters.

The nation's advocacy, services and safety group for recreational boat owners, Boat Owners Association of The United States (BoatUS), thanks bill sponsor Rep. Debbie Dingel (D-MI) and Rep. Garret Graves (R-LA) for introducing the legislation, and Sen. Maria Cantwell (D-WA) and Sen. Roger Wicker (R-MS) for the companion bill S.1995. The legislation is anticipated to be incorporated into a larger transportation bill.

"H.R. 3702 builds on many years of success," said BoatUS Manager of Government Affairs David Kennedy. "It continues to support infrastructure grants, the Clean Vessel Act, and U.S. Coast Guard and local boating safety programs. However, it also addresses some new challenges we face as more folks head to the water, such as what to do with end-of-lifecycle recreational vessels and how to equitably fund waterway access points. We look forward to its passage."

Since its enactment in 1950, the Trust Fund has provided more than \$38 billion in funding for state-based conservation programs, recreational boating access and safety, aquatic resources education, and fisheries management and restoration.

They Are at It Again: Confusing and Ineffective Fuel Pump Warning Labels
Do Not Help Boaters Choose Safe Fuel BoatUS says efforts to grow sales of higher blend 15% ethanol fuels such as "Regular 88" and reduce or eliminate warning labels are anti-consumer

SPRINGFIELD, Va., June 1, 2021 – Efforts by the ethanol industry to create a new federal rule that would weaken or eliminate important warning labels designed to prevent boaters and consumers from misfueling with prohibited higher-ethanol fuels at roadside gas pumps has Boat Owners Association of The United States (BoatUS) concerned. The national recreational

boating advocacy, services and safety group recently co-signed a letter to EPA Administrator Elizabeth Dermott addressing the proposed "E15 Fuel Dispenser Labeling and Compatibility With Underground Storage Tanks" legislation (EPA-HW-OAR-202-0448) and urging the federal regulator to side with consumers on its Misfueling Mitigation Program (MMP) to ensure transparency in the sale of fuel to consumers.


"Ethanol manufacturers are pushing to blend more ethanol into the nation's fuel supply. To accomplish that, consumers are not being fully informed at the roadside pump about the type of fuel going into their boats' gas tanks," said BoatUS Manager of Government Affairs David Kennedy. "New marketing schemes to brand these prohibited 15% ethanol fuels as 'regular 88,' promoting them as a low-cost alternative and, at the same time, attempting to drive federal rulemaking efforts to reduce and weaken warning labels at the pump is an anticonsumer one-two-three punch that should not be tolerated."

The proposed rulemaking provides no new data on a theoretical basis to support the proposals to either decrease the stringency of the existing E15 warning label or eliminate it altogether. A 2020 Outdoor Power Equipment Institute (OPEI) poll shows that only about one in five consumers know that "regular 88" — or 88 octane fuel — has more ethanol (15%) in it than 87 octane (10% ethanol) fuel. Use of ethanol fuel blends with more than 10% ethanol, such as "regular 88," in recreational

\*Lemon pepper \*Cajun Seasoning \*Garlic powder

\*Paprika \*Cayenne Pepper \*Oregano \*Brown Sugar

\*Chili Powder \*Crushed Peppers \*Black Pepper

\*Onion Powder \*Old Bay Seasoning \*Parsley Flakes

\*Ground Mustard

4 Sticks of Unsalted Butter

1 Onion Sliced (yellow, white or purple your choice)

1T Honey

1T Balsamic Vinegar

1T Worchestershire Sauce

3 to 4 Slices of Fresh Ginger

1 Lemon (Juice Only)

1T Hot Sauce (or to your taste)

3T Fresh Garlic (Minced)

12 Oz Bottle of Cocktail Sauce

1 Cup Chicken Stock (add more if sauce is too thick)

Melt 4 sticks of butter over low/medium heat (do not burn the butter). Add sliced onions, minced garlic simmer until translucent. Continue to stir do not allow ingredients to stick to the bottom of the pan. Add ginger and lemon juice, balsamic vinegar, hot sauce, Worchestershire sauce, cocktail sauce and chicken stock bring ingredients to a slight boil, continue to stir. Gradually stir in bowl of dry ingredients and simmer on medium heat for 5 minutes stir occasionally. Taste the sauce, more hot sauce or honey can be added or paprika for coloring if needed. Let Muckbang settle for a few minutes stir again before serving.

This sauce is delicious over just about everything. Left over sauce can be frozen for later use or try marinating chicken breast in it, then bake the chicken with the sauce spread over the top (finger licking good!). Each time you make this sauce you'll begin to add your own touch to it. I have also seen this sauce made with red and green bell peppers sautéed in with the onions and garlic, but I have not tried it yet. Enjoy and welcome to making Muckbang!

boat engines, motorcycles, off-road vehicles and power equipment is prohibited by federal law. E15 fuels have been proven to damage engines and fuel systems, and its use in a marine engine voids the warranty.

Consumers have indicated the need for a better, more effective higher-blend ethanol fuel warning label design as well as more prominent placement of the warning label on the pump. A recent national poll shows that just 18.25% of consumers think the current E15 label used at gas pumps across the country is very effective for warning that E15 is hazardous to certain types of engines.

EPA has also worked to broaden the availability of E15 fuel in the U.S., including most recently with the 2019 repeal of summertime restrictions on its sale. These restrictions were originally implemented years ago to address concerns over the higher ethanol fuel's contribution to ground level ozone (smog) on hot days.

"Visit a local gas station dispensing higher ethanol fuels and look for the warning label on the pump," added Kennedy. "It's often hidden or buried along with a mountain of promotional signage. EPA should help consumers make the right fuel choice, and efforts to weaken the Misfueling Mitigation Program, such as stripping away label elements that indicate a warning message or exclude mention of 15% ethanol altogether, only accommodate the interests of ethanol producers and harm boaters."

Let's see when Mama had to go to the fields and need to have food cooked for dinner this is what she did. She did not have a crock pot, but she had a wood stove and a big heavy, iron Dutch oven. She put a big green log in the stove, the green log burned slower, and the heat was lower than a dry log and put the pot on, then went searching the pantry and the freezer. She always washed and prepared the food before putting them in the freezer, so it was out of the freezer into the pot. Poultry leftover from Easter, ok. Frozen veggies from the garden last fall, got to use them up so they can be replaced this year. Rice, potatoes which ever you have. ## Meet the Ebony Anglers, Five Black Women Catching Fish and Stares

The team, formed in the past few months, is trying to make a mark in the mostly white, mostly male world of competitive fishing.

ATLANTIC BEACH, N.C. — The shooting stars that illuminated the dark sky on the journey to deeper waters had given way to a crisp morning when Gia Peebles felt her fishing rod tense.

She gritted her teeth. Her adrenaline surged. She braced herself, gripped her rod tighter and started reeling, all while fighting the waves and current. After a few minutes of coaxing, she spotted rainbow scales glistening on a king mackerel as it neared the water's surface.

Captain David Stone hooked the hefty fish, plucking it from the ocean and plopping it onto the Cay Sea May's deck. Cheers erupted. Peebles exhaled. "Look at him, he's a fatty," Tiana Davis said. "He is a fatty," Bobbiette Palmer said. "That's your name: Fatty." Fatty mounted a final stand, furiously flopping. "Tell 'em what you're talking about," Lesleigh Mausi said. "Tell 'em why you're mad." Soon, the 26-foot boat raced back to shore with the group's haul to be weighed in at Chasin' Tails Outdoors Bait & Tackle. The Atlantic Beach King Mackerel Fishing Tournament had stretched for three weeks. But this, the final day of the tournament,

marked the first time that the <u>Ebony Anglers</u> could sync their schedules and sink their lines together. As the women walked from the dock to weigh in, a few bystanders cast curious glances their way. It was probably the first time any of them had come across a team of all Black women in the mostly white, mostly male world of competitive fishing. It's one reason Peebles, 49, formed the team. She did not fish until she met her husband, William Peebles, a couple of decades ago. But in college, she competed in the World Series four times after becoming the first Black woman to earn a softball scholarship at Cal State Long Beach. So the mix of relaxation and spurts of intense focus in competitive fishing appealed to her.

## EBONY ANGLERS CATCHING FISH

In June, Peebles noticed a swarm of activity near a pier where she and her husband own an Emerald Isle condo. She watched as teams disembarked after competing in the Big Rock Blue Marlin Tournament. Some women exited the boats, but all of them, Pebbles noticed, appeared to be white. Many Black people, Peebles said, are not exposed to the nautical lifestyle, and the high cost of entry to competitive fishing is a significant deterrent.

She first called Mausi, 47, a longtime friend, about collaborating. The two had fished casually a few times, and Mausi's father was a professional angler.

Just the thought gave Mausi goose bumps. She brought along Davis, 44, who also had fishing experience. They next asked Glenda Turner, 56, a nail technician at Peebles's beauty salon, to join.

Palmer, 37, a model Peebles knew from styling her hair, rounded out the team. She initially laughed when Peebles asked her about fishing, thinking Peebles was joking. But Palmer agreed, deciding that she wanted to get out of isolation during the pandemic and try something new.

"We instantly developed a bond," Palmer said. "We're all organized in our own ways, and we fill each other's gaps. Our strengths and weaknesses, they complement each other."

Palmer's previous boating experiences consisted of a couple of cruises that left her sick. Turner offered her a motion sickness patch, and Palmer pushed through early stomach-churning outings with the team.

By July, the team had entered its first tournament, the Carteret Community College Foundation's Spanish Mackerel & Dolphin Tournament in Morehead City. That weekend, the Ebony Anglers caught a 48-pound king mackerel to claim first place in the division.(The fish, however, was listed at just 43.06 pounds on a hand-printed board naming the top finishers.)

"It just catches some off-guard that here we are," Peebles said. "We're not only female, but we're Black. We're competing and we're doing it well. We're actually winning.

"Fatty was their largest catch at the Atlantic Beach King Mackerel Fishing Tournament, weighing 29 pounds. The winning team, Pirate's Pleasure, topped the <u>leaderboard</u> with a catch of 41.61 pounds. The Ebony Anglers did not place, though the team took solace in knowing it had competed much less than many of the 150 other boats.

After weigh-in, Peebles and her husband took some of the fish to a market for filleting. They caught a nap before the team reconvened for the tournament's awards banquet. For the first time, the Ebony Anglers met some of the other competing teams.

Kelly Albritton, a former bail bondsman in Kinston, N.C., claimed third place in the tournament with a 39.51-pound king mackerel. He said he recognized the Ebony Anglers from the weigh-in and introduced himself while clutching his trophy.

He said he couldn't believe his eyes when he saw the group of Black women.

"I saw y'all go by and I said, 'Go to hell!' I said: 'There are those girls. I have to come over there and say hi.' I wanna know the story." The women described their backgrounds, how the team had formed, how they had fared during the tournament. "Twenty-nine?" Albritton, his mouth hanging open, asked with excitement when they told him the size of Fatty.

"This country belongs to all of us, and I'm just really glad you gals are here. I'm so excited that y'all are into fishing," he said. At one point in life, Mausi said, she would have taken offense to being referred to as "girl" or "gal." Here, she said, most people know one another. Outsiders will draw double takes, especially a fishing team of Black women.

"I think I have to meet people where they are," said Mausi, who is from Detroit. "I felt good that he came and addressed us and just wanted to know more. And I think that is what is going to be the turning point in our country, when people of different cultures aren't afraid to approach one another and just say, 'I want to learn more about you."

A man from California sent a voice mail message saying he wanted to take the team out to dinner and talk fish. Several women have sent messages, inquiring about becoming part of their team. "You can't just join the Carolina Panthers," Mausi said, referring to the N.F.L. team. "We're not a club. We really want people to understand this is a sport. We're athletes, and we're competitive." They hope to use the tournament as a tuneup to compete in next year's Big Rock Blue Marlin Tournament, where Peebles envisions her journey coming full circle.

"Hopefully, people are seeing us step into an arena that's normally considered to be dominated by white males and it can inspire others," she said. "Hopefully, we are making an impact on a lot of people, and people of color and, in particular, women of color to know they can step out of their box and do something that they never thought that they could do."

## California Reopening

What Does This Mean?
California is Open, With Some Restrictions
As of June 15, California retired its Blueprint for a
Safer Economy. 1 California's economy is now fully
open. Restaurants, shopping malls, movie theaters,
and most everyday places are operating as normal –
with no capacity limits or physical distancing
required. 2 However, everyone is still required to
follow masking guidelines in select settings. Some
restrictions also still exist for large events.

Masking is Still Required In Some Settings everyone, regardless of vaccination status, is still required to wear masks on public transportation (buses, trains, planes, etc.) and some other places (like hospitals and shelters) per CDC guidelines.

People who are not fully vaccinated must still wear masks in all indoor public settings (such as, but not limited to, the grocery store and the movie theater) and should wear masks in outdoor crowded settings when that region is experiencing high covid transmission.

Fully vaccinated people may go unmasked in most settings (except public transportation and places like hospitals and shelters). Workers must follow Cal/OSHA rules.

Read our full masking guidance. Large Events are Subject to Some Restrictions Some public health measures are still in place for large, or mega events, which include 5,000+ people indoors or 10,000+ outdoors. Think concerts, sporting events, festivals, and conventions. Mega events are high risk for spreading covid-19 because they attract people from around the world, and people gather in crowds. Indoor mega event attendees will be required to confirm proof of vaccination or negative covid-19 status to attend. Outdoor mega event attendees will be strongly encouraged to do so.

### What's Next

California will keep a close eye on covid-19 vaccination and infection rates over the summer and will review these guidelines by September 1, 2021.

- **2**Local health jurisdictions may impose stricter criteria. In workplaces, employers are subject to the Cal/OSHA COVID-19 Emergency Temporary Standards (ETS) or in some workplaces the CalOSHA Aerosol Transmissible Diseases Standard, and should consult those regulations for additional applicable requirements.
- **3**This includes K-12 schools, childcare and other youth settings, healthcare settings (including long term care facilities), state and local correctional facilities and detention centers, homeless shelters, emergency shelters, and cooling centers.
- **4**Someone is considered fully vaccinated two weeks or more after their second dose of Pfizer/Moderna or two weeks after receiving the single dose J&J vaccine.
