Item 1

DY 1117 hrs meeting called to order.

DY Need 20% of 61 Shareholders = 12.2 Shareholders to have a quorum.

DY Conducted roll call. 17 in attendance, with proxies and shareholders with more than one share we have 35.5 in attendance, a quorum.

Item 4, Matters of public discussion?

DY Any concerns from the Shareholders? Harvey Boganwright concerned about the dilapidated state of the CalTrans fence on his cabins property line. AD contact CalTrans directly, she gave Harvey points of contact.

Item 5, Late Agenda Items?

SH motion to move agenda item 10.3 to a new 9.2 position

AD With Michael McClellan's passing, we had to get a Water Manager for our water system. AD interviewed scores of companies and individuals. The Board selected Central Cal Waterworks. This company is more expensive than Michael McClellan, but provides more complete services with full service management. Central Cal Waterworks also does mandatory water quality testing, something Michael couldn't.

AD Covered EPA water requirement to tell what kind of tie-in between the MMMWCO1 system and each shareholder's home. It is not optional to have "no answer" to this question. PM and SH are collecting this data. Getting the information is the shareholder's responsibility.

PF Described how to identify the water main.

AD Re-iterated what kind of materials are possible with the shareholder's pipe from the concrete pit to the home.

Item 8.1

JB Detailed highlights of Statement of Income and Expenses and highlights of the Balance Sheet. BOD agreed to an increase to cover the our higher cost of contract with Central Cal

Waterworks. This will bring the annual cost of water per residential shareholder to \$850. As covered in the BOD meeting, Standby Residential is \$425/yr.

Commercial properties are twice the Residential rate, so $2 \times \$850 = \$1,700/\text{yr}$. Standby Commercial is \$850/yr.

CalTrans rate is triple the Residential Rate, so $3 \times \$850 = \$2,550/\text{yr}$. The CalTrans rate makes up for the fact that CalTrans doesn't pay assessments and they are not a stockholder.

Item 8.2

JB Noted no additional costs for the year 2023 for snow removal.

Item 9.1

PF Described the metal stakes he and SH put in to make it easier to identify your water main shutoff valve. PF and SH located all the water main concrete pits where the water meters are located, and drove in metal poles. These poles have blue reflective tape to identify your main in snow season.

PF Renters are pulling out the stakes in the winter to make sledding runs. If you are renting your cabin out please advise renters to not remove stakes.

SH More specifics on identifying your water main. Poles with two bands of blue reflective tape notes the location of two water mains. Stakes with orange reflective tape locate fire hydrants. Richard Conley asked how to identify a particular water main for a neighbor.
