10 Good day –

11 I noted that Mr. Williams recently announced an investigation of the NYPD unit involved
12 with sex crimes. I am passing along the following contacts derived from this type of operation
13 by NYPD and other police powers agencies in the region. I have also provided the Federal
14 Transit Administration Office of Civil Rights information with regard to the Operations and
15 police powers units of New Jersey Transit. I shared the NJT/FTA information with the NJ AG
16 Office of Constituent Services (reference OAG-CS-19989 enclosed).

17 Feel free to pass any or all this material along to the relevant SDNY personnel for their
18 use.

19 Most if not all these contacts were sourced from various online dating sites from varying
20 time periods since I began making these types of contacts in late 2018. Virtually all of them
21 seemed to have one thing in common – they were the result of screening out of all contacts
22 except those involving police powers operations, likely either undercover officers or possibly
23 some close contact of these personnel.

24 This is consistent with the extensive honey trap operations run by various police powers
25 agencies in the region, including, without limitation, NYPD in and around NYC streets, subways,
26 and various venues; and NJT PD on buses (Route 158 Edgewater, NJ to/from PABT) and trains
27 (Ramsey, Nj to/from NY Penn). These honey trap operations also ran in Washington and Oregon
28 in 2004/2005. There was also phone contact related to prostitution stings while I resided in
29 Ramsey, NJ between March 2011 and November 2018.

30 As you likely already know, I have absolutely no criminal history of any kind, anywhere,
31 so there is no basis in law for these or similar operations. I have never been questioned or held
32 for even one second by any uniformed police powers officer and my only known contact with
33 undercover officers has come through the very extensive targeting efforts of street-level
34 undercover contacts. I did have routine social contact with FBI agents in the 1980s (parties and
35 double dinner dates with spouses present) and 1990s (social events and our babysitting of an
36 agent's infant son).

I have also enclosed the two contacts with which I had more extensive relationships over time. This is a repeat of material previously supplied to you for the convenience of managing the information. The letter to the Federal Transit Administration Office of Civil Rights and other relevant information is also enclosed for your convenience.

Following is a list of contacts made using various online dating sites. Call history is no longer on my cell phone. Some of these contacts resulted in meetings in NYC, other contacts were texts and/or phone calls only. My cell phone service has been provided by Consumer Cellular for the past four to five years. Their online system provides billing records dating to January 2021 per my lookup as I write this. I was previously on a universal service free cell phone plan while I lived in Ramsey, NJ. Since it is likely that my phone is part of a surveillance package existing in some police powers agency, it is probable that historical records are also available.

Please Note: The extent of federal police powers involvement in these operations is unknown but I note that a very few of the contacts occurred in Nj (other than the one recent prolonged relationship with "Gia [REDACTED] All of the in-person meetings involved one participant or the other crossing state lines.

Re: Civil Rights Complaint against New Jersey Transit Operations and Police Powers

Good day -

The New Jersey Transit (NJT) agency has engaged in a pattern of discriminatory and retaliatory actions against me from my arrival in the northern New Jersey area in August 2007. These activities were halted for a time earlier in 2022. These issues began reoccurring in NJT Route 158 bus operations/police powers activities and on the NJT mobile app recently. They include, for example, buses departing at the moment I arrive at the Port Authority Bus Terminal (PABT) gate in New York City (PABT gate 202 or 301) and/or significantly before the listed scheduled time in the NJT mobile app at the stop 352 feet south of Thompson Lane.

Prior to the reoccurrence of these activities, I sent an Evidence Preservation Letter to NJT and its police powers unit on April 15, 2022. The Evidence Preservation Letter addressed to New Jersey Transit on April 15, 202, an extension on June 19, 2022, and an incident report describing the specific actions undertaken by New Jersey Transit on June 19, 2022, are attached.

A similar set of problems has occurred with various other police powers operations since my arrival in August 2007 in the NYC/NJ area. While the current prejudicial and retaliatory conduct has occurred primarily on this NJT 158 bus run, similar problems were encountered at times during my NJT rail trips between Ramsey, NJ and Penn Station, NYC between April 2011 and October 2018. I relocated from Ramsey to Edgewater, NJ in November 2018. I have also experienced various female undercover officer "honey traps" on Route 158 bus runs from 2018 into early 2022 when those ceased, though NYPD continues them in NYC.

NJT police powers activities may pre-date August 2007 as it may have been a party to prior trafficking activities involving my movements from Washington state to Boston, Massachusetts, thence to northern New Jersey between 2002 and 2007, which trafficking activities appear to have been a coordinated effort integrating FBI and various other police powers and intelligence operations in Massachusetts, New Jersey, and New York.

While not directly relevant to any future inquiry by your office, police powers agencies are also currently continuing their civil rights violations on various online dating sites (including Hinge, Match, and Tinder) as they have from 2004 into the present in both Washington/Oregon

where I lived until December 2005 and New Jersey/New York since August 2007. State and local police powers agencies as well as FBI and other federal agencies have also contributed to these and other civil rights violations over many years. A civil lawsuit is pending appeal in DC US Circuit Court at this time. Reference US DC District Court case 22-cv-996 and Appellate Court 22-5158 for further information if desired.

Re: NOTICE OF DUTY TO PRESERVE EVIDENCE

Good day:

Dennis Sheldon Brewer has filed a lawsuit against the Federal Bureau of Investigation and various federal, state, and local law enforcement and intelligence agencies. While your Agency is not yet formally named in the lawsuit, it will be upon the next amendment of named Defendants. The preservation of all documents for the duration of the litigation or until you are notified in writing you are not subject to this litigation is required under federal law and the Rules of Civil Procedure of the US District Court. This requirement extends to your agency's contacts with and targeting of the Plaintiff from Plaintiff's arrival in the state of New Jersey in August 2007 into the present and includes, without limitation, all honey trap operations, other interferences with civil rights, and purposeful service and scheduling manipulations in violation of federal civil rights law and U.S. Department of Transportation regulations during use and attempted use by Plaintiff of NJ Transit facilities, trains, and buses.

Pursuant to the federal Rules of Civil Procedure, every party to a lawsuit has a duty to preserve all evidence which could be relevant to the suit. This includes the duty to preserve all electronic and paper-based evidence, such as notes, emails, communication logs, recordings, plans, analyses, and other relevant materials discussing the incidents or related to matters at issue in the suit. The suit contemplates a broad and durable set of civil rights violations, constitutional rights violations, wrongful process, conduct not permitted under Article I Section 8 of the Constitution, and eminent domain violations. Statutes cited or to be cited in conjunction with the contemplated federal Complaint include the Klu Klux Klan Act, civil RICO, and FTCA.

This duty to preserve evidence is broad and extends to all documents, regardless of whether the document is stored electronically (such as email) or in hard-copy and regardless of the type of document. For example, reports, spreadsheets, photographs, and videotapes are all considered documents that must be preserved. Furthermore, the duty to preserve this documentary evidence extends to all documents in existence as of the time you reasonably anticipated this litigation. This Notice covers information retained on all computers, servers, server back-up systems, CDs, tapes, PDAs, cell phones, and any other device on which information may be stored electronically.

To avoid civil or criminal sanctions by the Court, ensure that all relevant documents are preserved, and no alterations are allowed. Communicate directly with all employees who have possession or control of potentially relevant evidence, including but not limited to personnel who deal with email retention, deletion, and archiving. Advise each of these employees to preserve any relevant documents in their custody. Furthermore, advise all such persons that any regularly scheduled and/or automatic deletion of email or other electronic documents must be discontinued with respect to any relevant data. In addition, any document destruction (such as shredding of documents) must cease with respect to any relevant documents. All relevant documents, both electronic and paper, must be preserved for the duration of this litigation.



NYPD Event Sequence - April 22, 2022

The following is fairly typical event sequence involving police powers undercover operations I have experienced in New York City over the past several years. Each NYC excursion has some variation on some type of psychological operation and/or sting package as does much of my online life as well. These types of events are also typical of my near daily trips and errands in Edgewater, New Jersey. Since these operations are part of daily life, I rarely take extensive notes as I would otherwise spend several hours per day writing up the detail of the outing, much as police officers must spend considerable time documenting instead of being on the street. The irony does not escape me either.

Date, Time, Planned Destination:

Friday, April 22, 2022, event located and reserved on Club Free Time.com in NYC at Irish Arts Center 11th Ave between 51st and 52nd to see Mufutau Yusuf: Owe.

Overall Travel Sequence:

New Jersey Transit (NJT) Rt. 158 Old River Rd stop on River Road to Port Authority Bus Terminal (PABT/NYC). Walk to Galaxy Diner on 9th, then to Duane Reed on 9th for replacement mask (replace broken strap) which is unavailable, then toward Irish Arts Center but misdirected and divert one block short at 51st due to address misunderstanding created by BRMT intervention, then cross 11th Ave to west side, walk south one block to 50th and west then south by Westside Highway to Intrepid, then turn east and zigzag walk to PABT Walgreens for mask, then to NJT Rt. 158 at PABT Gate 202.

Note that my diversion at 51st, one block short of the Irish Arts Center on 11th, was due to BRMT induced confusion which caused me to wrongly believe the Center was between 50th and 51st. I further note there have been several times when I was directed to non-existent addresses, unoccupied addresses and facilities, and/or non-existent events in NYC since 2007, so I wrongly assumed this was yet another one of those.

Enroute Occurrences Notes:

Typical high profile female honey trap cameos, pickets, et cetera from boarding at NJT Rt. 158 stop in Edgewater at Old River Road toward NYC. Walk from PABT to Galaxy Diner on 9th. At Diner, loud noises, backfires, and loud car revs outside, no check to table for extended period, otherwise normal. Depart Galaxy Diner at 736pm with broken mask ear loop needing replacement, internal agitation amped by BRMT beginning at Duane Reade on 9th where unable to locate mask to replace mask with broken ear loop, 4 younger undercover white males laughing in Duane Reed and more on sidewalk.

Walk toward Irish Arts Center: Up 11th to 51st, cross 11th down to 50th, walk 50th to Westside Highway.

Verbalize on 50th Street on the way from 11th to Westside Highway as BRMT powered anxiety amplitude increases. Verbalizations are regarding this set of coercive operations and BRMT enhanced anxiety amplitude being used to damage and endanger subjects and anyone nearby if subject lashes out. I verbally note potential for destruction, incarcerations, and killings of or by subject, also suggest evidence tampering if my sidewalk speech is not being accurately recorded with directional mic and camera at the end of the block (walking west on 50th during this verbalization). As expected, I note a camera/directional microphone is being placed by an older white male in a parked SUV as I pass by. Suggest possibility of evidence tampering and destruction if this cannot be found on the record in future discovery activity.

Walk south on sidewalk on the east side of Westside Highway through cluster of 4 younger adult females (honey trap bait), one of whom walks from building corner where they stand together to street corner just before I pass, then walk past pickets, and two high visibility vested parking flaggers about 1 block south (undercover older males), then more on-sidewalk pickets, then turn east just south of Intrepid, and zigzag street and avenues to return to PABT.

On return to PABT, NJT Rt. 158 bus leaves on my approach to door in gate 202 area. That bus replaced about 5 minutes later by the next bus (typical intervals between buses at this time of the evening is 15-30 minutes). Jerky high frequency accelerate/decelerate and braking by bus driver noted on ride home. This atypical bus replacement and driving behavior is likely part of the package of psychological operations intended to cause the subject to act out as a result of and/or during the event sequence.

Missing GPS location travel history sequence

During my late evening initial recap of this event sequence, I noted exceptions in my Google Maps GPS data capture on my cell phone:

556pm NJT Route 158 Edgewater, NJ to NYC

640pm to 736pm Galaxy Diner.

Missing GPS location travel history sequence on phone during my travel in NYC from Galaxy Diner to West Side Highway to Intrepid to PABT between 736pm and 812pm. Likely deleted purposefully since I had mentioned the possibility of evidence tampering in my dialog recorded during one block walk described above.

All the above are quite predictable elements of a typical psychological operation as enhanced by BRMT. Use of BRMT likely require federal police/intelligence powers collaboration as the system is very unlikely to be accessible to NYPD or other agencies outside the federal government. These BRMT enhanced operations have been going on for several decades as documented elsewhere.

Friday, April 22, 2022, Club Free Time Event, NYC, Irish Arts Center 11th Ave between 51st and 52nd:

Mufutau Yusuf: Owe Friday, Apr 22, 8:00pm

Sequence: 158 Old River Rd to PABT to Galaxy diner on 9th to Duane Reed on 9th for mask unavailable, then toward Irish Arts Center then south to Intrepid, east zigzag to PABT Walgreens for mask then to 158 at PABT Gate 202.

Notes:

PABT to Galaxy Diner on 9th, loud noises, backfire and car revs outside, no check to table, other normal. Typical high profile female cameos, pickets, etcetera from boarding at River Road stop toward NYC. Depart Galaxy Diner at 736pm with broken mask loop needing replacement, internal agitation amped beginning at Duane Reade on 9th where unable to locate mask to replace broken ear loop, 4 younger under white males laughing in Duane Reed and more on sidewalk.

Verbalize on way to Westside as amp increases regarding this set of coercive ops and amp being used to damage and endanger subjects and anyone nearby if subject lashes out, note potential for destruction, incarcerations, and killings of or by subject, suggest evidence tampering if my sidewalk speech not recorded with directional mic and camera at end of block, which device is being placed by older male in parked suv as I pass by. Suggest possibility of evidence tampering and destruction if this cannot be found on the record in future discovery activity.

Walk toward Irish Arts Center: Up 11th to 51st, cross 11th down to 50th, walk 50th to Westside highway. Turn south along Westside through 4 female cluster, past pickets, two parking flaggers about 1 block south (unders, older male), then more pickets, turn east just south of Intrepid, return to PABT.

On return to PABT, 158 leaves on my approach to door in gate 202 area. Bus replaced about 5 minutes later by next bus. Jerky ride home noted.

640 to 736pm galaxy Diner.

Deloitte Haskins and Sells, Seattle, WA

It is possible that PGE Portland (approximately 1984) project manager (name not recalled) who worked with Gerald Thorpe (see below) is same person as the individual I ran into sitting on brick pedestal at Bain & Co entrance in Boston 2006-2007. He briefly stayed in same Dorchester church basement shelter during the time I was there. He stated to another person during an afternoon van ride from Pine Street main shelter to Dorchester shelter that he was in and out of jail at various time.

Gerald Thorpe was my WSU MBA office mate in early 1979 and close personal friend and sometime business partner until about 1985. He was recruited by me in about 1981 at request of Seattle office consulting partner in charge Hopper to Seattle office from about 1981 through my Westin Seattle project (same time as Queen Elizabeth visit to Seattle) until he went to Palau with Deloitte manager Easton, then to Saudi Arabia on same Saudia project as Blair. John Blair was IT manager at Deloitte Seattle, then to Honolulu office (office later offered to me and declined by me in about 1984).

John Zoulas, WSU MBA classmate while his wife was attending WSU vet school joined Westin corporate office in Seattle. He introduced potential Westin Seattle project to me. The Seattle flagship hotel manager, Jim Treadway, was the former general manager of the South Africa Westin Hotel project in Johannesburg and went on to be President of Westin Hotels for a time.

I met my first wife in the Fall of 1979 on an audit project at Safeco Insurance corporate offices near the University of Washington. She had previously been twice married mother of two daughter as the teen wife of Greg Boyle, a subordinate of Sheriff David Reichert (later elected as Congressional representative succeeding Jennifer Dunn).

Boyle was assigned to the Reichert led Green River Serial Murderer Task Force, then Boyle named its leader succeeding Reichert, and later Maple Valley Precinct Commander. Boyle retired to and died in the Phoenix, AZ area. His younger daughter, Debora, lived with her mother, her older sister Bridgett, and me, as a teen. Debora had a personal relationship with me and my second wife and a business relationship with my second wife, Jeanette, until around 2002, while Debora lived in Gilbert, AZ and we lived in Kirkland, WA. More detail is included in my other biographical materials and my resume included in the DC District Court case 22-cv-996 and the DC Circuit appeal 22-5158.

During this time, I worked from about October 1979 to February 1980 for Margaret Dufresne, the Safeco audit manager for Deloitte. Margaret was married to Bruce Ciosacchi, a Seattle office FBI agent. We shared dates and various social activities for several years and, at one point, placed a distraught Dufresne in the back seat of our car during an episode of distress with her husband in Kirkland, WA.

Deloitte Haskins and Sells, Seattle, WA, and LazerSoft, Bothell, WA

Dave Moller was project manager who entered Deloitte Seattle office, went to South Africa some months later for Deloitte/Boeing project to place an ATM network in South Africa in about 1984/85. Moller had an alcohol abuse issue, left Deloitte after South Africa project, landed at LazerSoft. I joined him in 1986. He was ousted about 3-4 months later and I became CEO, raised another \$500K and some debt, tried to raise venture capital, failed, then sold company to Pacer during the period it as being acquired by Wembley PLC (home of Wimbledon tennis tournament).

Ruthann Meyers (a LazerSoft employee for a time before and after I arrived there as CFO) is likely also Zoe Schumaker who later identified herself as the CIO of Great Lakes Chemical. Schumaker ostensibly lived and worked in the Indianapolis, IN area. I met Schumaker at the Olympic Hotel in Seattle and transported her to a conference at the Microsoft conference center in Redmond, WA while I was a co-CEO of Performa LLC in about 2003. I later met her in a conference room in the headquarters reception area of Bio-Lab, a Great Lakes subsidiary near Atlanta. I was accompanied by my co-CEO "Darrell Pray," whether Pray was the original version or a lookalike cutout is not known. This is the same company referenced in another letter as having experienced a warehouse fire. The company manufactured hazardous flammable bromine-based pool chemicals, among other things.

As an aside, I have encountered various cutouts such as a version of "George Soros" near a subway entrance at NYC City Hall on September 11, 2021, among others over time. Typical CIA stuff, of course, though others such as NYPD likely do these types of things as well.

As a further aside, I met my second wife, Jeanette, during a visit to Greenwood Inn, Bellevue, WA. I was accompanying my software engineer, Stephen Waters, to a weeknight after-work drink at his insistence. Jeanette worked at First American Title, Bellevue, WA. One of her co-workers was married to Kerry Vanderberry, who was then assigned to the Bank Robbery task force in FBI Seattle. We babysat their infant son at least once and spent a limited amount of time together socially over the years Jeanette was employed there.

Pacific Pipeline, Kent, WA

Dennis (last name not recalled) was CEO Pacific Pipeline - I was recruited to Pacific Pipeline Board as the P.A.N Environmental Services company project was winding down (see my resume and other background information in DC US Circuit Court 22-cv-996 (refer to blue page numbers at top of page in Document 1 pages 52-53, Document 1-1 pages 2-4, and Document 1-5 pages 27-30). That Dennis, my predecessor at Pacific Pipeline, a closely held book distribution company which sold to Barnes and Noble, Costco, and numerous independent bookstores, was the former COO of Egghead Software, first name Dennis, last name not recalled. This Dennis also had a similar build to the below-mentioned CUC sorter supervisor and D&D i-banker.

This Dennis allegedly came to Pacific Pipeline from Egghead Software, a company started by an Alhadeff family member, and later taken over as CEO by the son-in-law of Sam Strom, the wealthy founder of a regional retail auto supply chain. Strom's son-in-law CEO named this Dennis as Egghead's COO. The Strom's later ceded control of the company and this Dennis was removed from Egghead. The accuracy of this legend or cover story for the prior experience of this Dennis was not verified by me. I joined the newly formed Board of Pacific Pipeline as this Dennis was named CEO, succeeding the founder, Vito Perillo, who remained as Chairman.

As an aside, the Alhadeff family owned Longacres, the thoroughbred horseracing track south of Seattle. It was among the first projects I worked on as a consultant in 1980 for its CFO. A chemist was murdered in the stables area of the track during that same period, never solved.

Kim Epskamp was the President of the MBA student association when I was at WSU. We shared some classes and also went on a bird hunt together while at WSU. Epskamp later reappeared as the banker

assigned by US Bank headquarters in Portland as the Special Credits workout officer to Pacific Pipeline after a botched ERP installation which began about September 1995 and continued into early 1996, severely disrupting both company operations and hundreds of independent bookstores in the critical holiday sales period.

Arnie Seppi (Manager Deloitte mid 1980s) and Mark Gross (a Dominick & Dickerman investment banker 2016, who later moved to Westmark, also in NYC) may be the same person.

CNA Industrial Engineering Inc, Bellevue, WA

Davidson Software (Torrance, CA) purchased Sierra, another software company (Oakhurst, CA). This company was later known as CUC. Davidson's SVP Operations (name not recalled, 1996-97) was the client officer responsible for the CNA Consulting project I managed in 1996-97 at its new Torrance CA packaging and distribution facility is likely the same person as the white-haired detail member who befriended me while I was in a Dorchester Heights church basement homeless shelter (part of Pine Street Inn) in Boston (2006-2007). The physical build and aging process are consistent with number of years elapsed.

CUC sorter supervisor (first name Dennis, last name not recalled) is likely the same person as Dominick and Dickerman investment banker Michael Callahan, and the Dennis referenced above as the Pacific Pipeline CEO for a time. The physical build and face shape are consistent with the aging process and normal aging weight gain one could reasonably expect.

Dominick & Dickerman LLC., a FINRA registered broker-dealer, with its principal place of business at 570 Lexington Avenue, New York, NY 10022 ("Dominick" or the "Advisor") is pleased to act as the exclusive financial advisor to Winnett Perico, Inc., with its principal place of business 5151 East Broadway Blvd., Suite 1600, Tucson, AZ 85711 ("Winnett", and together with its subsidiaries and affiliates, the "Company"). This letter agreement (this "Agreement") confirms the terms of our engagement.

1. Engagement and Services. The Company hereby engages Dominick to act, and Dominick hereby agrees to act, as the sole and exclusive financial advisor to the Company, upon the terms and subject to the conditions set forth herein, for the purpose of advising the Company in connection with arranging and negotiating, on terms and conditions acceptable to the Company, an Investment (as such term is defined below) in the Company, the criteria for which will be agreed as a part of this engagement, by one or more investors, groups or companies (the "Transaction Candidate(s)").

As used herein, the term "Investment" shall mean (i) the acquisition, directly or indirectly, by a Transaction Candidate(s) of any or all of the capital stock or assets of the Company by way of a negotiated purchase, leveraged buyout, tender or exchange offer, open market purchase or otherwise; (ii) any merger, consolidation, reorganization, recapitalization or other business combination pursuant to which the business of a Transaction Candidate is combined with that of the Company; (iii) any other investment including funded debt, mezzanine debt, debt convertible to equity, directly or indirectly, in the Company by a Transaction Candidate(s); (iv)

the sale of assets of the Company, including product lines or business units of the Company, or portions thereof, to a Transaction Candidate; or (v) any strategic or other alliance of any form whatsoever with a Transaction Candidate, including without limitation any joint venture, partnership, licensing, dealership or distribution arrangement, in each case, in one or a series of transactions. The term "Company", for the purposes of this paragraph, shall mean the Company or one or more persons formed by or affiliated with the Company.

- e) Recommend strategies to the Company for pursuing such Investment, including but not limited to, managing communications with the Transaction Candidate and assisting in preparing term sheets and/or other documents including responses to indications of interest, letters of intent, etc;
- f) Assist the Company in coordinating the due diligence review including the assembly, administration and dissemination of its financial, operational and legal data as required;
- g) Advise the Company from a business perspective on proposed Investment structures by Transaction Candidate(s);
- h) Advise on strategies for negotiations with a Transaction Candidate (e.g. purchase price adjustments, employment agreements, customer and vendor issues, incentive plans, earnouts);
- i) Review and offer comments of a business nature on any purchase or sale offer and any related closing documentation.
- j) Advise and support the Company as requested in other matters related to the Investment process through closing.

2. Fees. As compensation to Dominick for the services rendered hereunder, the Company shall pay or caused to be paid to Dominick the following fees (all fees payable in United States Dollars, via wire transfer of immediately available funds to an account designated in writing by Dominick):
- a) Retainer: The Company shall pay or cause to be paid to Dominick a non-refundable execution fee in the amount of twenty-five thousand dollars (\$25,000.00) upon signing this agreement.

[SEP]
 - ii. For any financing based on mezzanine, unsecured, subordinated, or second lien debt that is not linked to the Company's common stock, Dominick shall be entitled to receive an amount equal to Four Percent (4.0%) of the gross proceeds of any such financing received by the Company at such Closing.
 - iii. For any financing based on senior secured debt, Dominick shall be entitled to receive an amount equal to Three Percent (3.0%) of the gross proceeds of any such Financing received by the Company at such Closing. [SEP]
 - c) Contingent Equity Fee: At each and any Closing in connection with a financing involving or consisting of Equity Linked Securities, Dominick, in addition to any Success Fee, shall receive from the Company, and the Company shall issue to Dominick, such number of Equity Linked Securities equal to Five Percent (5.0%) of the securities issued or issuable to the Transaction Candidate exercisable or convertible on the same terms as the Equity Linked Securities issued or issuable to the Transaction Candidate.

For purposes of calculating any Success Fees due hereunder, "Total Consideration Paid" (with respect to each Investment) shall mean the aggregate value of all cash, securities and other property paid or agreed to be paid or any and all liabilities and funded debt incurred or assumed or agreed to be incurred or assumed (including, without limitation, any such payments or assumptions that are contingent on the occurrence of some future event) by or on behalf of the Company, whether directly or indirectly, in connection with the Transaction. Without limiting the foregoing, Total Consideration shall also be deemed to include any management, consulting, non-compete or similar fees paid, and the aggregate value of any licensing or similar arrangements entered into, or guaranties made, or indebtedness incurred or assumed, or transfers of assets made by or on behalf of the Company, whether directly or indirectly, in connection with the transaction.

3. Out-of-Pocket Expenses. The Company shall reimburse Dominick promptly upon request for any out-of-pocket expenses reasonably incurred during the period of its engagement hereunder with respect to the services to be rendered, including, but not limited to, travel expenses, communication expenses and professional fees incurred by Dominick. Any individual expense in excess of \$1,000 will require pre-approval by the Company.
4. Term. This Agreement shall begin on the date hereof and terminate on the date twelve (12) months hereafter. Notwithstanding the foregoing, either party may terminate this Agreement at any time with thirty (30) days prior written notice. Paragraphs 2, 3, 4 (with respect to this sentence only), 6, 7, 8, and 13 through 18 shall survive the termination of this Agreement.
5. Confidential Information. Dominick acknowledges and agrees that, except as otherwise required by law, judicial process or regulatory request or demand, or as contemplated by its engagement hereunder, the non-public information furnished to Dominick by the Company hereunder shall be held by Dominick as confidential for a period of two years following the termination of this Agreement. Dominick shall be responsible for any breaches of this provision by its agents and representatives. The term "Confidential Information" shall not include information which (i) was or becomes generally available to the public other than as a result of a disclosure by Dominick or its representatives, (ii) was rightfully known to Dominick or was rightfully in Dominick's possession prior to the date of disclosure, (iii) becomes available to Dominick from a third party and to Dominick's knowledge such third party is not in breach of an obligation of confidentiality by making such disclosure, (iv) is independently developed by Dominick without the use of Confidential Information or (v) has been approved for release by written authorization by the Company.
6. Indemnity. The Company agrees to indemnify and hold harmless Dominick, (its affiliates, and respective officers, directors, agents, employees and controlling persons, (each, an "Indemnified Party") from and against all claims, liabilities,

losses, damages and expenses (including reasonable attorneys' fees and disbursements), joint or several, to which Dominick may become subject arising out of or relating in any way to this Agreement and Dominick's services thereunder, provided, however, that the Company should not be liable for any such claims, liabilities, losses, damages, and expenses which a court of competent jurisdiction shall have found in a judgment final beyond possibility of appeal, resulted solely and directly out of the willful misconduct, bad faith, or gross negligence of Dominick, or Dominick's violation of any material provision of this Agreement. The Company will not, without Dominick's prior written consent, settle, compromise, consent to the entry of any judgment in or otherwise seek to terminate any action, claim, suit or proceeding in respect of which indemnification may be sought hereunder (whether or not Dominick is a party thereto) unless such settlement, compromise, consent or termination includes a release of Dominick from any liabilities arising out of such action, claim, suit or proceeding. The foregoing indemnification is effective immediately in respect of all events occurring or omitted prior to or after the date hereof. In order that the Company and Dominick can best coordinate efforts to effect Investment, the Company agrees that during the term of this Agreement it shall initiate any and all discussions with potential Transaction Candidates only through Dominick. Notwithstanding the foregoing sentence, nothing herein shall be construed as limiting the Company's right to obtain the advice of its legal counsel or other representatives as necessary or its right not to use Dominick's services.
9. Notices. All notices provided for by this Agreement shall be in writing addressed to the parties at the address for such party first set forth above, and shall be transmitted by either personal or overnight courier delivery, or by certified mail. All notices shall be deemed given when received by the party to whom it is addressed. All requests or other communications provided for by this Agreement (except as set forth in the first sentence of this paragraph) may be by email or facsimile transmission.
10. Successors and Assigns. This Agreement shall inure to the benefit of, and be binding upon, each of the Company and Dominick and their respective successors or assigns. Neither party may assign its rights or obligations under this Agreement without the written consent of the other party.
11. Pre-Existing Relationships. The Company acknowledges that a pre-existing relationship may exist between Dominick and the potential Transaction Candidate. In connection with any such pre-existing relationship, Dominick shall not act adversely to the Company's interests hereunder and subject to confidentiality restrictions, Dominick shall promptly inform the Company with respect to such pre-existing relationship.
12. Amendments. No amendment, modification, termination, or waiver of any provision of this Agreement, or consent to any departure by either party therefrom, shall be effective unless signed in writing by the parties hereto.




20. Counterparts. This Agreement may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.



12 Good day –

13 There is a continuing pattern of police powers abuses being undertaken against me
14 online, including on July 5, 2022. This is one element of an overall pattern of police powers
15 corruption and abuse which has been conducted over a long period of time, likely since before I
16 arrived in the New Jersey in 2007.

17 Mr. George Turner at SDNY Criminal, copied on this letter, is my point of contact at the
18 Department of Justice. I have been periodically writing letters to SDNY for several months now
19 and have filed a civil RICO and KKK civil rights case in the District of Columbia. I recommend you
20 contact Mr. Turner prior to taking any actions relating to this letter. You can also consult civil
21 litigation I have filed in DC US District Court 22-cv-996 and DC US Circuit Court 22-5158.

22 The most recent tampering and harassment incidents occurred after my morning
23 delivery to SDNY in New York City on July 5, 2022. These incidents relate to 1) my attempt to
24 communicate with the NJ AG Office of Constituent Services (OCS) via webform, and 2) my
25 attempts to communicate with various U.S. Senators via webform.

26 The NJ AG OCS (item 1 above) previously acknowledged my two webform
27 communications in 2 minutes and 6 minutes of submission last week. There was no such
28 acknowledgement on June 5 as of 9:12pm to my webform submission after my 6:44 pm
29 webform completion. Further, as the attached webform history record shows I actually
30 accessed the webform at 6:44 PM. However, even the history shown has been tampered with.

31 When I first checked the history, both the Yahoo search and the OCS website showed up
32 as having occurred at 6:10pm. Neither the Yahoo search nor the OCS webform completion
33 occurred at 6:10pm. Both the Yahoo search and the OCS webform access occurred at 6:44PM.
34 This is clear evidence of tampering with my search history.

35 The OCS communication in question related to what appears to be yet another
36 incidence of police powers spoofing. The HP Instant Ink customer service interaction occurred
37 after about 14-16 hours I spent over two days trying to clean up one of their prior attacks, likely

38 by this same police powers operation. The entire interaction from initial hack through the
39 customer service interaction documented in the enclosed documentation was clearly intended
40 to harass and frustrate.

41 The customer service interaction was not in any way consistent with the actions of any
42 major corporation's customer service unit. I spent more than 20 years working with and in the
43 corporate world as a consultant and executive. The actions and the responses of the customer
44 service personnel were completely inconsistent with the way these businesses treat their
45 customers. They also likely would violate consumer protection laws in any case, so the
46 interaction can most plausibly be interpreted only intended to be harassment, retaliation, and
47 tampering.

48 These types of tampering incidents and the harassment demonstrated by the police
49 powers "HP customer support" interaction have occurred repeatedly as described in my
50 previous letters and incident reports to Mr. Turner. By way of example, such incidents include a
51 recent visit to NYC's Irish Arts Center when my cell phone's Google GPS tracking history was
52 deliberately suppressed, tampered and removed from my phone. Since I live in New Jersey, I
53 thought it might be useful to link your two entities together as relates to these matters. The
54 pace and extent of these interferences has notably increased in recent months and most
55 certainly are related to my repeatedly disrupted efforts to communicate with DOJ, various
56 federal Inspectors General, and with the DC District and Circuit Courts.

57 The Senate messages (item 2 above) relate to Moore v Harper, an upcoming Supreme
58 Court case and its implications for business before the Senate. Please note I am currently
59 attempting to verify whether this communication was received during the July 4th recess period
60 and simply not responded to by personnel who were out of office during the recess period. This
61 would be unusual given the typical auto-responses I receive but is possible.

62 Webforms provided at each of these Senate websites were accessed between 2:28pm
63 and 2:38pm and a uniform message was left on each webform. I typically receive a reply from
64 each office, though not always. As noted in the enclosed webforms 1-4, I accessed these sites
65 on Saturday, July 3. Instead of the typical auto-responder message I receive, I only received an
66 acknowledgement form from Senator Sinema. Since the matter in question has critical electoral
67 consequence, I am concerned the messages may not have reached the Senators' offices. This
68 may be yet another set of wire frauds by Defendants.

69 Previous interferences with rights, harassment, tampering, and other invasions have
70 occurred hundreds of times. Most of those involving street-level police powers personnel have
71 occurred in New York City, involving NYPD and other police powers agencies there, and/or on
72 New Jersey Transit involving both operations and police powers personnel. Also, among other
73 things, the Bergen County website used to register for Covid vaccines was also blocked, hacked,
74 and otherwise manipulated on at least some of the 149 attempts I made to make an
75 appointment for the vaccine over about 6-7 weeks in early 2021. Interferences with my

personal life have included direct police powers manipulation of my social interactions and short and longer term relationships, among other things.

Due to the extent and duration of these and other adverse police powers targeting in this region, which are civil and constitutional rights violations and retaliation, and have persisted since 2007 when I arrived in New Jersey, I do not and will not communicate directly with police powers operations regarding these matters. They have enduring conflicts of interest. I have no problem communicating directly with personnel permanently assigned to public integrity and national security prosecutions or with inspectors general operations which are not internal elements of any police powers operation.

Cindy – Thanks for your message. Despite several attempts, I was also unable to reach any customer support to resolve a complete inability to print even with store bought cartridges. I did talk to several people but got a complete run around from them. Copy of a chat transcript below for your review as an example of the type of interaction I had.

In order to get the needed documents delivered only 2 days late, I bought an Epson printer and will be using that going forward. No more HP despite 35 or so years using them and getting previously excellent print quality and support. Once you send me a notice that the balance has been written down to an appropriate amount, I will provide a credit card number to charge and return the unused ink.

It seems some intervening mail fraud and wire fraud may have been the reasons for these problems but I cannot be sure. In any event, the instant ink arrived late, then printing was disrupted, then I cancelled but was still charged at \$1 per 10 pages after cancellation date, then I bought third party ink at Target and could not print at all, then HP support was bad. Invested around 14-16 hours to fix these issues, its simply not worth the time wasted, so I no longer use subscription ink nor provide direct internet access for printer updates. I have had this type pf problem episodically in the past as I've tried to communicate critical information and while simply doing normal office work, so that is the reason In

think it is wire fraud at the root. It's consistent with pother police powers experiences from my life in general. Extra-legal, unconstitutional, but here we are.

Good day –

There are on-going police powers abuses being undertaken against me online as recently as yesterday July 5. This is an element of an overall pattern of police powers corruption and abuse which has transpired over a long period of time, likely since before I arrived in the State in 2007. Mr. Turner, SDNY, is my point of contact at the Department of Justice. I have been writing letters to SDNY for a number of months now and have filed a civil RICO and KKK case in the District of Columbia.

The most recent incidents occurred on July 5, 2022, after my morning letter packages delivery to SDNY in New York City and relate to 1) my attempts to communicate with various U.S. Senators, and 2) my attempt to communicate with the NJ AG Office of Constituent Services (OCS) via webform in the early evening. Previous interferences have occurred hundreds of times. Most of those involved police powers personnel in street operations have occurred in New York City involving NYPD and other agencies there, and/or on New Jersey Transit involving both operations and police powers personnel. Among other things, the Bergen County website used to register for Covid vaccines was also blocked, hacked, and otherwise manipulated on at least some of the 149 attempts I made to make an appointment for the vaccine over about 6-7 weeks in early 2021.

The Senate messages (item 1 above) relate to an upcoming Supreme Court case and its implications for business before the Senate. Webforms provided at each of these Senate websites were accessed and a uniform message was left on each webform. I typically receive a reply from each office, though not always. As noted in the enclosed webforms 1-4, I accessed

these sites on Saturday, July 3. Instead of the typical auto-responder message I received, I only received an acknowledgement from Senator Sinema. Since the matter in question is of electoral consequence, I am concerned the messages may not have reached the Senator's offices. In other words, wire fraud, at least from the point of view of a citizen.

The NJ AG OCS (item 2 above) previously acknowledged my two webform communications in 2 minutes and 6 minutes of submission last week. There was no such acknowledgement to my webform after my June 5 at 6:44 pm webform completion as of 7:40 pm. Further, as the attached webform history record shows I actually made that effort at 6:10 PM on July 5. However, the history shown has been tampered with. When I first checked the history, both the Yahoo search and the OCS website showed up at the time shown for the relevant Yahoo search, which appears to have occurred at 6:10PM. It did not occur at 6:10PM. Both the Yahoo search and the OCS webform access occurred at 6:44PM. This is clear tampering with the evidentiary record in my search history, again at least from the perspective of a citizen.

These types of incidents have occurred repeatedly as described in my previous letters and incident reports to Mr. Turner, including on a recent visit to NYC's Irish Arts Center when my cell phone Google GPS tracking history was deliberately suppressed. Since I live in New Jersey, I thought it might be useful to link your two entities together as relates to these matters. The pace and extent of these interferences has notably increased in recent months and most certainly are related to my repeatedly disrupted efforts to communicate with DOJ, various federal Inspectors General, and the federal court in DC.

Due to the extent and duration of adverse police powers operations in this region since 2007 when I arrived, I do not and will not communicate directly with police powers operations regarding these matters due to their inherent conflict of interest. I have no problem communicating directly with personnel permanently assigned to public integrity and national security prosecutions or with inspectors general operations which are not internal elements of a police powers operation

Cindy – Thanks for your message. Despite several attempts, I was also unable to reach any customer support to resolve a complete inability to print even with store bought cartridges. I did talk to several people but got a complete run around from them. Copy of a chat transcript below for your review as an example of the type of interaction I had.

In order to get the needed documents delivered only 2 days late, I bought an Epson printer and will be using that going forward. No more HP despite 35 or so years using them and getting previously excellent print quality and support. Once you send me a notice that the balance has been written down to an appropriate amount, I will provide a credit card number to charge and return the unused ink.

It seems some intervening mail fraud and wire fraud may have been the reasons for these problems but I cannot be sure. In any event, the instant ink arrived late, then printing was disrupted, then I cancelled but was still charged at \$1 per 10 pages after cancellation date, then I bought third party ink at Target and could not print at all, then HP support was bad. Invested around 14-16 hours to fix these issues, its simply not worth the time wasted, so I no longer use subscription ink nor provide direct internet access for printer updates. I have had this type pf problem episodically in the past as I've tried to communicate critical information and while simply doing normal office work, so that is the reason In

think it is wire fraud at the root. It's consistent with pother police powers experiences from my life in general. Extra-legal, unconstitutional, but here we are.
