## Southern District of New York: Brewer v Burns et al case number 1:23-cv-09605-UA

On November 1, 2023, I add the postscript below and the Addendum - Congress Part One, enclosed, to my letter of October 10, 2023 –

Jack – Kindly explain in your amicus brief how your past actions in support of national security in your earlier career, and as expressed in Active Liberty, comport or do not, with those of the gentleman whose story begins on the next page. My great-great grandfather, William John Brewer, was an Army Corporal during the Civil War, who riding atop a horse in hostile fire for four years as an unarmed pacifist bugler, wheeling his Cavalry Company at the command of its CO. William John rests in a Quaker cemetery in Cornwall-on-Hudson, NY. He acted practically and actively to support the Constitution and what would become the 13<sup>th</sup> Amendment. Please further explain how your own past actions comport or do not with your premise in Active Liberty as they relate to this specific secret program of illegal human experimentation and racketeering over the past fifty years.

Two of William John's great grandsons, my father and uncle, also both honorably served in the US Army at similar rank to William John and to you. Among others, and likely based upon their Quakerstyle pacifist religion, these two men were forcibly and surreptitiously converted to indentured servitude for a further lifetime of service beyond their official service. They were deliberately engaged by Army, FBI, and CIA before me in ActivLabor on behalf of a malignant federal enterprise which has been and still is focused on protecting its federal police powers over protecting the liberty and "unalienable Rights" of American citizens.

As you well know, I inherited that role as an indentures servant as well, a bill of attainder lacking even an authentic original cause, much less any valid constitutional basis. Others have similarly suffered, though we do not yet know all their names nor all their fates. Those names and those fates we will determine - with or without the help of government officials - so that their fate becomes clear to all the world. These malign acts and conspiracies of our government do directly contradict the clear intent of the Declaration and Constitution and do violate the 13th Amendment very directly and specifically.

For its own convenience and self-exculpation, our federal government has purposefully confused the nature and corpus of the sovereign. As to the actual and intended nature and corpus of the sovereign, I offer you the founding People's answer to the English King they despised as a Tyrant and Oppressor:

From our Constitution: "We, the People.......do ordain and establish this Constitution for the United States of America......" clearly demarcating the corpus of the sovereign, and Our relationship to Our agent to be known as the United States of America, just as surely as any Articles of Incorporation do when filed with any Secretary of State of any of our fifty states. Further, the purpose of government is clear as *emphasized* in the first phrases of the Declaration

From our Declaration: "We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness.--That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed, --That whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to institute new Government, laying its foundation on such principles and organizing its powers in such

form, as to them shall seem most likely to effect their Safety and Happiness. Prudence, indeed, will dictate that Governments long established should not be changed for light and transient causes; and accordingly all experience hath shewn, that mankind are more disposed to suffer, while evils are sufferable, than to right themselves by abolishing the forms to which they are accustomed. But when a long train of abuses and usurpations, pursuing invariably the same Object evinces a design to reduce them under absolute Despotism, it is their right, it is their duty, to throw off such Government, and to provide new Guards for their future security.--Such has been the patient sufferance of these Colonies; and such is now the necessity which constrains them to alter their former Systems of Government. The history of the present King of Great Britain is a history of repeated injuries and usurpations, all having in direct object the establishment of an absolute Tyranny over these States. To prove this, let Facts be submitted to a candid world. .......

"In every stage of these <u>Oppressions</u> We have Petitioned for Redress in the most humble terms: Our repeated Petitions have been answered only by repeated injury. A Prince whose character is thus marked by every act which may define a Tyrant, is unfit to be the ruler of a free people."

\* \* \* \* \*

National security law and regulation, constitutionally formulated, protects the sovereign, We, the People, not an agent acting contrary to the sovereign's interests. The intrigue of agents ostensibly serving the sovereign, and secretly serving themselves, was left to certain Lord Chamberlains, as you may recall from English history.

For that matter, that same lesson is available in recent Chinese history, such as a head of missile forces, a military chief, a foreign minister, and a premier, wherein our Company and at least one President acting well outside constitutional authority played key roles, and invited nuclear retaliation under the international laws of war for their willful illegal acts of war to be visited upon us all.

That proper constitutional relationship of the sovereign with our agent must be restored if we are to be a democratic republic. Putting this relationship right and putting the agent in its proper place through gravely needed consequences must be done (and never has been done) - or we will have no democratic republic, nor perhaps even life itself, for millions of our fellow citizens.

You can assist if you choose to do so. Your legacy will remain.

Finally, if you would, please also request your colleague Professor Tribe to extend this same courtesy of an amicus brief so we may begin to restore the People's dignity and liberty over that of an oppressive agent, a federal government which lost its way some time ago. Perhaps Judge Luttig would be willing to do the same. These acts will be on behalf of a class of oppressed persons who have been treated to tyrannical and oppressive behavior - just as Americans were in the prior versions of this pogrom - FBI's Cointelpro, CIA's MKUltra, and the Army's companion bioweapons lab pogrom against our own soldiers and civilians - and as they were in tyranny and oppressions in the King's Colonies before the Declaration was signed. And on behalf of all Americans, including your grandchildren and millions more.

The alternative is yet more cycles of the depravities and ravages of MKUltra and Cointelpro, malign patterns of practice the federal executive perpetuates in its daily operations (see my numerous incident reports in the exhibits) within DOJ, within DHS, within the intelligence community, imposed by our ostensible agent on our children and our grandchildren. Is that what we wish for them?
