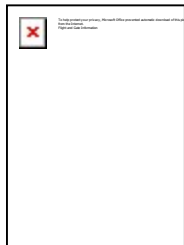

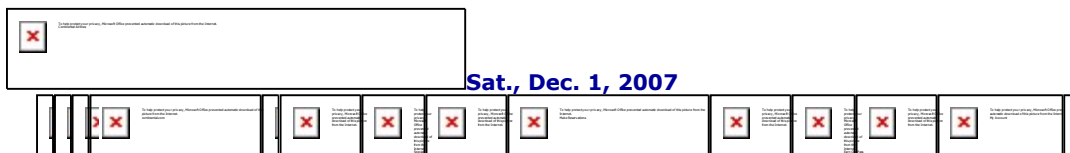

Conrad - Good afternoon. Three issues remain to complete our close out process:

1) Denise suggested I discuss the Clipper Windpower commission with you. According to my offer letter dated July 25, 2007:

"You will be eligible to earn a 4 percent commission on work that you sell. We use a team selling effort for many of our projects. This means that in addition to your individual sales activities, we will involve you in sales along with others in the firm. My name is Jonathan and I will be team leading this afternoon project. From 12:30 - 4:00 P.M. we will be helping to sort, tag, and hang clothing for a Housing Works warehouse in Long Island City. Housing Works is a non-profit organization that uses the proceeds from selling clothing in thrift shops to help homeless and low-income people living with HIV/AIDS. Now for today's essay ;-)

Much of my life, including family relationships, money, financial assets, creditworthiness, property, income, business, and reputation, has been stolen by this long-running episode of criminal misconduct. It's a kinder, gentler form of institutional facism (deterministic treatment of persons or groups on the irrational basis of the subject's family or religious heritage or ethnicity, the persecutors' group identity, etc., rather than character and behavior) using covert means to attain its hateful goals. Assuming that regime change means that this serial psychopathic form of non-compliance with the rule of law changes, things should get better for me.

But the institutional tools for accomplishing this extralegal form of persecution remain in place to this day - and there is no meaningful institutional check and balance for this misconduct. The rules that say this shall not be done are not generally enforced - that would be contrary to sometimes hateful and irrational thinking which claims the thin blue line can do no wrong and your fellow law enforcement or intelligence employee must be protected no matter what they do. Accomplishing authentic rule of law will require both further professionalization of the law enforcement and intelligence communities and a meaningfully funded and staffed institution at the federal level which can educate, supervise, investigate, and prosecute to the full extent of the law across all agencies with police and intelligence powers - federal, state, and local - for that is the true extent of the problem which I, and many others, have experienced.

We have the highest incarceration rate on the planet - 1% of the adult population is in prison - six times the world average. Only Russia and the Central Asian republics - all formerly part of the Soviet Union - have a rate which approaches (but does not equal) the incarceration rate in the US. And I can say with certainty that no jail cell is required to be extralegally sentenced to indeterminate detention - you can experience the same loss of liberty, property, and movement as a result of the extralegal efforts of covert police and intelligence operations. My life experience in recent years and in numerous locations across the US definitively demonstrates this problem, it is indeed a kinder, gentler form of facism.....
