Conrad - Good afternoon. Three issues remain to complete our close out process:

1) Denise suggested I discuss the Clipper Windpower commission with you. According to my offer letter dated July 25, 2007:

"You will be eligible to earn a 4 percent commission on work that you sell. We use a team selling effort for many of our projects. This means that in addition to your individual sales activities, we will involve you in sales along with others in the firm. If you sell work totally on your own, the commission will be 4 percent of the billable work. If you sell the work in a team effort, then you will earn a percentage of the 4 percent commission based on your participation in the sale. This commission will be paid quarterly on the basis of billable work during that time on projects you sold or participated in selling."

To briefly review the Clipper sales process:

- The Clipper lead was developed by me at a private equity conference I participated in NYC.
- I prepared, reviewed, and revised a powerpoint presentation of Establish to Clipper with the initial lead, then presented this information to the Clipper management team which ultimately selected Establish.
- Christine Wong and Bill Drumm accompanied me on the initial sales call in Santa Barbara.
- I prepared the initial proposal dated in December.
- I discussed the proposal with Clipper management.
- Based upon those discussions, I prepared and reviewed the revised proposal with Clipper management. This proposal was ultimately agreed by Clipper's COO.
- The work as agreed in the proposal was performed, resulting in billings of slightly more than 100,000.

Clipper was clearly billable work sold by me. I believe I am due a 4 percent commission on this billable work under terms of my offer letter.

2) Bill Drumm and I discussed the PPG project and agreed to a 2% commission rate on billable work for that client.

3) Denise has informed me that I owe the firm 2 days vacation. I accept this determination.

I look forward to concluding this matter at your earliest convenience.

Jaymes - I spoke with Dave Wyly on Monday. He relayed your interest in using an earnout to achieve management's ownership objectives. Attached please find a spreadsheet with an earnout formula. The earnout occurs over a total of three years, 18% in 2012, 32% in 2013, and 50% in 2014, assuming we meet our Business Plan earnings goals. It also contains my founder's shares (which in fact are in line with the ownership interest guidelines that Dave relayed to me last week). None of my team objects to using the earnout approach instead of the lapse of time approach we had intended to use with the restricted stock.

I hope you find the earnout formula to be satisfactory to your fund's interests. It is certainly an excellent way to align the interests of the fund and those of the management team, other key employees, and Directors.

Also attached find a spreadsheet describing a proposed bridge loan from others, to be used by the company during January and early February to advance critical tasks (described in the spreadsheet) which need to be performed on the Niobrara site. Getting this work underway in January is important. It will allow us to complete these tasks in time for the late March start of the planting season.

Options to purchase shares to Brewer CEO 1,000,000 shares, Dooley CFO 500,000 shares, Morse VP Operations 500,000 shares, all at \$1.40 option price.

Seward, our Sales VP, has elected to work on a consulting basis for the first year due to low expected demands on his time and will therefore not participate in this equity round as an optionee. I have already completed nearly all of our customer pre-contract work. Once we have the production property in place, I will be working with Seward to complete customer contracts for our organic wheat and for organic and commercial beans. Also, is the \$5 million loan package in October a certainty or is that just the next time they will look at it to make a decision? It's important to know the status - if it is a certainty, I can get a bridge loan from an existing investor for \$250,000 plus.

I have \$5 million in equity tentatively raised if we can figure out how to get a management investment into the company (which I will do by borrowing the funds from the seller of one of the properties we are acquiring). I also have commitments from a mortgage lender and a leasing company subject to raising \$14M of total equity capital. I would like to get started on this rest of this equity raise but need about \$150-\$250K including salaries, legal expenses, fees, and travel to get through the end of the year. Is this \$250K something Blue Leopard could help us get done in the next 60 days if one of the other two options above does not work out in the near term?
