Re: Illegal Police Power Operations by NYPD – 2007 to Present

Dear Mr. Mayor:

Congratulations on your inauguration as Mayor of New York City. This letter reprises much of a letter I sent to you on December 13 and includes updates of more recent illegitimate police powers abuses which continue into the present moment.

Due to the high profile situation I find myself in by no design of my own, you doubtless know NYPD has continued to engage in “investigative” operations against me throughout the Bloomberg and DeBlasio administrations, at times in conjunction with various federal, state, and local police powers operations in the region. It’s part of an on-going pattern of extra-legal and unconstitutional operations against me which has persisted over decades. It has included counter-terror, honey traps, collaborative efforts to sexually humiliate me, control of my rights to speak and assemble, speak and associate with others freely, and a variety of other operations. NYPD is a named Defendant in my litigation against several federal Departments and Agencies within DOJ, DHS, DOD, with additional defendants to be named.

Despite nearly two decades of offensive operations involving NYPD, they have failed in repeated entrapment attempts which have never had any legal foundation of reasonable suspicion, and constitute on-going violations of the Constitution, civil rights law, and racketeering statutes of the United States and the State of New York. While it is unclear how many other people have been swept up in this type of corrupt operations posing as law enforcement, it is clear these have been intended to entrap, discredit, destroy, and to retaliate for making other persons and entities aware of their corrupt conduct.

This type of conduct has been pervasive in federal intelligence operations inside the United States. Cointelpro revealed the common tactics of FBI, including burglaries, disinformation, slander, and entrapment efforts against people focused on asserting their Constitutional and civil rights and the rights of groups they represented. MKULTRA, despite the best efforts of CIA to destroy evidence of its illegal activities within the United States against US persons, was exposed for direct and indirect efforts to sanction (kill) some of those caught in their experiments, also enabled by elements of the U.S. Army.

In more recent times, senior citizens were investigated by Department of Commerce and Department of Homeland Security police powers operations for such protected activity as political speech and reportage. This lawless conduct has persisted due to the federal government’s inability to manage and police its own agents, officers, and task forces even inside the United States. Coverups continue and violations go unpunished. For example, FBI failed to properly investigate one medical doctor’s on-going misconduct against hundreds of female gymnasts and others. FBI promptly fired the supervising agent who allowed the conduct to continue by his negligent and dilatory investigation, exactly one week before a highly publicized Congressional hearing – six years after his improper conduct.

I am certainly confident you are much more aware than I am of similar patterns of conduct inside New York City's police power operations. The culture of large institutions with a tradition of impunity, retaliation, lax and difficult to accomplish discipline, and the tendency of senior leaders to discipline lower level personnel for conduct they had previously engaged in themselves, had ordered others to conduct, or had consistently failed to discipline until a matter became politically difficult for the agency, is extraordinarily difficult to change.

It is not, however, impossible to accomplish the required change, transparency, and accountability. For example, accountability in the protection of money has gone through a series of evolutionary actions over the last 100 years. The current iteration, with updates to state and federal laws, protect money and wealth with independent regulatory agencies, such as the Security and Exchange Commission, independent financial audits, and the explicit requirements of Sarbanes-Oxley for independent auditors to seek out corruption and to be periodically rotated so incestuous relationships with auditors and regulators. An independent entity fully read in on police powers operations and completely independent is the best way to accomplish accountability and transparency.

In addition, it is probable that NYPD has been willingly or unwittingly co-opted into improper investigations and coverup by self-interested federal actors. Taken together with the police powers/intelligence community's pattern of entrapping and self-exculpatory conduct, an on-going culture which does not serve the public well, prior terror attacks in New York City, the presence of the United Nations and the obvious presence of various international actors working to acquire intelligence and political advantage on the world stage in New York City, it's clear NYC is fertile ground for both confused operations, misinformation promulgated by any number of sources, and misconduct.

Among the possibilities for these completely inappropriate extra-legal and unproductive operations against me and other persons like me is the employment of current or former members of the federal government within NYPD. The most likely root cause of this type of perpetuated misconduct would be an individual or team resident inside NYPD whose actual on-going allegiance is to a "working group" within CIA, FBI, or a DOD special operations unit. To date, each of these agencies has stonewalled my requests for information about this pattern of conduct which dates to my teenage years. I am 66.

After its initial acknowledgment of a counter-terror operation against me, NYPD has also denied the existence of any related records. A recent letter to the NYPD PALS unit resulted in a response from Lt. Robert Corbett, Esq., on November 23, 2021. Lt. Corbett stated the basic computerized records available to line officers has no record of me. The likely reason is the sensitivity of these operations conducted off books due to the initial terror designation by the federal government abusing the JTTF process. Its field operations conduct is far more obvious. For example, on November 13, 2021, NYPD rushed two units to the front door of the 108<sup>th</sup> Precinct station as I was walking by. The Precinct had previously dispatched a vanload of plainclothes female officers to run about a dozen lone female pedestrian honey trap operations against me. I encountered the non-concealed "bait" members of this team as I walked through the Hunter's Point area along the East River a few minutes later that evening, between about 6:30PM and 8:00PM.

Similar activities have occurred on my frequent visits to the City over the years, including as recently as the evening of December 27<sup>th</sup>. I have no desire to "out" undercover officers as they have other duties which do place them in challenging situations and need the advantage of their cover. However, ongoing unconstitutional conduct by the Department cannot be tolerated at any time, nor should it be. Police

powers operations which have no basis in fact are both illegal and unconstitutional as the Department well knows, *Floyd v City of New York*, and so forth. The use of “surround” or “kittling” tactics is also illegal whether applied to a street protest or to access to other civilians on dating websites.

The ex-husband of my first wife hunted the Green River serial killer while I resided in King County, Washington. That individual was a person of interest for a couple of decades, during which time he continued to be employed as a truck painter by a large corporation, raise children, pay the mortgage, and so forth, as required by the Constitution and the laws of the United States. Lawless police powers operations which include prior restraint of speech; kettling for the purpose of setting up fake relationships, various forms of attempted sexual humiliation, and fake employment, among other things; honey trap operations endlessly repeated without any legal foundation; a counter-terror operation involving about two dozen officers in vests carrying submachine guns; and so forth, are in fact, criminal abuses of police powers. They are certainly not law enforcement which conforms to Constitutional requirements, the rule of law, or case law.

These predatory practices are a violation of the Klu Klux Klan Act which, taken together with other predatory and retaliatory actions can also be charged under federal RICO. While my case is a civil case, I have also provided SDNY similar information.

I strongly encourage you to have your new Commissioner closely review these actions using a trusted team member who is independent of current JTTF, Intelligence, Precinct, and other line operations. This review will find durable misconduct, both witting and unwitting by NYPD, as well as the abuse of JTTF case designation and investigative procedures in my case and, most likely, others. Discrediting and retaliation after those initial counter-terror operations in my case will also likely be readily identifiable.

Corrective action for this misconduct by the incoming Mayor and Commissioner would seem to be preferable to widespread adverse publicity and the inevitable blame-shifting attempts to the City of New York by the federal agencies which initiated this entire problem and process decades ago in the State of Washington.

As mentioned, NYPD is being sued by me in the US District Court for the District of Columbia and will be served soon. Other Defendants will be added to the existing list of federal Department and Agency Defendants as needed to responsibly and properly litigate this case. It is also possible that other Plaintiffs with ties to the NYC area will be identified during the discovery process.

**Re: SECOND AMENDED NOTICE OF DUTY TO PRESERVE EVIDENCE**

Good day:

Dennis Sheldon Brewer has filed a lawsuit against various federal, state, and local law enforcement and intelligence agencies, and is in the process of evaluating including Match Group as a Defendant. The preservation of all documents for the duration of the litigation or until you are notified in writing you are not subject to this litigation is required under federal law and the Rules of Civil Procedure of the US District Court. *This requirement extends to the Plaintiff's contacts as a user with Match.com, Tinder.com, and Hinge.com beginning in 2004.*

*Without limitation as to any form of evidence described in this letter, any communication or record thereof in any form, at any time from September 2001 forward, with any law enforcement or police powers organizations and operations, or any person or entity which directly or indirectly manages or controls same, related to myself or the entities listed below must also be preserved, as well as any internal communication in any form regarding any interactions with law enforcement police powers organizations and operations related thereto.*

Pursuant to the federal Rules of Civil Procedure, every party to a lawsuit has a duty to preserve all evidence which could be relevant to the suit. This includes the duty to preserve all electronic and paper-based evidence, such as notes, emails, communication logs, recordings, plans, analyses, and other relevant materials discussing the incidents or related to matters at issue in the suit. The suit contemplates a broad and durable set of civil rights violations, constitutional rights violations, wrongful process, conduct not permitted under Article I Section 8 of the Constitution, and eminent domain violations. Statutes cited or to be cited in conjunction with the contemplated federal Complaint include the Klu Klux Klan Act, civil RICO, and FTCA.

This duty to preserve evidence is broad and extends to all documents, regardless of whether the document is stored electronically (such as email) or in hard-copy and regardless of the type of document. For example, reports, spreadsheets, photographs, and videotapes are all considered documents that must be preserved. Furthermore, the duty to preserve this documentary evidence extends to all documents in existence as of the time you reasonably anticipated this litigation. This Notice covers information retained on all computers, servers, server back-up systems, CDs, tapes, PDAs, cell phones, and any other device on which information may be stored electronically.

To avoid civil or criminal sanctions by the Court, ensure that all relevant documents are preserved, and no alterations are allowed. Communicate directly with all employees who have possession or

control of potentially relevant evidence, including but not limited to personnel who deal with email retention, deletion, and archiving. Advise each of these employees to preserve any relevant documents in their custody. Furthermore, advise all such persons that any regularly scheduled and/or automatic deletion of email or other electronic documents must be discontinued with respect to any relevant data. In addition, any document destruction (such as shredding of documents) must cease with respect to any relevant documents. All relevant documents, both electronic and paper, must be preserved for the duration of this litigation.



Good day –

I received your letter of March 22, 2022, indicating the subjects raised in my complaint were outside your investigative domain. On knowledge and belief, the entire sequence of events involving the financial destruction of Performa, a company I owned in partnership, between 2002 to 2005 was undertaken by FBI. The agency was further involved in improper police powers activities in Boston and New York metropolitan areas summarized below.

The conduct in question is not individual misconduct which can be handled by the agency. Rather, it is **institutional misconduct by an agency within the Department of Justice**. So, I am requesting official answers to the following three direct and specific questions for potential use in civil litigation already filed against the Department of Justice.

**1. Is your office stating officially for the record that institutional misconduct by the FBI is outside the jurisdiction of DOJ OIG?**

A copy of the revised Complaint 22-cv-00592, now pending before the DC District Court, is attached for your convenience.

For your further investigative development, I offer the following if you wish to proceed to investigate institutional misconduct by FBI. The following sales leads have a common thread beyond TSL, they occurred across state lines in the jurisdiction of numerous field offices and in plants that had no employees present (other than faux employees, all FBI field agents upon knowledge and belief).

This fact, the complete absence of hourly and other managerial employees, is unlike any other period of sales activity I had undertaken between August 1979 and September 2001. During that period, I was a consultant who conducted and managed hundreds of projects on behalf of management consulting firms and an engineering firm, in a very wide variety of enterprises, as well as an executive in startup and mid-size commercial enterprises.

In other words, I have vastly more experience and knowledge of the customs and habits of such enterprises than any government employee would reasonably be expected to have. I know and understand the territory of commercial enterprises. Kindly refer to my resume in Complaint 22-cv-00592 for more information.

Upon knowledge and belief, FBI Boston arranged the set up of a dummy company, known to me as Technology Sales Leads (TSL), which I visited in downtown Boston during the period that Performa was in business. TSL provided a series of bogus sales leads in the 2003/2004 period for the unstated purpose of conducting a financial starve-out of the company, which resulted in the loss of my personal residence in Kirkland, Washington in the fall of 2005. The residence itself may well have been subsequently

internally destroyed by FBI in a search for some non-existent phantom. Kindly see lines 224 to 248 of the Complaint originally provided to your office.

Sales leads provided by TSL are shown below. None ever closed and converted to revenue projects, unlike my prior 20 year history of 60% to 80% converting to sales revenue while selling and conducting projects and technological products in large scale, mid-size, and startup enterprises.

11. BioControl, Zoe Schumaker, Lawrenceville, GA, information technology
12. Brightstar, Miami, FL, information technology
13. Rockwell Collins, Cedar Rapids, IA financial planning
14. Rocketdyne Folsom, CA, F-35 e-procurement
15. Steel and Pipe Supply, Manhattan, KS, information technology
16. Samsonite, near Denver
17. Holland Group, Holland, MI

A series of fraudulent checks was also proffered to Performa for work conducted, or at least allegedly conducted during this time period by my partner, or a carefully disguised substitute as he allegedly relocated to Tucson with his wife and subsequently reappeared in the Seattle area, totaling about \$160,000. Perhaps FBI, being so closely engaged with my company through TSL, was unaware of this, or perhaps they were fully engaged. I am unable to investigate this matter further until the discovery phase of my civil complaint, though perhaps it will offer further evidence of institutional misconduct as part of this overall package of destruction.

**2. Has FBI officially and categorically stated to your office they had no involvement with the Technology Sales Leads Boston boiler room sales leads development and the series of subsequent sales calls involving me and Performa in 2003/2004?**

FBI was also involved during my time in Boston as a homeless person in 2006 and 2007, and in the New York City metro area from 2007 to present. I was trafficked by a police powers network I am currently working to identify and subjected to investigation as a terrorist as confirmed by NYPD. This would strike most people as peculiar, given my previous consideration by the Governor of the State of Washington to Chair the Higher Education Coordinating Board for the State of Washington. This Board oversees an agency which has various regulatory authorities over all institutions of higher education in the state. Also, my tenure as the regional Chair of a high technology trade association and personal familiarity to and with members of the leadership of the state's House and Senate may strike some as a bit contradictory to the concept that I was inclined toward terrorism.

3. **Has FBI officially and categorically stated to your office that it was in no way involved in any investigation of me as a terror suspect in the state of Washington, the Boston metropolitan area, the New York City metropolitan region, or any other location within or without the United States, between 2001 and the present?**

That would stretch credulity well beyond the point of disbelief. I will note again that the landlord of my building informed me that an individual was removed from my seven unit apartment building in Cliffside Park, New Jersey by FBI and handed over to DHS for deportation due to anti-American statements or sympathies while I was a resident there.

Finally, I recommend you carefully review the full extent of my Complaint 22-cv-00592 to determine if you can truly disregard any and all institutional misconduct possibilities by any and all agencies, offices, bureaus of the Department of Justice.

I look forward to your reply to my three specific questions above and to other matters as you wish. I clearly understand your investigations are the confidential domain of the Department. Thank you very much for your attention to this matter.

We are selling conventional beef from North and South America into China and have 2 offices there – Shunde City (one hour northwest of Hong Kong) and Shanghai. We opened those offices in February as the pandemic began to subside in China. The current global backlog of this protein trading business is a modest \$100 million, typically based on 12 month contracts, though we have some one-off orders from time to time. We are in the early stages of evaluating whether we want to establish a beef partnership on Hainan Island with a Chinese national and a US national who have some grassfed cattle there.

Our case ready pasture finished organic grainfed beef and pork product lines will begin accepting pre-orders after Labor Day and ship in December through online and retail channels. Initial focus is on the West Coast. Walmart is currently evaluating whether to take this product line on as well.

Cindy – Thanks for your message. Despite several attempts, I was also unable to reach any customer support to resolve a complete inability to print even with store bought cartridges. I did talk to several people but got a complete run around from them. Copy of a chat transcript below for your review as an example of the type of interaction I had.

In order to get the needed documents delivered only 2 days late, I bought an Epson printer and will be using that going forward. No more HP despite 35 or so years using them and getting previously excellent print quality and support. Once you send me a notice that the balance has been written down to an appropriate amount, I will provide a credit card number to charge and return the unused ink.

It seems some intervening mail fraud and wire fraud may have been the reasons for these problems but I cannot be sure. In any event, the instant ink arrived late, then printing was disrupted, then I cancelled but was still charged at \$1 per 10 pages after cancellation date, then I bought third party ink at Target and could not print at all, then HP support was bad. Invested around 14-16 hours to fix these issues, its simply not worth the time wasted, so I no longer use subscription ink nor provide direct internet access for printer updates. I have had this type pf problem episodically in the past as I've tried to communicate critical information and while simply doing normal office work, so that is the reason In think it is wire fraud at the root. It's consistent with pother police powers experiences from my life in general. Extra-legal, unconstitutional, but here we are.

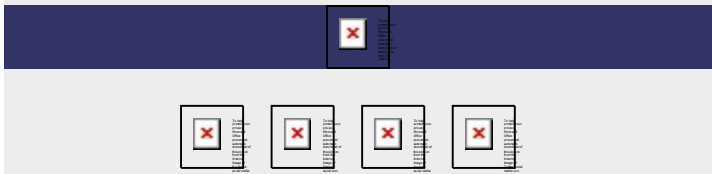

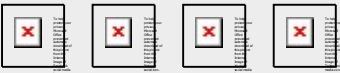

Good day - I'm now on my sixth try to get the attached whistleblower misconduct Complaint admitted to DC US Court. The Complaint details illegal experimentation on and the destruction of one U.S. person by the United States. But it unquestionably leads to something much bigger than a single victim.

The issue in the Complaint is at the very heart and soul of what the United States of America allegedly holds itself up to be. But this illusion does not translate to reality when it comes to its misuse of classified intelligence weapons hiding behind a veil of secrecy. The core issue is at the very heart of liberty, human autonomy; the second ring is black space misconduct leading to death, permanent injury, incarceration, suicide, or destruction; the third ring is collaboration through illegal police powers operations; and the outer ring is public disclosure leading to vigilantism.

Since I'm in forma pauperis and the claims made in the Complaint are based upon a highly technical system not in the public domain, which sounds like a science fiction horror film plot (including prequels and sequels spanning 50 years), five DC federal judges have dismissed it as frivolous. But, as we have seen in other cases and in the publicly viewable elements of this situation, the government's misconduct can be factually deadly.

At the very least, this has been one of the most closely held secrets in the United States arsenal of intelligence tools. But it seems likely our adversaries discovered this tool sometime back, likely turned it against us to provide disinformation for a time, then found ways to retaliate which are as untraceable as this US government tool. It's use against adversaries is a highly plausible explanation for the series of retaliations against State, CIA, and FBI employees leading to their brain injuries and permanent disability. The global powers intelligence game has been played with human assets for a very long time with very few real casualties on any side being killed by others despite the record of torture shared by many, including our own CIA in recent times, making it still more plausible that the Havana Syndrome was retaliation rather than a new offensive in these types of actions.

But the illegal experimentation on U.S. persons which has been part of these activities has resulted in multiple life-terminating situations involving me (and others at times), sometimes narrowly avoided. As with MKULTRA and COINTELPRO, it is very unlikely I have been the sole victim of this misconduct. More than likely, some of my current and former relatives suffered

from this, as did many others. The possible outcomes for those innocent victims range from death, permanent physical or psychological injury or disability, incarceration, financial and personal destruction, to damaged reputations.

As you know, whistleblowers with allegedly secure government jobs and protection have faced all types of retaliation and adverse consequences from their courageous decisions to blow the whistle. At the same time, those favored by federal institutions - like J Edgar Hoover - have retired to full pension and zero consequences for year of illegal and unconstitutional conduct. Same with the CIA Director Helms who ordered the destruction of MKULTRA evidence, then, instead of being criminally charged with evidence destruction, was confirmed by the Senate as Ambassador to Iran. More recently, the FBI agent responsible for the investigation of Larry Nassar was fired for his conduct and for allowing hundreds of additional sex abuse offenses to be committed in the interim. His termination came six years after the case and one week before the Director testified in mournful tones about the case to Congress.

Between qualified immunity, the Reynolds case providing a national security legal precedent which was based upon perjured affidavits provided from USAF to the trial court, and a national security classification system easily overused to evade accountability, this process continues unchecked, including against me as I write this.

So, I need counsel and sufficient support to get this Complaint across the transom and into discovery and the series of US government appeals which will need to be overcome so that the United States, the entity chartered by the People after confederation failed, is required to comply with the Constitution and all 27 amendments in both form and substance. The criminal misuse of national security tools against U.S. persons cannot be allowed to stand.

As with Area 51, nearly everyone knows it's there - our adversaries certainly do, members of Congress and the public do (though not all yet), only the United States itself insists on denying it and the damage they have caused. Like the "mysterious" sheep die-off near the Toole Arsenal's nerve gas repositories, Agent Orange in Vietnam and elsewhere, the burn pits in Iraq and Afghanistan, and on and on, these misdeeds cannot be allowed to stand.

Government stonewalling for the simple expediency of avoiding embarrassment to the US government, and accountability for violations of the Constitution, our laws, international law, the UN charter on human rights, and other treaty obligations worldwide, cannot be allowed to stand. It violates all we allegedly stand for as a nation and puts our people around the world at risk, be they soldiers, spies, diplomats, businesspeople or tourists.

There must be accountability for every victim and for all losses. This is just the first step in that process. But like the journey to basic civil rights for all disfavored persons or groups, it must begin somewhere. It's long past time for that beginning.

Please consider this situation and let me know if and how you would like to proceed.

Mr. Cole - Good day. A familiar story has reemerged along the lines of MKUTLRA and its sibling COINTELPRO but wrapped in one neat package. While this story originates in the State of Washington, it has transpired over decades across 44 states and several European countries, and over the past 16 years, primarily in the NYC metro area. It integrates national security assets, police powers misconduct and counter-terrorism operations all wrapped in one complex package but designed, as usual, to obscure sources, methods, and, in this program, criminal misconduct hidden behind the cloak of state secrets and self-exculpatory acts, as well as the discrediting and destruction of the subject(s). It follows the same familiar script as police powers and intelligence as the misconduct disclosed by the Church and Rockefeller Committees of the early 1970s while these agencies were under the control of Richard Helms, J Edgar Hoover, and involve NYPD here in New York City.

To be clear, I have never served in the military or intelligence services, never held a security clearance. I have been the subject of five traffic stops (speeding up to 10 miles over the limit and expired tabs, all in Washington and Oregon states prior to 2006) and two New Jersey parking tickets before 2010. There were probably a few other parking tickets around the country as well. No arrests ever for anything. I worked with the Governor's staff and state legislators in Washington state for several years as the volunteer Chair of a technology trade association. I hold a BA and MBA from a land grant university, passed the CPA exam with little accounting coursework, hold a pilot's license, and other ordinary activities, jobs, and achievements. Nothing in particular stands out from millions of other U.S. persons. Such is my record of maladies and missteps.

But please take the time to read the attached Complaint and related documents or ask a member of your team to do so. I have purposely filed in DC so that the precedent established in this case can apply to the entire Executive Branch as this step is essential to full implementation. I am currently acting pro se on my own behalf to get this case over the transom so discovery can proceed. I have also made numerous pre-discovery FOIA requests. All federal FOIA and PA requests to DHS, DOJ, and FBI have been stonewalled to date. Various DOD elements are processing FOIA and PA requests now. Army and CIA (both involved directly in MKULTRA from the 1950 into the 1970s) have never responded in any form to my FOIA/PA requests, including a letter to the Secretary of the Army noting this legal deficiency.

There is one notable exception – an admission by NYPD under NYS FOIL that I was investigated as part of a counter-terrorism operation. FBI did surveil the 7 unit apartment building I lived in previously and removed one tenant for deportation. And, of course, upon my return to NYC, I was met by a squad of about 2 dozen bulletproof vested submachine carrying NYPD officers standing about 8 feet apart in the bike lane and extending the full length of the Port Authority Bus Terminal's South Building on the 8<sup>th</sup> Avenue side, a "privilege" I had not previously been accorded.

It is inconceivable that the regional JTTF's, including NYPD, PAPD, FBI, DHS, and so forth were not involved and coordinating on this matter. That they had no reasonable legal basis for their conduct, which likely included trafficking me from a nearly foreclosed residence in Washington state to 21 months of homelessness in Boston to a fake seven month \$140,000 per year job in Fort Lee, NJ, or later resurrecting a long dead investment banking firm to "work" with me on a designed for failure financing exercise is, of course, beside the point – at least as seen from their perspective.

I continue to experience numerous difficulties in daily life ranging from an ongoing managed string of "dates" beginning in Washington and Oregon in 2005, to the NYC area in 2019 to the present, and honey traps (one on November 13, 2021 involving 10-12 female officers dispatched from the 108<sup>th</sup> Precinct in a marked NYPD van with lights flashing a few minutes ahead of my early evening arrival to the mostly

deserted sidewalks of the Gantry Plaza area and apartments adjacent to the East River); to interference with websites including the lack of a floor number for both your office and the NYC Human Rights Watch office on January 27; to an unmanaged steak choking episode in January 2022; and the inability to control my own body resulting in forward momentum which tumbled me to the floor while I was flipping an office chair to replace the rollers while seated, also in January 2022. I am 6 foot 4 inches, nearly 300 pounds, so an office chair would not typically result in a total loss of body control and forward roll to a back sprawl.

I have been carefully medically evaluated, no neurological damage, no substantial health problems, no psychological issues in the past ten years, and so forth. There have also been a series of unexplained falls, mostly abrupt blackouts (not fainting, more like flipping a light switch) on mountain trails, ladders, and so forth, as well as an abrupt effort to put me to sleep while driving adjacent to a sea cliff about 8 feet away. Sleep periods in other settings, sudden repetitive cramps, and on and on. Not the normal maladies of everyday life, though an effort to make them appear natural is generally part of the incident. Put another way, a comprehensive management of human autonomy itself – bizarre, yes, delusional, no.

This technology is based upon currently available advanced technologies. I have carefully reverse engineered the overall system using the scientific method, found that many of the actions are programmed and somewhat repetitive, all more fully summarized in the Complaint. The command set is based in computational neuroscience and has been used in increasingly capable forms as an intelligence asset, though it was likely uncovered some years ago by our adversaries. The motivation behind the billions spent to develop this computational neurosystem, and to leverage other advanced technologies including supercomputing, satellite communications, and precision location technology was quite simple.

By progressively invading human autonomy, the United States has gradually been able to attain advantage over its strategic adversaries, replacing and/or implanting thoughts and physical actions perceived as voluntary, but actually carefully managed. What better way to feed your enemy disinformation and indecision than through the brain of an analyst, advisor, or leader? Can't think of a thing, can you?

Yes, this sounds bizarre and unbelievable, but then so did putting a man on the moon by 1969 when Jules Verne wrote about it in 1865, as the first transcontinental railroad was being completed and the Pony express was being replaced by the telegraph. And, of course, with Moore's law, computing power was said to double every two years (today it's more like ten-fold every two years).

Thanks for your review of the attached documentation. Please let me know of your receipt and suggestions for further pursuit of this matter. It is highly improbable I am the only subject/victim of these malign activities. These agencies have a durable history and heritage of abusing innocent and unknowing U.S. persons from inception. For example, OSS began LSD experimentation during World War II, continuing it until discovery in the early 1970s. FBI ran Cointelpro the same way until the illegal activities and smear campaigns were discovered when activists broke into an FBI field office. I'm sure you know these stories well.

Finally, I assure you that I am not the conspiracy monger type. I have a strong background in logic, the scientific method, and have worked on complex consulting, engineering, science, business and political

issues throughout my adult life. Two of the Exhibits attached deal specifically with mental fitness and character issues.

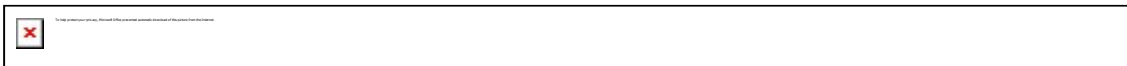

Good day – Thanks for your communication. Can I reasonably and legally conclude from your statements that (1) there is no outstanding court order requiring you to limit the access of other persons on your platform to communicating with me (2) there is no outstanding court order requiring you to limit communications from me to others on the platform (3) there is no court authorized intervention or prevention limiting my access to all other members based upon my selected search criteria (4) you are completely unaware of and have no involvement in any blocking or limiting of my platform access of any kind at any time since I first joined each of these platforms into the present time?

The reason I ask these questions is that it appears that there is a form of blocking going on. For example, in using Match in the 2004-2005 period, there were no women of color among the 2 dozen or so in-person meetings I was able to arrange in the Seattle-Portland area and most did not involve travel across state lines, whereas in 2019 in northern New Jersey/New York City, there was only one woman not of color among about 18 women in similar circumstances, and all of these visits involved travel across state lines. These days there is functionally no response from women in the local area despite my presence in what is objectively the largest market in the US for these services. Given my selection criteria in each situation and the population balances in each case, these are extremely biased results rather than the blended results you would typically expect.

These results are strong circumstantial evidence of some form of intervention in all three scenarios. In order to release you as a defendant in this class action litigation, a letter from a properly authorized company officer which specifically
