Pattern evidence destruction similar to web search evidence destruction pattern below has been experienced as to bank accounts. For example BA accounts opened in NJ in 2007 was implemented in Summer 2015 which led to closure of both Bank of America personal and business accounts in Summer 2015 by Defendants using cover of "investment" to provide two fraudulent checks (per scam contained in email evidence from that period) which resulted in those accounts being closed by BA and which required use of cash walked from Ramsey Wells Fargo to BA branch in Ramsey to pay off something more than \$9K after BA explicitly refused WF cashier's check I had walked over to payoff overdraft which cashier's check had originated at Wells Fargo about 5 minutes prior in my attempt to pay off the dishonored checks using Dean Smith investment funds around the end of August 2015. Account history was deleted as BA informed me that they would not preserve evidence as the litigation did not directly involve them. All account history was stored online, not on paper statements and access to account was lost be the closures in 2015 before I could download (and did not think there was a need to do so in August 2015).

Chose to delete cookies this morning to attempt to improve performance after a couple of reboots and yet another non-factory updates (which impact normal performance with other forms of hacks installed and occurs frequently despite my ongoing use of the very stable Windows 10 OS. As a result of my decision to clear cookies, Defendants used this performance issue which they enabled by hack to cause the clearing of search history, making it look as if it was my choice when it actually occurred because of their performance hacks and then a stealth removal of search history using the following means: Chrome search history selection on Basic tab was checked while this same selection was unchecked on the Advanced Tab I was using in my effort to clear cookies. This rendered my search history unavailable to me by this hack, and also rendered the header info (originating IP addresses and routing info is in header info of search results so the origin can be traced back). Same selection choice (History Delete) in the first position on the Advanced tab I was looking at was unchecked as I desired to retain search history. This was another in a long-running series of web search history delete takeovers conducted by Defendants. In the past these have typically been the result of a technical fault (hack of Chrome) which required clearing of all cached items and all search history using a remote takeover by Defendants in order to restore normal operation. All have been intended to eliminate traceability and constitute obstruction through evidence destruction by those Defendants


This is a technical hack pattern violation which series began in the early 2000s and has been implemented periodically well over a dozen times in the past. It is consistent with other pattern hacks such as disabling of printers and bogus circular "customer support" interventions which leave the problem unresolved, such as disabled printers – Lexmark, HP, Epson most recently – as well as requirements between 2011 and 2018 to repair my computer at Staples while in Ramsey – my current recollection is this repair was required twice (which would allow both hardware and software tech to be installed without consent as well as to physically wipe or modify information on the hard drive.)






As Shown in the following sequence, the Clear History Selection remains checked on the Basic tab even when not checked (same or similar functionality). The issue fro the Google engineering team is:




8/13/23, 7:24 AM Timeline

Subject: Unable to print in any color

Attempted to correct printing problem with black ink by installing update of firmware et al as shown in video sequence shot this date just before 8AM. As sequence shows, cannot successfully remove and replace ink cartridges for any color, so all printing in any color is now disabled. Once second update, can still scan only. So, this hack has completely disabled all printing leaving me in the same situation as I was with HP inkjet printer when that printer had to be replaced. Also stuck with about 2 dozen useless ink cartridges (around \$15 each subject to purchase price verification) and 10,000 pages of printer paper at \$50 per case (\$100 total).

Typical fubar created by hackers in this situation and by other actions in other situations many thousands of times beginning in 2001 with high intensity/frequency, on much slower cycle prior to that 2001 AUMF induced accelerant.
