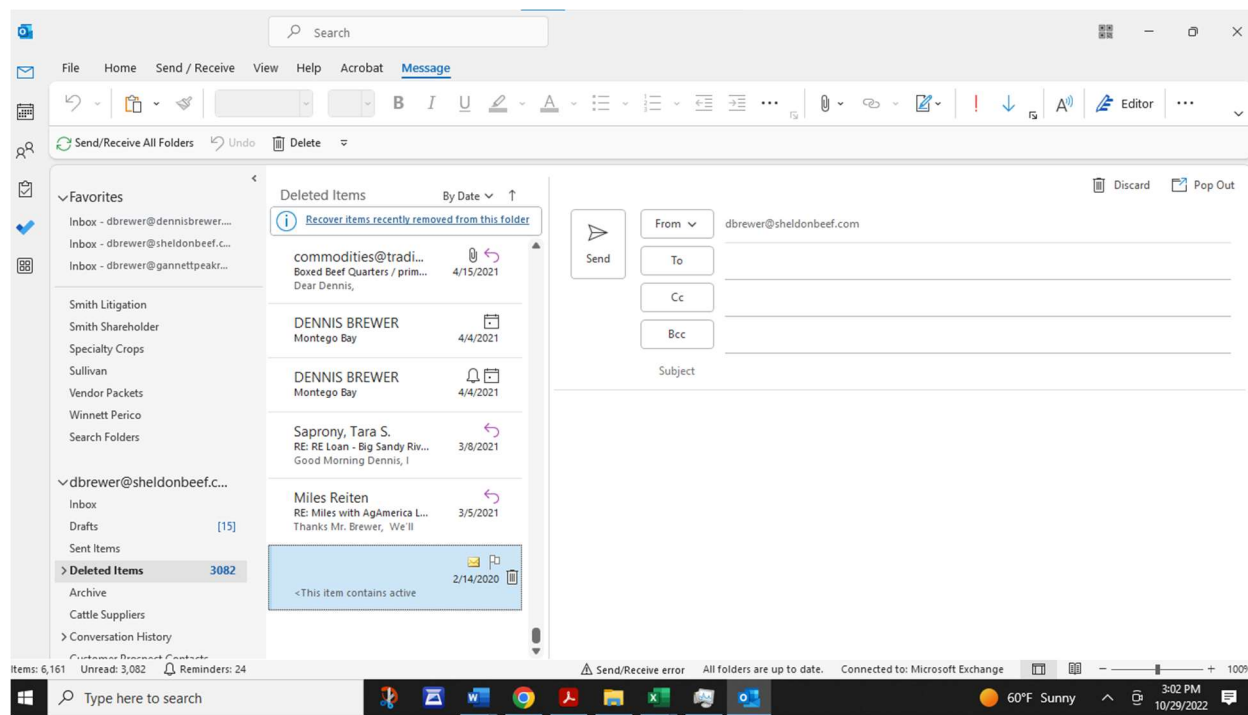

Tampering Incident 10/17/22

During editing of count resequencing in Complaint on Sunday evening, Defendants manipulated cut and paste command to drop 3 counts from Complaint. Counts dropped were original count number 45 46 47 in excel spreadsheet Count By SDNY Ltr Matrix at A Revised Complaint October Filing folder. The counts relate to tampering retaliating and fraud re official documents, respectively.

Noted during count cross audit of Complaint to spreadsheet on 10/17/22, restored to Complaint just before 916am 10/17/22 Defendants used cut command to drop the Count from the Complaint. I audited because I had noted this behavior several times before during prior document preparations.

BRMT neck twist and slight pain right lower neck at appx 9:24am 10/17/22 during this writeup.

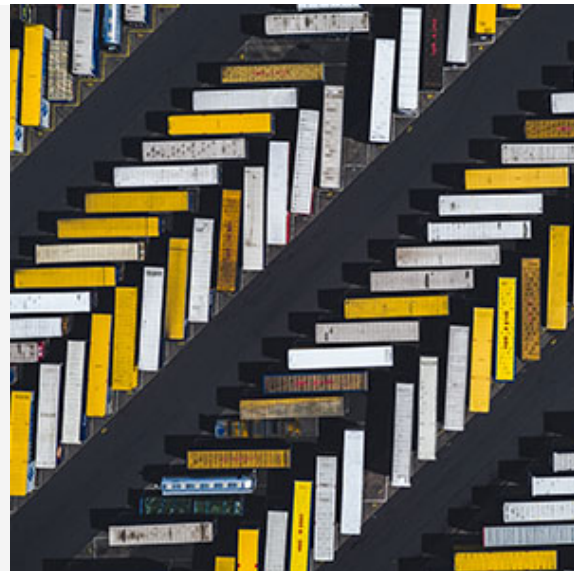

While working through the WO email account forensic review, am obstructed from moving past March 4, 2018 to later dated email records which document the subsequent activity e.g., sales attempts with Costco on China incl Meat mtg at Issaquah HQ with Walker and Costco meat procurement Director Huskey in vacant HQ bldg. in HQ complex, also Smith relationship loan for NE i-banker retainer, leading to 2019 litigation, Sullivan opt out as no CA license, Madison St retainer, NE i-banker ??? retainer and fail, MSC litigation against NE i-banker for poaching, Nickless on JFO missing, Manning Beef and Pico Rivera BRMT eye-watering enroute Lax thereafter, emails with SD cold storage after all LA area cold storage full, OWB additional emails and perpetual response failures Steve Summers, safety eqpt supplier ref to Arturo, WMT Bville house visit Higaki during floor install finish for pre-China party on a Friday when trip to inspect a/c at southern MO airport w/ regional contractor and daughter as sellers at Joplin, MO airport.

Also note that the email record prior to 3/4/2018 has been tampered with to eliminate all emails relating to WMT required SCS audit of supplier and of logistics provider, of Waseman in loop throughout SCS process, of logistics providers advance of SCS auditor pre-pay and our inability to reimburse, of various emails re Euro network interest in UK and through a Euro-based referral network, emails with and regarding CA logistics provider Ameri-cold (and its primary competitor who did later buyout which name is blocked search at 1051am 10/29/2022)

WO Email vertical date scroll bar freezes at March 4, 2018, refuses to allow access to later emails through the rest of 2019, made multiple attempts, and restarted, same issue continues around 1030am 10/26/2022. Further attempt at 1106am yields identical result. Same result at 1120am.

Checked Sheldon Beef email and no access prior to July 20 2020 which see first email in this same Folder.

Bottom line is all emails in WO and SBI between March 4, 2018 and July 20, 2020 are either missing or blocked as of 221029. Either evidence tampering or third party block under FISA court order.

SBI Notes on poss tampers – No access prior to 200727 Cachola, though acct would have been opened on or immediately after January 4, 2020. Most MO contractor Heuer II emails in early 2020 do not appear as noted from looking at MO ranch reference in National Livestock email on 200817, possibly frozen out or else wiped, unclear at this moment as of 221029 239pm
