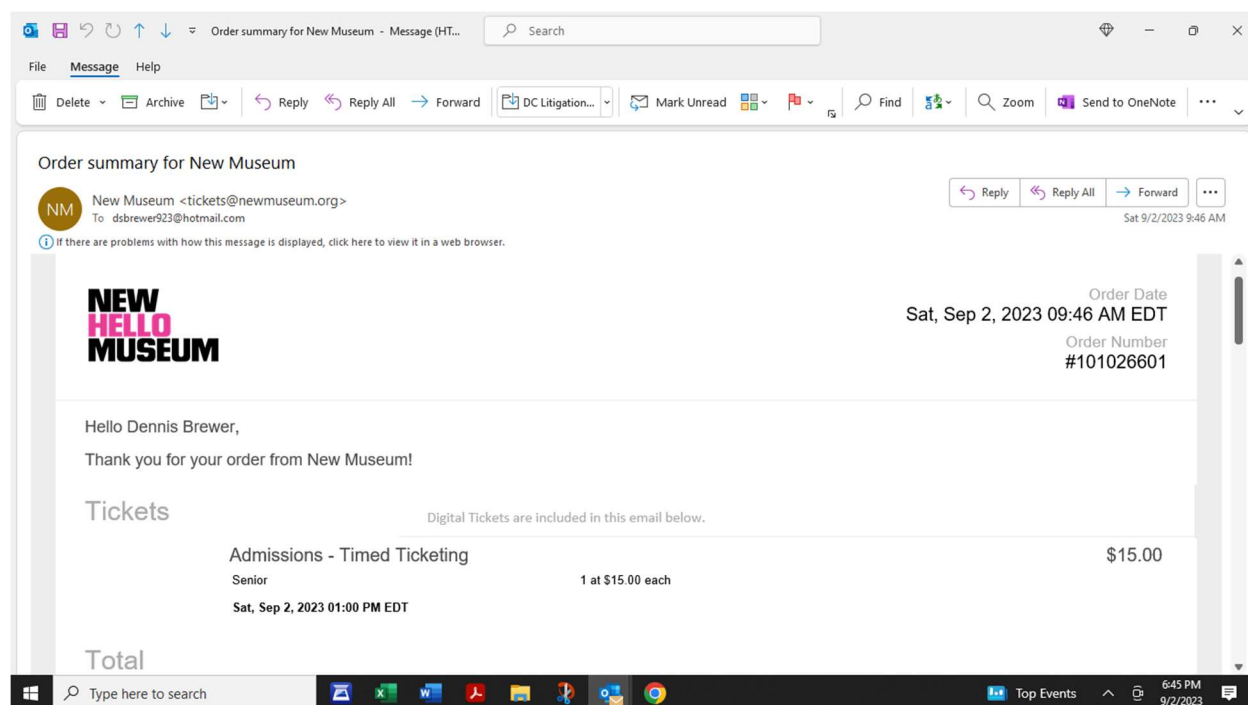

230902: Notes from walkabout - Manhattan police powers operations

Trip for the purpose of visiting New Museum on Bowery Street, which I did around 115pm.

Took D train from 6th Ave past stop which was not specifically identified on New Museum map below to Brooklyn Barclay's Center as location of B, D, F, M stop mislabeled on New Museum map provided in ticket email. Then during return across bridge there was a truckload of scaffolding on the bridge westbound toward Manhattan, which I saw as I was turned toward doorway a few seconds after male at 2nd left subway car doorway to left had turned in that direction (my body turn BRMT and visual stimulus induced).

Above was an attempt to discredit/minimize re reported Manhattan Bridge Q train murder 220522 NYT web story - or disinformation plant thereof for false attribution to SDNY, else attempt to which see my letter 220617.

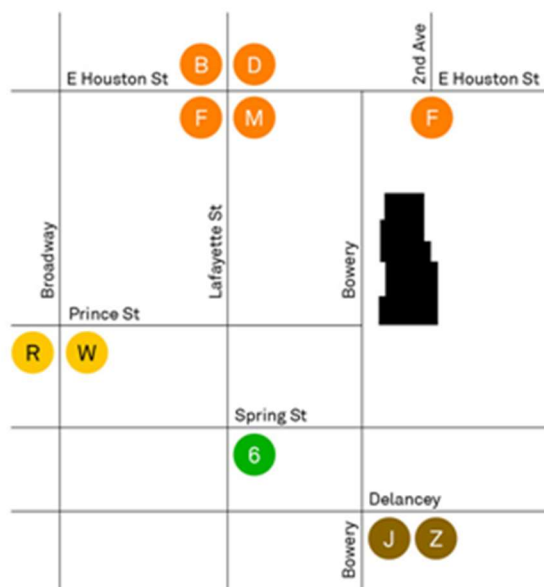

After New Museum visit walked west, then north as follows:

Attempt to disinform or to discredit prior story re FBI agent attack on NYPD parking enforcement officer 220423 NY Daily News web news story – parking enforcement officer crosses to Bleeker Lafayette ahead of me, I catch up and pass to her left.

Gibberish speaking fake demonstration by NYPD and about 100 people on south side of E 23rd St across from Madison Square Park. Incident commander sends short earshot message as walk past re fake nature of activities presented in “demonstration.”

Continue northbound walk up east side of 4th in the 30s which generates cross traffic NYPD patrol vehicle, followed by electric scooter westbound with yelling undercover riding, then a block or so and crosstown bus eastbound close pass (typical NYPD pattern actions to mock and minimize prior scooter and vehicle intimidation threat uptown on 230829 as documented in SDNY letter 230901.

All part of NYPD resources dedicated to mocking and discrediting, following overt real-time hacks same morning while writing up prior events sequence and tampering with that evidence live real time by police powers operations.
