BRMT, including both the actual biological mechanisms of operation of the brain hijacking bioweapon itself, and the complex technological system (supercomputers, software, and precision directed energy systems) which delivers it, were first reverse engineered by Lead Plaintiff in 2021. Table 2 summarizes key occurrences of BRMT and racketeering violations of law and rights against the Lead Plaintiff since approximately 1972 (age 17). These acts began at the age of 12. See First Steps Supplement at pages 12245-12250.

BRMT bioweapon brain hijacking development apparently began in earnest in the 1970s as Defendant CIA was "terminating" the illegal MKUltra LSD program and Defendant FBI was "halting" Cointelpro, two secret programs of criminal violations of the US Constitution and laws. These 1950s programs were publicly "terminated" in the 1970s due to public exposure and outrage. There were absolutely no criminal consequences to these agencies nor to any government executive, manager, or agent, for the hundreds of thousands of felony law violations against American citizens – drug distribution, prostitution, mail and wire fraud, accessory to assault and murder, funding of violent extremist militia, evidence destruction, and obstruction of justice, to name just a few.

The behaviors simply continue in secret as before, perhaps morphed a bit to get around some new laws. But mostly those laws are simply ignored. The FISA Court recently published another report in a series which documents 45 years of FISA violations. Congress recently memorialized the 15th year of Section 702 violations in hearings. The Senate Intelligence Committee was spied upon by CIA in 2014 during oversight related to torture abuses by CIA. CIA then removed the internal CIA report on this spying from the computers used by the Senate Intelligence Committee. These are other indications of the executive branch intelligence and police powers operations pattern of practice simply ignoring the Constitution, law, rights, and even the separation of powers, since there are no consequences for their actions anyway – never have been.

Lead Plaintiff began using forensic reverse engineering to identify the basic medical and technological tools required to abuse with BRMT and its effects on humans in 2021. Using this biomedical abuse knowledge, and newly recognized past patterns of handler and minder tradecraft embedded in Defendants' signature tradecraft, woven into their psychological operations, and direct knowledge of racketeering both as a victim and as an involuntary servant of these criminal operations against US persons and enterprises, the timeline below was constructed.
