This arises much controversy in creditors and court trustee.

During this time objections arise to JR closely associated hidden assets in and around, other properties are enjoined into the bankruptcies and investigation into relations with owners of JR's llcs. My understanding is that at this time Gladstone has issued a petition as an intervener, I am not sure if the case that they are a creditor on other JR projects or if they are going to be asking the court to make a cash offer on the property.
